# Scaffolding/Gantry/Protection Structure

When such structures are installed on the road reserve, there are a number of public-safety requirements that need to be addressed. These requirements help to ensure (among other things):

- a) there is adequate footpath space available for pedestrians;
- b) public car parks remain available;
- c) all street features (e.g., rubbish bins, parking metres, private entranceways, etc.) remain accessible to the public; and
- d) sightlines of regulatory signage are not impeded.

#### **Minimum footpath widths:**

- · 4 metres for Willis Street and Lambton Quay.
- 3 metres for Cuba Street, Manners Street and Courtenay Place.
- 2 metres footpath for all other streets.

If the original footpath width is narrower than the above-mentioned minimum, then you must try to keep it open at all times. Otherwise, please discuss with the Street Activities Officer (streetactivities@wcc.govt.nz) for alternate solutions.

#### Head clearance throughout the site:

• A minimum height of 2.4 metres should be maintained throughout any space (e.g., under scaffolding and gantry) through which pedestrians pass.

#### Accessibility to footpath from road:

- Pedestrians/motorists must be able to reasonably access the footpath from the road.
- Long sites must have breaks for pedestrians to be able to pass through.
- When scaffolding is erected next to car park spaces, adequate clearance must be left for motorists to exit the vehicle from either side.

### **Pedestrian protection:**

- You must take adequate measures to prevent debris or slurry from penetrating the pedestrian area.
- You must make all efforts necessary to ensure that the general public are unable to enter the worksite area.
- Your site must be locked and secured outside of working hours.

The construction of a scaffolding/gantry may require a building consent or resource consent to comply with District Plan requirements. For further information, contact Building Consents and Licensing Service on (04) 499 4444.

If working near overhead utility lines or underground services, please consult the NZ Electrical Code of Safe Practice for Electrical Safe Distances and contact the appropriate Utility Company/s to advise as required. For details, visit our website at:

The plan needs to identify the internal and external barriers, footpath diversion, and define the area you wish to use.

## **Construction Loading Zone (CLZ)**

A CLZ is a designated area used for the loading and unloading of materials via delivery vehicles—it is **not** for general parking used by site workers.

There may be charges for sole use of space for a CLZ. These charges apply when the CLZ is occupying paid-parking space and where Council must recuperate this loss of revenue.
