The rates remission policy

The rates remission policy is to help first home builders and increase the supply of housing in Wellington City.

Under the policy Wellington City Council can grant a rates remission, up to a maximum of \$5,000 (inc GST) on a new home finished after 01 July 2017 within Wellington City Council.

Applying for the rates remission

This application form is for a rates remission for the 2023/2024 rating year (the period 1 July 2023 to 30 June 2024) and applications close on 30 June 2023.

To apply for a rates remission: fill in sections 1-4 of this form, then contact the Rates Team by email at rates@wcc.govt.nz to make an appointment. All owners need to apply, and each owner will need to provide some form of ID showing you are either a New Zealand permanent resident or citizen to the appointment. The application will then be processed, and a rates officer will contact you should they require more information and to confirm if the remission can be granted or has been declined.
