Councillor expenses and towing

Thank you for your request made under the Local Government Official Information and Meetings Act 1987 (the Act), received on 08 August 2022.

You requested the following information:

- The amount councillors have claimed in expenses and allowances over the last term (3 years) in office, if possible whether the allowance was used or not as well.
- The number of vehicles towed in clearways across Wellington over the last 12 month broken down into what easiest to report, either monthly or weekly and the streets that the towing occurred, like Adelaide Road,

Wellington City Council has granted your request for information.

If councillors do not receive equipment provided by the Council, they are entitled to claim for the following equipment if they have purchased it:

- Use of a personal computer \$150
- Use of an electronic tablet \$150
- Use of a printer \$40
- Use of a mobile phone \$60
- Internet connection \$250

Councillors can also receive \$400 annually for council-related toll and mobile phone charges. The total amount payable to a member must not exceed \$1,050 annually.


