Iwi leaders unite to bring message of peace from Pipitea.

The leaders of Taranaki Whānui ki Te Upoko o Te Ika and Ngā Iwi o Taranaki — with the tautoko of the Kiingitanga from Turangawaewae Marae — conducted a dawn ceremony at Pipitea Marae this morning to bring a message of peace and unity to the ongoing protest on their tupuna whenua, in central Wellington.

As ahi kaa of the whenua, the iwi says their role is to provide protection to people and the environment in their takiwā.

"This morning, we have laid down Te Kahu o Te Raukura – a cloak of aroha and peace over the Parliament grounds and our surrounding ancestral sites," says Pipitea Chair Kura Moeahu.

"Te Raukura contains the three feathers representing honour, peace, and goodwill – the same symbol used at Parihaka."

Te Kahu o Te Raukura will stay as a form of cultural protection over their ancestral whenua – including Parliament until the dispute is ended.

Kura says the iwi acknowledge the hurt and upset of the protestors and also the effect on local residents and businesses.

"This raruraru has gone on for too long and we urge the parties to find a way forward so we can begin the process of healing."

Chair of Taranaki based Te Kotahitanga o Te Ātiawa Liana Poutu participated in this morning's karakia along with leadership from around Taranaki Maunga.

Ms Poutu said Ngā Iwi o Taranaki supported the calls of their Wellington-based whānau for a peaceful resolution.

"We tautoko Te Kahu o Te Raukura and the desire of our whanaunga for calm and resolution to the current situation."

Kiingitanga spokesperson Rahui Papa said the Kiingitanga unites with Taranaki Whānui and Ngā Iwi o Taranaki at this time.

"For generations we have worked together and prayed together with ngaa kiiwai o te kete. This morning we do that as an expression of deep tautoko Taranaki and all iwi of the motu to bring peace and kotahitanga."

Taranaki Whānui Chair Kara Puketapu-Dentice says iwi leaders across the motu have joined the call for a peaceful outcome.

"There has been a lot of hurt and it's time to find a way forward to unite the nation again. "We need to look to the future when we will be able to move freely and without fear of the sickness that covid has brought.

"Until then, we need to hang tough and respect our whenua, our moana, our marae, our raukura and each other."

Inspector and and myself have been meeting daily with the 5 schools and 3 Early Learning Services in the vicinity of the protest action at parliament.

@gw.govt.nz>

Two of the High Schools have this week made the decision to go online due to concerns over student safety with behaviour of some of the protestors. Staff at Union meetings this week also expressed health and safety concerns and have withdrew from supervising the routes to and from school – prompting the move online. They are wanting to review their decision on Sunday.

There is strong interest from the collective group in establishing a unified safety corridor for students from train / bus stop to the schools.

Having a common path would enable some efficiencies with regard to co-ordinating people / resources to monitor the route. We estimate 1800+ students potential travel each day. Police and Māori Wardens have been increasingly visible but it is believed more people are needed.

The route being suggested is:

Train Station – Thorndon Quay – Mulgrave St – (split at Aitken) – Hill St Times suggested are 7 a.m. – 9.00 a.m. and again at 2.30 – 3.45 p.m. Monday – Friday There is a request for more people to be stationed on this route – they are hoping other agencies / organisations will assist (WCC, MOE, Aviation Security ???) There has also been offers of parent volunteers from Wellington Girls and Thorndon School.

An additional problem is that due to bus stops being impacted – students are being dropped off down Lambton Quay (by Farmers) – which is forcing them to navigate directly through the protest site. The request if if it would be possible to establish a temporary new drop off point on Thorndon Quay outside Pipitea Marae as this would help resolve this issue.

I would appreciate the opportunity to meet and discuss. There is a time pressure with those schools wanting to plan for next week to they can . Would be good to be as proactive as possible as media and Ministers office as seeking more information.




