Protests in the last five years

Thank you for your request made under the Local Government Official Information and Meetings Act 1987 (the Act), received on 03 January 2023. You requested the following information:

For the past 5 years:

- Marches (political or issue-based) that have occurred on Wellington CBD streets (walking and/or vehicles) and ending at Parliament grounds
 e.g. BLM, Ihumatao protestors, School Strike 4 climate, March for Life, Poneke Anti-Fascist Action etc
- For each of the marches over the past 5 years, could you please provide the following info:
 - o Which of the marches had council sanction with a Permit to march (in advance)
 - o Which of the marches had a Traffic Management Plan (TMP) in place
 - What was the amount of the payment made for the traffic management plan (if applicable).
 - o <u>Who</u> paid for the TMP protestors, WCC, other?

Wellington City Council has partially granted your request for information.

1. Marches (political or issue-based) that have occurred on Wellington CBD streets (walking and/or vehicles) and ending at Parliament grounds

We do not keep a full record of protests, therefore; this has not been provided under section 17(e) of the Act.

Permission is needed from the Speaker's Office to protest on Parliament grounds, so you may wish to contact speakers.office@parliament.govt.nz as they may hold a record of protests which have been held there. 2. Which of the marches had council sanction with a Permit to march (in advance)

You do not need permission from Council to hold a protest. We request a protest to submit a TMP if they will be on the road, however it is not a requirement. Please see the below response for further context.

3. Which of the marches had a Traffic Management Plan (TMP) in place

Please see above table for the information we hold. Beyond this, please see our response to question on.

4. What was the amount of the payment made for the traffic management plan (if applicable).

If the group has arranged for a Corridor Access Request (CAR) and Traffic Management Plan (TMP), the fees Customer Compliance team charge are:

- CAR fees (from 1 July 2021) \$75
- CAR fees (prior to 1 July 2021) \$65
- TMP (from 1 July 2021) \$95
- TMP (prior to July 2021) \$90

The fee for the on-site traffic management is dependent on the traffic management company and size. WCC is not aware of what costs may have been discussed between protest groups and the selected Temporary Traffic Management (TTM) company as this is a private contract between them, and WCC has no part to play in selection of TTM company, services requested, or fees charged.

5. Who paid for the TMP – protestors, WCC, other?

Usually, the cost for a TMP is often discussed between the protest organisers and the provider undertaking the TMP. This is a private contract between both parties and the Council plays no part in the selection of TMP company, the services requested, or fees charged.

In cases where the Council does organise a TMP (for example, a risk analysis shows a public safety concern that was not being adequately addressed by organisers) it is our discretion if TMP fees should be paid or waived.

We do not keep a record of Traffic Management Plan payments. therefore, this has not been provided undersection 17(e) of the Act. There is no policy or records to track our decision to charge a TMP or how much it would cost.

I can advise that the below were paid for by Wellington City Council, however, cannot confirm if there have been other instances in the past five years of payments:

23 August 2022 – Destiny Church

New Zealand Police requested that Fulton Hogan provided a Temporary Traffic Management (TTM). The TTM was charged back to the Council via the CBD maintenance contract to the amount of \$16,577.48. This was then charged to the Police.

The TTM was requested by Police and there was no request from the protest organisers, nor dialogue between the Council and the protest organisers regarding the TTM.

• 09 April 2021 – School Strike for Climate

Organisers engaged Fulton Hogan to provide TTM services. These costs were covered by WCC at a total of \$5,466.33

- 14 June 2020 Black Lives Matter
- 24 May 2019 School Strike for Climate

The protest was run with a TTM provided by WCC. This was approved after a risk analysis showed a public safety concern that was not being adequately addressed by organisers.

Right of review
