Official Information request – Noise complaints

Thank you for your request made under the Local Government Official Information and Meetings Act 1987 (the Act), received on 19 October 2023. You have requested the following information:

- Data from the past 5 years showing the overall number of noise complaints issued per year, broken down by month and suburb, and with an explanation for any trends visible.
- The street where the most noise complaints have been issued over the past 5 years.
- The most common causes for noise complaints, and how people can avoid causing these complaints.
- Any changes to the noise complaint system in the past 5 years.
- Any further detail that you think is relevant to this query.

Wellington City Council has **partly granted** your request for this information however we do not hold all data in its requested format and in some instances we have supplied you with alternative data. This is explained below for each of your questions.

Where the information you have requested is not available in that format, it is refused under section 17(g) of the Act, because the information requested is not held by Wellington City Council and we have no grounds for believing that the information is either—

- (i) held by another local authority or a department or Minister of the Crown or organisation; or
- (ii) connected more closely with the functions of another local authority, or a department or Minister of the Crown or organisation.

Data from the past 5 years showing the overall number of noise complaints issued per year. Can this please be broken down by month, and suburb, with an explanation for any trends visible.

Wellington City Council does not hold noise complaint data by month, split by suburb, so is unable to provide you with data in that format. We also do not hold five-year data for the Wellington suburb associated with the noise complaint.

We have, however, attached two spreadsheets. One shows the monthly breakdown of noise complaints for the past five years. The second spreadsheet shows data by suburb at the centre of the complaint for the period November 2021 to September 2023.

There can be errors and irregularities in noting the address and so also in allocating the address to a suburb.

We do not have any information relating to trends associated with these noise complaints.

The street where the most noise complaints have been issued over the past 5 years.

Wellington City Council does not hold data covering addresses for the past five years. However, we can advise you that, in the past three years, the most noise complaints have been recorded on The Terrace.

The most common causes for noise complaints and how people can avoid causing these complaints.

The most common cause of noise complaints is amplified music.

Have there been any changes to the noise complaint system in the past 5 years?

Wellington City Council is required to manage its legislative duties under the Resource Management Act 1991, so all notices, seizures, entries etc remain the same. Our management of noise and complaints are, however, constantly undergoing revision to address new situations or events. Generally, these revisions are initiated as minor changes to our policies or processes.

The service management system used internally by council officers to manage client requests, including noise complaints, was changed approximately five years ago. The service management system now used by the Council is known as Freshservice.
