#### **Aotearoa New Zealand Values**

In terms of values, New Zealanders responded to the call of what we Stand For with 43,000 individual contributions during the recent Flag Referendum process. Here is the image from the website.



None of the above suggest TPP. 43,000 people is a large sample of the 4.5 million NZ population.

## TPP Evidence - Civil Society Opposes the TPP!

The Foreign Affairs Defence and Trade (FADT) select committee treaty examination process motivated thousands to make contribute their interest.

Hundreds attending hearings in Wellington, Christchurch and Auckland.

The Vice Chancellors of all eight (8) NZ universities oppose the TPP.

Their thesis, 'TPP is not in our interests.'

The Vice Chancellors evidence is supremely authoritative!

They oppose TPP for its alteration of IP and copyright law, for the imposition of ISDS amongst other reasons.

#### Pressures on Local Government in NZ

- Local Government Act (LGA) 2002 Amendment Dec 2012 removes Four Wellbeings; Social, Environmental, Economic and Social and more...
- LGA Amendments 2014 attempt to reorder local government giving more power to the Local Government Commission (LGC) to promote council amalgamations, and encourage council assets into Council Controlled Organisations (CCOs)
- LGA 2002 Amendment Bill #2 (2016) gives more power to the LGC to propose amalgamations, proposes CCOs without direct Council representation, removes LGOIA accountability
- Resource Management Act amendments likely to expedite environmental degradation Water Quality is one example
- Local Government is scapegoated for Housing Crisis Central Government Fiscal Policy is culprit






These Councils represent 60% of the population of New Zealand.

#### TPP Free Zone remit - clause 7

7. Declares until such time as there is robust debate and convincing protection of local government decision-making for the benefit of residents, citizens and ratepayers, and an analysis of how these issues will be addressed at local government level, Council is a TPP\* Free Zone where the constraints imposed by the TPP, and the changes to national and local legislation to make our area comply with TPP requirements are not supported by the Council. \*TPP plus all the others.

### TPP Activism the Success to Date

 TPP contains 30 Chapters of which a few are about trade. Most of the chapters intrude into behind the border arrangements and regulation.

New Zealand's TPP negotiators were able to defer inclusion of the application of two chapters to New Zealand;

- Government procurement at the Sub-Local Government level for three (3) years
- State Owned Enterprises for Five (5) years

Additional wins include;

- The retention of the Pharmac Model (the efficacy of the win will depend on the level of funding and patent extension impacts)
- Tobacco Control carveout from ISDS arbitration (a state party must elect for this – NZ has signalled that it will)
