

PROPOSED TEMPORARY ROAD CLOSURE IMPACT REPORT:

REAL WOMEN'S DUATHLON – SUNDAY 10 APRIL 2011

1. Description of Event

This is the sixth year for this event and the fifth time a closure of roads for through traffic has been requested. Sponsored by Sparc, the Real Women's Duathlon is aimed at encouraging participation by women in active recreation. The 3.5km run course is from Herd Street to a point near Point Jerningham at the end of Oriental Bay. The 10km cycle course is from Herd Street to a point approximately 150metres north of Cobham Drive. It is proposed to close **Oriental Parade** and **Evans Bay Parade**, from Cable Street to Cobham Drive, to all through vehicle traffic but allow entry and exit for residents. Pedestrian access will be unaffected. This year's event is planned for Sunday 10 April, with the closures in place between 6am and 10am.

Known stakeholders in the Oriental Parade/Evans Bay area have been informed of the proposed closures. Road closure notification signs will be placed at points along the proposed closure route at least one week prior to the event. Residents and local businesses will receive a letter drop advising them of the event and the road closures. The event is also to be advertised in the Our Wellington Page of the Dominion Post in the week preceding the event.

The event is to be traffic managed by a professional traffic management company and emergency services will have immediate access to the area if required. Transport operators have been informed of the proposed closures. Impacts of the proposed closure are expected to be minimised by allowing entry/exit access for residents and the timing of the event early on Sunday morning.

2. Rugby World Cup and Events Directorate Support

The Real Women's Duathlon has been successfully run for several years and last year attracted approximately 1,000 participants.

This community/sporting event is supported by the Rugby World Cup and Events Directorate.

3. Proposal Notice and Consultation

The public notice that the Council was proposing to consider this closure was published in the following newspaper:

The New Zealand Police and the Ministry of Transport have also been consulted with.

4. Objections

No objections were received in response to the proposal notice.

None of the proposed closures for this event will result in a road being closed for an aggregate of more than 31 days in any year.

In the opinion of Soon Teck Kong, Manager Transport Network, acting as the Council's Traffic Engineer, the proposed closure, if implemented according to the plans provided, is not likely to impede traffic unreasonably subject to the conditions listed below. However, the Council reserves the right to modify this opinion at any time. If, in the opinion of the Council, the closure may or does impede traffic unreasonably, any approval granted by the Temporary Road Closures Subcommittee may be revoked and the event organiser may be required to open the road at the direction of a suitably qualified Council officer in charge of traffic.

Conditions:

- The event organiser is to publicly notify the event via letter drop, local newspaper advertisement, advanced signage and media releases.
- The event organiser is to ensure that the emergency services (Police, Fire and Ambulance Services) have been consulted with and that the Traffic Management Plan includes all of their specific requirements.
- The event organiser is to ensure that the affected property owners and businesses along the road closure are consulted with.
- The event organiser is to provide marshals at all road closure ends to ensure that public safety (interaction of traffic and spectators) is not compromised.
- Detour routes are to be provided during the road closure period.
- The event organiser is to work with the public transport operators to provide alternative public transport route and bus stops as required.
- The event organiser is to provide further details of the Traffic Management Plan to Council for approval prior to the event.

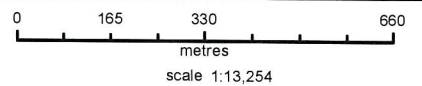

PROPOSED TEMPORARY ROAD CLOSURE IMPACT REPORT:

ANZAC DAY COMMEMORATIONS, WELLINGTON CITY MONDAY 25 APRIL 2011

1. Description of Event

The Wellington Returned and Services Association (Inc) and Wellington City Council City Events Team have requested the closure of the following roads to safely facilitate commemorations for ANZAC Day:

- **Bunny Street** (between Featherston Street and Lambton Quay); **Lambton Quay** (both sides between Bunny Street and Ballance Street); **Bowen Street** (between The Terrace and Lambton Quay) and **Whitmore Street** (between Stout Street and Lambton Quay), 5am until 6:30am for the Dawn Parade.
- **Molesworth Street** (between Hill Street and the Lambton Quay/Bunny Street intersection) and **Lambton Quay** (northbound side between Bowen Street/Cenotaph and Molesworth Street – access for buses to remain open) between 10:15am and 10:45am for the **Wreath Laying Ceremony**.

The proposed road closures for the Dawn Parade are larger than that for 2010. A small section of Whitmore Street has been added to the proposed road closures - to safely accommodate the increasing numbers of people who attend. The Dawn Parade has become a popular event and draws attendance from a large cross-section of the community.

The events will be advertised in the Our Wellington Page of the Dominion Post in the week preceding ANZAC Day. Public Transport Operators have been consulted with and their requirements will be accommodated.

The event is to be traffic managed and marshalled by a professional traffic management company. Emergency services will have immediate access to the area if required.

This local community event is managed and supported by the Rugby World Cup and Events Directorate.

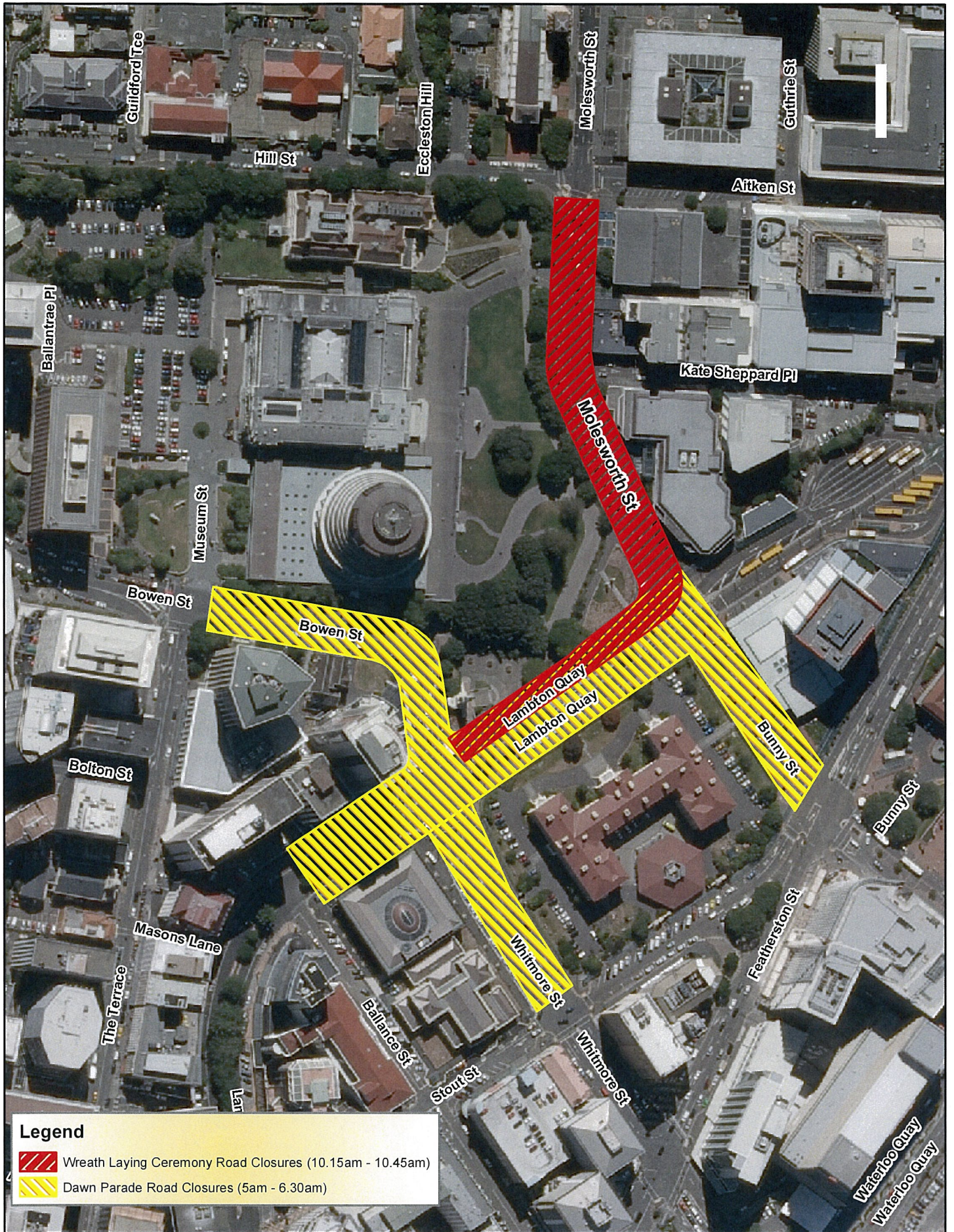

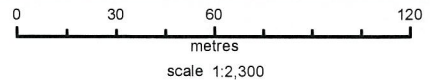

ARMSTRONG MOTOR GROUP WELLINGTON MARATHON, HALF MARATHON & 10KM RUN – SUNDAY 19 JUNE 2011

1. Description of Event

Established in 1986, the newly named Armstrong Motor Group Wellington Marathon, Half Marathon & 10km Run event is one of the largest community events during the winter months. Organised by the Wellington Marathon Clinic, approximately 4,900 runners and walkers entered the 2010 event – with the event experiencing a 200% growth since 2003. The event follows a scenic out-and-back route from Westpac Stadium, along Waterloo Quay, through the waterfront area, Waitangi Park, Oriental Parade/Oriental Bay, Evans Bay, Cobham Drive and around the Eastern Bays to the Pass of Branda, Breaker Bay and return. This year's event is programmed for Sunday 19 June, with the first set of marathon walkers leaving Westpac Stadium at 6:30am, followed by the marathon itself at 7:30am, the half marathon at 9.00am, 10km run/walk at 9:15am and Kids' Magic Mile at 9:25am. Road closures are required on sections of the course that are narrow and involve blind corners. On these roads it is difficult to safely manage traffic without a road closure. Permission is sought to close **Shelly Bay Road** (from Miramar Avenue to Massey Road) and **Massey Road** (until a point just north of Scorching Bay Road) to vehicle traffic between 8am and 11.30am on Sunday 19 June 2011.

Aside from the above road closures, the Wellington Marathon Clinic also proposes the same one way traffic system on Oriental Parade and Evans Bay Parade as that run in 2009 and 2010. They again seek Council and community support and approval for the system to safely manage traffic flows and participants. Because of the numbers now participating, it is felt that an on road course makes the event more pleasurable and safer for both serious and recreational runners and walkers. It is therefore proposed to close the entire seaward traffic lane of Oriental Parade and Evans Bay Parade (from Herd Street all the way to Cobham Drive), where it's proposed the marathon will operate as an out-and-back course. Normal vehicular traffic will operate via a one way system in the landward side lane - from the eastern suburbs to the city. A possible 1 hour only managed traffic detour via Roseneath is also proposed (to more safely accommodate the 10km turnaround) on Evans Bay Parade. This is subject to a detailed layout of the detour route with an approved Traffic Management Plan that safely manages all vehicle traffic.

A suitable traffic management plan approved by a Council Officer will also be necessary for the entire proposal, as well as for other areas that involve lane

closures and parking restrictions - including Waterloo, Customhouse and Jervois Quays. Other traffic management procedures will also be in place (as per other years) on Cobham Drive (NZTA approval required), Miramar Avenue, Karaka Bay Road, Marine Parade, Inglis Street, The Pass of Branda and Breaker Bay Road.

Public notification signs will be placed at strategic points around the course at least one week prior to the event. Residents and local businesses will receive letter drops advising them of the event, the proposed one way system and the road closures. The event and proposed traffic management system is also to be advertised in the Our Wellington Page of the Dominion Post in the week preceding the event.

The event is to be managed by a professional traffic management company. Emergency services will have immediate access to all areas if required.

- The event organiser is to provide marshals at all partial and full closure ends to ensure that public safety (interaction of traffic and spectators) is not compromised. This is essential where road closures transition from partial to full closures and vice versa.
- The event organiser is to work with the public transport operators to provide alternative public transport route and bus stops along the proposed partial and full closures.
- The event organiser is to provide adequate detour routes to provide access for affected residents and businesses during the event.
- The event organiser is to provide full details of the Traffic Management Plan to Council for approval prior to the event.




