My Name is David Wilcock

Our family have lived in Newtown for approx 8 yrs and have had our family business for 17yrs in Newtown.

We presently have a couple of hairdressing shops called Amadeus Hair & Cut n Go.

I represent the business owners in Newtown ...being the Newtown Business Group coordinator

Having a hairsalon keeps me informed of whats going on in our community and our communities concerns.

I have enclosed a list of letters and photos supplied to me from our local business community seeking a Liquor Ban for Newtown.

As we all know we are presently in a recesssion. Many businesses are struggling and matters are made worse when you have to deal with antisocial behaviour, damage to our shops, together with our Newtown business area that is in a decline.

Last year we have had three established businesses close and two others closed after a short time.

Estillo Fabric Direct Als cameras

Paris cafe Clothes store.

As Tom has said. Newtown is unique to other suburbs and with this we have our own set of problems and challengers which we need help from the Wellington City Council.

Newtown Business have suffered from the following antisocial behaviour directly attributed to liquor:

Broken windows

Damage to property

Graffitti

Tags etched on windows ...even our community police station is not immune..

Empty alcohol bottles discarded

Broken glass

Shops doorways urinated on

Vomit outside our shops fronts

People bludging money to buy alcohol.

Intoxicated people sleeping and loitering outside our shops

Intoxicated people shouting bad language and abuse in public.

Examples of Antisocial behaviour

Alcoholics meeting in groups to drink in public areas, discarding bottles and packaging. Bad language and being abusive. One problem area is the Childrens park on Riddiford and Constable streets. Also Karrara Park, broken bottles and rubbish left with the locals having to clean up before they can let their children play safely.

Outside New World Supermarket.

A favourite place for buskers (mental health / alcoholics/ binge drinkers) when they get together as a group they tend to socialise and start drinking it then goes into a downward spiral and the consequences are they start getting louder, more abusive and use of bad language. The public feel threatened and the Mall shopkeepers are frustrated because some of them have a buskers licence from the WCC. Which makes matters worse when trying to move them on.

Donald Mclean Street area / Zoo bar and business area. As covered by Jan (Nigel Hall decorators) Damage to property, bottles and rubbish left behind, broken glass. Graffitti.

Adelaide Road - Caltex station - Judy

Judy to explain problems with young people drinking and cars.

Bus stops - Riddiford Street

Drinking alcohol at the bustops, bottles left behind and can be known to be abusive and use of bad language . Threatening for the public who wish to use the bus service.

#### Mental Health Patients

No one seems to want to deal with them when they have been drinking or showing antisocial behaviour.

The authorities are not willing to take any responsibility eg Police, WCC, Cat team.

They all say call the otherperson.

Business owners need consistancy, we need one number to call so that the right people can take the appropriate action.

Evidence that the Alcoholics have moved from Wellington CBD to Newtown

We have evidence from a Newtown Shop keeper who had a shop in Cuba Street, who has identified the alcoholics from Wellington City who are now in Newtown.

Negative feedback from the public through our shop and fellow shopkeepers. :

Comments saying Newtown is

Dodgy

Newtown is the rough area of Wellington

We avoid Newtown McDonalds and go to Basin Reserve Mc Donalds

We wont let our children go to the Newtown shops by themselves.

People dont feel safe in Newtown

People feel threatened

Sick of people bludging money

Newtown has a lot of sick people

People avoid coming to Newtown to shop.

There are lots of alcholics in Newtown

Why go to Newtown to shop?

What impression do we give people coming to Wellington and visit Newtown?

Newtown is the gateway to our Zoo, and Wellington Region Hospital.

I believe we could be doing more to make Newtown an attractive destination instead of playing poor cousin to Wellington City.

A liquor ban will help go a long way in helping restore Newtowns Image and safety.

#### Walk wise

A good idea, has it been effective?

Two issues we have:

1 When the walkwise officers do meet a difficult person who has been drinking they presently cannot take the drink off them and calling the police wont help.

They have to wait until they are drunk and dissorderly before the police will take action.

2 Keeping of records, we know liquor related incidents have been recorded but statistically no evidence shown? Why?

Having a liquor ban will empower Walkwise officers in doing their job.

The Newtown business community call upon you, Wellington City Council to take immediate action in putting a liquor ban in place for Newtown. We have simply had enough of these problems caused by liquor and we cannot wait any longer. The Police recognise we have problems and have allocated 10 police officers to Newtown . We also need the WCC to put in the necessary resources to deal with these problems.

When I first got the notice of a public meeting to discuss the effects of people consuming alcohol in Newtown I thought that it didn't really affect myself or my business. However on further reflection I realised that even though I live in a pretty quiet street and my business is not in the main street it does have an effect in the following ways:

In the last year there seems to be an increasing number of beer bottles littering the street near my business that I am picking up and disposing of before they get broken – I am guaranteed to find empty alcohol bottles around the shop or adjacent areas every Saturday morning and if I am around on Sunday mornings also.

A large window was smashed in our workspace on the corner of Constable St one Friday night last year – this took hours to clean up the glass and considerable cost and time for the landlord to sort out with the insurance company although we can't prove the window was smashed by drunk people it is highly unlikely that someone sober would do something like this. The shop across from me also had a road barrier thrown through one of its windows just before Christmas – hardly the behaviour of a sober person.

One of my neighbours woke up this Sunday to find that a beer bottle had been thrown through the back window of their car – a major inconvenience for a family with two small children. Daniell/Princess St still has broken bottles in the gutter and other bottles lying around.

These examples may not seem like major problems but I think they indicate an increasing disregard by the drinkers for local residents and the environment. As a community we need to let these people know that we do not think their behaviour, their littering and their anti social behaviour is acceptable.

This letter is in support for the motion to ban liquor and to police street gatherings around Gordon Place and 216 Riddiford Street.

We have lived in apartment 6/216 Riddiford Street for around 5 years. In those years we have seen many fights and disturbances of all kinds. I have rung the police on a number of occasions because of fights that have broken out, cars being broken into and all out brawling and loud "car" parties. I have also rung noise control because of loud "car" parties and drinkers gathering outside the City Mission.

We are all professionals (teacher, doctor, nurse and film technician) in the flat and work at various hours. Many times during the week people drink with extremely loud music in their cars, once they have finished drinking they then go off driving up and down the street. Last week there was a carload of youths drinking in their cars and "tagging" the surrounding buildings. Because of the schedule of our jobs we come home at various times and frequently need to walk through drunken youths, swearing and defacing buildings, this is very scary and risky especially since at times we must walk amongst them late at night.

I suggest that liquor be completely banned on the streets of Newtown and strictly policed when groups of drunks gather. We are not a flat that complains a lot nor do we call the police but due to the increase of violence and loud drunks we have needed to protect ourselves and our cars.

The Bevan family who are our landlords are continually watching for our safety and cautioning us on certain situations. I feel we must stand up and support them and their noble cause to help make Newtown a safer place for all. This does not mean to single certain groups of people out but to have a general rule for all so that everything we value is respected.



I rang the Council but they did not want to know about it only pass me onto the Police
- 4.) During the day there are often people drinking in the front of the Church. I went to them one day and told them it was not a good look, and they should give the Police permission to move them off the church property. There are often parties on that area at night. In the mornings it is a rubbish tip.
- 5.) I often have to go out at night to the letter box or to deliver letters to our Tenants in Normanby Street and I often have to make my way through drinkers sittings on our front door steps..
- 6.) Gordon Place, the alleyway, and behind the Bus Shelter are always being used as a toilet. We had to put roller doors on our shop fronts because they were always being used as a toilet.
