SPC FORWARD PROGRAMME

1. Purpose of Report

3. Background

The Strategy and Policy Committee Forward Programme is presented for Committee approval on a monthly basis.

4. Discussion

The Forward Programme reflects organisational and political priorities and emerging issues that require decisions from the Strategy and Policy Committee (SPC).

The forward programme has been updated to reflect the Policy Work Programme to Strategy and Policy Committee. Regional governance is obviously a key focus. In addition other priorities are outlined as follows:

- There will be an ongoing work programme to deal with the Crown and Council's policy response to earthquake prone buildings, particularly the implications of policy decisions taken by Government and the need to work with the sector to find a balanced workable solution. While future report backs have not been scheduled at this stage officers anticipate reporting to Strategy and Policy Committee regularly as issues arise, direction is needed or decisions are required.
- Officers are continuing to progress the Housing affordability work. A workshop has been scheduled for 26 March where officers will seek your direction on the role of Council in the delivery of affordable housing. Direction is required so that officers can shape the work programme over

- The next 12-18 months and enter into discussions with other providers in the housing sector in good faith.
- Work on Our Living City is progressing well and officers will keep the Committee regularly updated.
- Other report backs on a range of policy priorities including open spaces and recreation framework, a volunteer strategy and action plan and Alcohol management plan and policy have been scheduled.

It is anticipated that external demands, particularly from proposed changes to government policy will provide additional pressure on resources and on the forward programme. Consultation time frames are short with little warning about when discussion and consultation documents are going to be released. Officers will keep the Committee updated as information comes to hand. There are approximately 12 SPC meetings scheduled to deal with Committee business between now and year end excluding annual plan deliberations and oral hearings.

The draft Forward Programme attached as Appendix 1 highlights reports to be presented to the end of September 2013.

5. Conclusion

This report presents a draft Forward Programme for the Strategy and Policy Committee's approval.
