The rural chapter has not yet been comprehensively reviewed and is therefore due for review under the Resource Management Act's 10 year review cycle.

In February this year Strategy and Policy Committee approved a new programme for the review of the District Plan which included a review of the Rural Zone chapter commencing with background work this year, which would then morph into community consultation over the next 18 months or so and culminate in notifying a plan change in about February 2014. It is very early days in this process.

A plan change does not necessarily mean fundamental change - the rules could stay more or less the way they are - however we are required to give greater focus to landscape and vegetation protection because of changes made by the regional council.

Andrew Macleod noted that he is happy to come to next month's Board meeting to answer any questions and go through the process for making rule changes.
