DISCRETIONARY FUND EXPENDITURE

1. Purpose of Report

To seek the Board's approval for expenditure of funds to replace pads on the defibrillator purchased by the Tawa Community Board located at Unichem Drummonds Pharmacy in Tawa.

2. Recommendations

It is recommended that the Tawa Community Board:

- 2. Approve the expenditure of \$150.75 including GST for replacement pads for the defibrillator located at Unichem Drummonds Pharmacy in Tawa.

3. Background

The Tawa Community Board in 2011 agreed to purchase a defibrillator from its Discretionary Fund and that it would be located in Unichem Drummonds Pharmacy. The supplier of the defibrillator has been in contact with Pharmacy owner Chris Reading to advise that the pads are due for replacement. The cost of replacement pads are \$150.75 including GST (\$125 ex GST) and the courier charge.
