#### 1.3 APW Awards

#### **The Wellington Tramway Museum Volunteers**

It is my pleasure to present an Absolutely Positively Wellingtonian Award to The Wellington Tramway Museum volunteers.

The Wellington Tramway Museum society, which owns the Tramway, was incorporated in 1964 as a non-profit organisation. The group preserves tramcars and other items of tramway interest. They make sure that Wellington's fascinating tramway history is accessible to all.

The work of the membership (made up completely of volunteers) has made it possible for this operating museum to maintain, restore and operate historic street trams which were a vital part of the capital's transportation system for 60 years.

The volunteers just celebrated 50 years of dedication to the operation of former Wellington electric trams at Queen Elizabeth Park in Paekākāriki.

The majority of the trams were presented to the museum by the Wellington City Council when the trams were withdrawn from the streets of the city in 1964.

The volunteers then created a working electric tramway, first laying the steel tracks over parkland, erecting the overhead electric wiring system, and building the large barns that ensure the vehicles are safe from the elements.

It is thanks to these volunteers that these trams have become an attraction for Wellingtonians and tourists.

The Wellington Tramway Museum volunteers, past and present, have given their time freely to make the museum the establishment it is today. I'd like to acknowledge and thank all of these volunteers.

#### John Shrapnell

It is my pleasure to present an Absolutely Positively Wellingtonian Award to John Shrapnell for his contribution to the Wadestown Community.

John was born in London and is a descendant of British army officer, also called John Shrapnel, (minus an 'l') who invented the 'shrapnel shell'. John spent time in the Royal Air Force, but spent the majority of his career working in the media as a director, actor, editor and producer.

John worked for the New Zealand Broadcasting Corporation and when television started became an editor of NZBC Newsreel. His role as a reporter on "Town and Around", a nightly show which played on screen in NZ during the late 60's, made him a familiar face for Wellingtonians. The piece John did on unlocked vehicles in the capital can still be viewed on NZ On Screen.

John travelled the world for television, but always came home to Wadestown, where he has lived at his current address since 1966. Along with his wife Bron and daughters Fiona and Amanda, he has worked to support community life in Wadestown for many years.

It was dogs that smelled like sewerage threatening residents' health which led John and 11 others to found the Wadestown Residents Association in September 1970. Since then, John and the Wadestown Residents Association have lobbied tirelessly on the Wadestown community's behalf.

John was the Association President for 25 years, before he stepped down in 2011. He has been a pivotal figure in a number of Wadestown events and activities over the past 4 decades. He also formed the Wadestown Coalition of Residents' Associations of Wellington, the Wadestown Community information website and the Community Liaison group which meets monthly at the library and he still chairs.

John is the embodiment of community spirit. He initiated the Wadestown fair in 1995, and has run it every year since, until this year. This fair is invaluable for building community networks.

Recently John has developed a keen interest in supporting the work of the Wellington Menz Shed, who provide companionship and learning opportunities for older men in the city. Their work benefits many community organisations.

Wellington City Council and John have not always agreed on issues, but we have always been united in our passion for Wellington. Having a variety of opinions and the freedom to challenge governing bodies is a hallmark of democracy, and we are very glad to have community stalwarts like John.

On behalf of the Wellington City Council, I'd like to thank John and declare him an Absolutely Positively Wellingtonian.
