

There are significant environmental impacts of extending the quarry, notably the loss of indigenous forest vegetation, reduced habitation for birds and wildlife, the seismic risk to the surrounding land, and the discharge of contaminants and air pollution. The impact on Wellington's gateway experience is also of concern, how can we be "the coolest little capital in the world" if a major quarry welcomes visitors and residents into the city. The Council website states Wellington is "embraced by a natural amphitheater of ocean and hill [and]...is also known as a socially and environmentally conscious city"! Is being an environmentally conscious city still an ambition for the Council? This proposal suggests, perhaps not.

Also, proposed district plan change 83 appears to be a short term solution. We understand it will provide only ten years of aggregate. We question whether the destruction of natural habitat (birds, lizards and other creatures) and gateway values, and disruption and risk to nearby residents will actually be worth it. We believe council should consider longer term options.

We also believe that the outcomes of the initial consultation process did not consider or properly reflect the submissions including sentiment and concern of residents located near the quarry. Page three of information sheet provided by the council says "We received 72 submissions. The majority of submissions favoured the maximum expansion option." However, we would like to note that the majority of these submissions were received from people living outside of the Wellington region and those with a direct interest (ie will use aggregate and will likely earn income from the proposed quarry expansion). It appears the proposed expansion of the quarry is biased towards supporting corporate business.

At the hearing / meeting of the council earlier in 2018 to discuss the proposal, there appeared to be some misunderstanding of the impacts to nearby residents in Khandallah. The comment was made by the Mayor, who said "If we were to have this quarry in other locations in the city, I can guarantee you the good people of Karori, Thorndon or Khandallah would not tolerate a quarry in their proximity." The proposed quarry extension backs onto Khandallah. This suggests the full impacts of the proposal were not fully understood, nor given full consideration by council members. This concerns us. Happy to provide a recording if need be.

We oppose the Proposed District Plan Change 83 - Kiwi Point Quarry.
