Comments

Taylor Preston Ltd (TPL) is located in the area adjacent to the Kiwi Point Quarry and is a Lessee of land owned by WCC which is in part affected by Proposed District Plan Change 83. TPL also holds Access, Grazing and Car Parking Licences which are affected by the proposed Plan Change and subsequent quarry expansion. Taylor Preston is a significant employer and economic contributor to the Wellington region - with over 650 FTE employees and sales revenue of \$260m p.a. our economic contribution dwarfs the proposed benefits of expanding the quarry. An independent economic impact analysis by BERL has already been supplied to WCC to confirm our contribution. In the current form we do not support the Proposed District Plan Change for several reasons. Firstly, the proposed area of quarrying and cleanfill operations includes TPL leasehold land, legal access to that land and TPL Grazing Licence Land. There has been no communication from WCC in regard to the Lease Land and Legal Access. There has been some conversation about Grazing Land but nothing specific. Secondly the traffic movement clause is brief to the point of inadequacy. The clause only mentions that the one point of entry/exit (crossing 22 that is also TPL's main entry) must be maintained to the standard of local streets. The point is that traffic management is not only required within the quarry but also between the quarry and TPL. At peak production periods we have in excess of 800 employees and a significant number of truck movements. Our priority - and we submit the priority of WCC and the guarry, is the safe entry and exit or our staff and the continued safe operation of stock delivery and product despatch. Finally TPL should be included in the list of neighbours to get written (or email) notice of blasting.

I seek the following decision from Council (please give precise details)

Comments

TPL seeks to have the Proposed District Plan Change amended to reflect our concerns. Specifically: Acknowledgement from WCC that if they do want or need parts of our land that an appropriate agreement as to compensation and/or alternative arrangements will be negotiated. TPL seeks involvement in development of traffic management plans for the quarry and specifically for the interface between TPL and the quarry. TPL needs to approve in writing any traffic management plan or movement that affects or potentially affects the safety of our staff and contractors. Traffic management should also be included in 34.2.3 as a matter of control for WCC. TPL wish to be notified in writing (email is acceptable) and by phone 5 minutes prior to blasting. TPL wish to be specifically notified of consent applications in relation to the quarry. As the closest neighbour we wish to be aware of possible future consents and their impact on our business.
