Comments

We oppose the rezoning. As a long term neighbours of the quarry we have concerns at the ability of the quarry to contain dust and noise impacts within their boundary. And also maintain land mitigated during the Quarrying process. Also with the blasting that needs to be done and the ongoing effects that this has on properties around the site and the land instability that this could cause. We are also concerned that with the removal of this section of the hillside that the wind flow will change and the impact this could have on the local area and residents. That this rezoning of the South face from open space 2 to Business 2 is only a short term stop gap in supplying rock, and that a long term replacement for the quarry needs to be sorted now as this is only a 20 year lifespan according to the information provided. Our original submission included points on the potential benefits of extending the quarry. We remain unconvinced that those benefits are real. We also believe this will not present Wellington in a good light. This is the gateway to our city

We oppose the rezoning of the South face from open space 2 to Business as per the concerns stated in our submissions and that all activity should be stopped. If rezoning is approved then we request that: Mitigation should start as soon as one area is finished and not delayed till the end of the quarrying process. A mitigation management plan is put in place that details dates, areas to be worked on and when mitigation will be started and completed for each section.
