PROPOSED DISTRICT PLAN CHANGE 53 – Proposed Additions & Deletions to Listed Heritage Buildings,

Objects & Areas WELLINGTON CITY DISTRICT PLAN

Clause 5 of First Schedule, Resource Management Act 1991

In 2005, the Council completed its heritage review and adopted the Built Heritage Policy. This recommended greater protection for the City's built heritage under the District Plan.

Plan Change 53 proposes the addition of 50 buildings and objects to the District Plan Heritage List. These items cover a wide variety of styles and periods of built heritage and include both Council-owned and privately-owned items. The plan change proposes the listing of new heritage items at the following locations:

Plan Change 53 also proposes the creation of a Heritage Area at Fort Balance above Massey Road, Miramar (Symbol Reference 6 Map 13).

In addition, Plan Change 53 proposes that the MED - former Capital Power Building at 40 Cuba Street (Symbol Reference 72/2 Map 16) - be removed from the Heritage List.

The submission must be in Form 5 of the Resource Management (Forms, Fees and Procedure) Regulations 2003 or similar, and must state whether or not you wish to be heard on your submission. Submissions close at 5pm on Monday 26 February 2007. The process for public participation in the consideration of the proposed plan change under the Act is as follows:

- after the closing date for submissions, the Council will prepare a summary of the submissions and this summary must be publicly notified; and
- there will be an opportunity to make a further submission in support of, or in opposition to, the submissions already made; and
- if a person making a submission asks to be heard in support of his or her submission, a hearing must be held; and
- the Council will give its decision on the proposed plan change (including its reasons for accepting or rejecting submissions); and
- any person who has made a submission has the right to appeal the decision on the proposed plan change to the Environment Court.
