## 090/09MB UPDATE ON WELLINGTON CITY COUNCIL'S FOREST SINK WORK PROGRAMME (1215/13/IM)

#### **NOTED:**

Amber Bill, Manager Community Engagement and Reserves, Parks and Gardens was in attendance for this item. She advised that the Council had recently submitted its first Permanent Forest Sink Initiative (PFSI) application to the Ministry of Agriculture and Forestry (MAF) for the Makara Peak area. This forest sink area includes parts of the Makara Peak reserve, the land buffering the Karori Sewage Treatment Plant and the Makara Cemetery. If the application is successful, the Council would place the Makara forest sink land under a protective "permanent forest sink"

covenant. The Council will receive tradable emission units in proportion to the carbon absorbed by the forest sink each year.
