The Deputy Chair advised the meeting that Council Officers had investigated an issue of earthworks at 195 McLintock Street North which was visible from Ohariu Valley.

Officers advised the following:

"Officers have now completed their investigation.

The ridgeline has not been levelled, what has occurred is a developer has placed earth on top of the ridgeline.

The earth placed on the ridgeline originated from earthworks carried out at the development at 195 McLintock Street, Resource Consent SR: 194454. Placing the fill on top of the ridgeline is not permitted under the resource consent therefore this is a breach of the District Plan rules.

An abatement notice will be served on the developer to remove the earth so that the ridgeline is reinstated and to hydro-seed the exposed area.

The abatement notice will require the work to be completed within two weeks from the date of issue. Follow up inspections will be undertaken

We are currently considering whether some sort of punitive action is appropriate. This is likely to involve an infringement fine.
