2.4 Makara Guardians Incorporated

Judy Liddell agreed to ascertain the progress made by Meridian in terms of getting a flood engineer to investigate the possibility of flood levels increasing as a result of the implementation of its Environmental Enhancement Plan ('the Plan'). Christine Grace in turn advised that she would forward the correspondence received from the Makara Guardians Incorporated ('the Guardians') to the Greater Wellington Regional Council (GWRC) along with a letter from the Board. Additionally the Board will seek both an independent review of the issues around the potential for greater flooding and a copy of the Meridian/GWRC covenant, which has the purpose of achieving the vision described in the Plan.

Christine Grace noted the Guardians' suggestion that a noise monitoring station be constructed at the head of the Makara Beach valley. She requested that officers explore this proposal's feasibility and report their findings back to the Board.

Christine Grace sought members' input in terms of creating an exhaustive list of roading issues in the Board's catchment area. Once complete this would then be passed on for actioning to Anthony Wilson, Council's Chief Asset Officer.
