REPORT 3 (1215/11/IM)

2010 DRAFT CLIMATE CHANGE ACTION PLAN

1. Purpose of Report

To seek the Council's agreement to consult on the draft 2010 Climate Change Action Plan in conjunction with the 2010/11 Draft Annual Plan.

2. Recommendations

Officers recommend that the Council:

- 1. Receive the information.
- 2. Note that the Strategy and Policy Committee agreed:
 - (a) that the Draft 2010 Climate Change Action Plan be considered by Council for consultation in conjunction with the 2010/11 Draft Annual Plan
 - *(b) five new initiatives from the Draft Climate Change Action Plan be included in the Statement of Proposal for consultation.*
- *3.* Agree the Draft 2010 Climate Change Action Plan (attached as Appendix 1) for consultation alongside the 2010/11 Draft Annual Plan.
- 4. Note that officers will make the necessary publication and design changes to the Draft 2010 Climate Change Action Plan to ensure a readable and user friendly consultation document.

3. Background

In December 2009, the Strategy and Policy Committee agreed:

- to the approach of the Draft 2010 Climate Change Action Plan
- that five climate change initiatives be included in the 2010/11 DAP deliberations for consideration
- that the Draft 2010 Climate Change Action Plan be considered by Council in March 2010 for consultation in conjunction with the 2010/11 DAP.

At the DAP deliberations from 2-3 March, the Committee agreed that the following five new climate change initiatives be included in the 2010/11 DAP statement of proposal to be presented to Council on 17 March:

4. Discussion

The Draft 2010 Climate Change Action Plan (attached as Appendix 1) has been developed by considering international best practice, internal options analysis and input from key external stakeholders. This paper is seeking the Council's agreement to consult on the Draft 2010 Climate Change Action Plan in conjunction with the 2010/11 DAP. The consultation will seek feedback and input from the community and key stakeholders:

- on the initiatives contained in the Draft Plan
- that the Council is focusing on the right areas and actions
- that actions in the Draft Plan are a priority when considered alongside, and in the context of, other initiatives in the 2010/11 Draft Annual Plan.

4.1 Consultation and Engagement

The actions identified in the 2010 Climate Change Action Plan represent a pragmatic approach in responding to climate change. They provide the foundation for a more ambitious programme when reviewed as part of the 2012/22 Long Term Council Community Plan (LTCCP).

If agreed for consultation, officers will design a user friendly consultation document based on the document text attached as Appendix 1. This will include images, graphics and other techniques to help emphasize the key messages and issues of the Draft Climate Change Action Plan. Consultation would include (amongst other approaches):

- public workshops alongside Draft Annual Plan presentations
- web based and other publication materials
- engagement with the Environmental Reference Group
- oral hearings.

Analysis of submissions and recommendations would be brought back to the Strategy and Policy Committee in early June.

4.2 LTCCP and Financial Considerations

The 2010 Climate Change Action Plan fulfils the Council's 3-year priority of taking steps to reduce greenhouse gas emissions for the city and the Council. It proposes five new funding initiatives that SPC agreed to consult on in the 2010/11 DAP. The funding implications for these initiatives are outlined in the table below.

This report is consistent with the outcomes and priorities of the Environment Strategy, the Urban Development Strategy and the Transport Strategy as reflected in the LTCCP. The advice provided supports existing policy and planning work to implement the Council's strategic direction, such as compact growth, waste minimisation and energy management planning.
