Purpose of the Pacific Advisory Group (PAG)

- Advise Council on how to help grow a great City, where Pasifika peoples thrive and contribute to Council's priorities.
- Bring knowledge and extra insight into Council about how the different needs of Wellington's Pasifika communities can be addressed in the context of Council's roles and priorities.

Expectations

The Role of the Pacific Advisory Group is to provide:

- Constructive advice – on Council projects and policies, where possible identifying evidence and solutions, whilst taking into account the wider needs, issues and views of communities from the Pacific nations that PAG members are from.
- Communication – engage with the Council and Pasifika communities to increase information flow and build knowledge of Council processes to increase involvement in Council decision-making.
- Involvement of communities – work with council staff to help Council involve more people from Wellington's Pasifika communities in the setting and meeting of city-wide objectives. The Council is ultimately responsible for full community consultation.

- 1 Candidates for the position of Tuvaluan Representative of the Wellington City Council must live in the Wellington City Council area and be a New Zealand citizen, enrolled as a parliamentary elector and be of Tuvaluan descent.
- 2 Both nominators must be enrolled as electors in the Wellington City area and be of Tuvaluan descent.
- 3 A candidate cannot nominate themselves for office.
- 4 A candidate can be nominated under a name which the candidate is commonly known provided that the name will not: cause offence to a reasonable person or is unreasonably long.
- 5 Nominations of candidates **must** be in the hands of the Democratic Service Team, Wellington City Council, Reception, 101 Wakefield Street, Wellington, not later than: 5pm on the 26th day of January 2016.

CANDIDATE PROFILE

The Candidate is required to provide a brief Profile (maximum of 250 words) outlining the following:

- Strategic thinking skills and experience - able to identify and present issues of strategic importance to Pacific communities and the Council.
- Governance experience - able to demonstrate governance experience, and it's relevance to Pacific communities.
- Excellent understanding of Pacific communities and their networks, community development or expertise in a relevant field.
- Commitment to the development of Pacific peoples, credibility, excellent people skills, communication abilities and strong advocacy for pacific people.
- Highest integrity, be inclusive, have a collaborative approach to issues.
- The ability to speak a Pacific language is desirable, but not essential.

The profile must include a recent passport size photograph of the candidate and both the profile statement and the photograph must be lodged together with the nomination form.
