	Alex Grey: A steep learning curve for pedestrians and in hindsight considers more temporary barriers were required. Has noted more pedestrians are looking before they step out (especially between Taranaki and Cuba streets). The wide footpath is working well and the bus route is quicker.
	Mike Mellor: Feels it runs pretty well and bus traffic is moving better. Some cyclists and motorists are still using the bus only lane. The Manners and Victoria traffic lights need some work and are blocked on one side. The road markings are not as clear.
	David Laing: Cycling routes around the city are difficult now; people seem to use the pedestrian crossing points more often than other parts of the city.

## **Child restraints campaign**

WCC and Police are continuing to run weekly child restraint checkpoints throughout the city (staff availability and weather permitting). Location selection is based on feedback from our police colleagues and local knowledge. Drivers with incorrectly restrained children are given tickets with 14 days to comply where appropriate. The main issue continues to be incorrect installation or no tether strap in use. Since our last meeting we have checked 326 vehicles with an average of 55% compliance. These checkpoints require significant commitment from Wellington police, and we wish to extend thanks to the Wellington STU for their on-going support.

On the 12<sup>th</sup> of February I had a display on child safety around vehicles at the Wesley church home safety day. This was a safety event attended by the Fire service and other health providers and organised by the ACC.

I have been in touch with PORSE child car and organised to do a presentation for their carers on the  $31^{st}$  of March.

## Motorcycles

I am delivering our subsidised motorcycle training in Wellington; ROADSAFE Ltd won the tendering process and the dates set are:

- $\approx 17^{th}$  March beginner riders this was cancelled due to lack of numbers.
- ≈ 23<sup>rd</sup> March moped riders this has been cancelled due to lack of numbers.

This is a joint project with UHCC, HCC, KCDC, WAIRSC, ACC and PCC. I am in discussion with our comms and marketing team to look at how we can better publicise this opportunity.

I am also currently delivering six high profile motorcycle checkpoints – these are targeting new riders. We have completed three so far and spoken to 98 moped or motorcycle riders. These checkpoints are done in conjunction with the STU.

## Intersection campaign – It's Your Call

The next phase of intersection campaign is currently being delivered and features the following media: radio, adshells and bus backs. It will follow the same lines as the November campaign and will be followed up with a Spotter campaign in April. This campaign involves both ACC and Hutt City Council and we would like to thank them for their support.

## Pedestrians

The 'Look Both Way's campaign has been launch as of late February with a multi-media approach building on the imagery and branding form the Manners street campaign. Currently we have radio and bus advertising and have had the Look walkers on the golden mile last week targeting afternoon workers in the CBD.

## Cyclists

Emma and I had stand at the Go-by-Bike breakfast which is organised by CAW as part of the Bike wise month. I had developed a shared pathways resource which was distributed at this event along with bicycle bells. In May we will look to do our cycle lights campaign with the Police again.

### Alcohol

The week prior top Christmas we (myself and Sgt. Pete Sowter) had the 'Last Choice' Crash trailer at the Wellington Railways station promoting the drive sober message to CBD employees.

I have recently met with the new SADD coordinator for this region who is based in Napier. He is keen to get SADD moving in Wellington High Schools again.

I have also attended the Orientation clubs day at Massey University (Victoria was called off due to rain) where I helped to promote the 'Stick with your Mates' pedestrian alcohol safety message as well as moped/motorcycle safety.

#### **Young Drivers**

I am looking to utilise a space at the Coca Cola careers expo at the TSB arena in late June which will target young drivers using the Last choice crash trailer.

#### Billboards

The billboards are currently displaying the "Stick with your Mates" which is part of the pedestrian alcohol safety campaign and will be changed to reflect the pedestrian 'Look Both Ways' campaign soon.

### **Orange Day**

The Orange Day parade which celebrate the work of school road patrols and draw attention to safety around schools will occur on July the 1<sup>st</sup> this year (it als been brought forward because of the Rugby World Cup).

#### **School Travel Plans**

In addition to the 14 schools currently signed on, this calendar year we welcome on Bellevue School and Strathmore Community School. We have also had interest from Khandallah School, Queen Margaret College and West Park School.

Existing schools are, for the most part, progressing well, with a number of schools due to undertake an annual follow-up survey of transport modes to school next term. This survey will be able to be compared with the base-line survey, and will give us an insight into the effectiveness of the programme.

All signed-on primary schools have now received waterproof, high-visibility backpack covers for each child at the school. A number of schools have adopted these into the school ethos, where they are given to each new-entrant along with information for the parents about how to reduce vehicle congestion outside the school.

#### **Organisational Travel Plans**

The Wellington City Council Staff Travelwise plan was formally 'launched' in August 2010. All staff were invited to be part of the broader, 'Active A2B' project. A cycle training module is also in the process of being developed with local cycle trainers, which would be offered to staff interested in using the fleet bicycles.

## Walking and Cycling Policy Implementation

Walk2Work Day

The annual Walk2Work event was delivered on 16 March 2011. The original plan for this event was to have one main site at Frank Kitts Park, where people walking could receive apples, bananas, fruit buns and a coffee voucher, as well as five "Snack Stations" situated around the city, where walkers could receive a piece of fruit as they walked by. Unfortunately a rainy morning meant that the main Frank Kitts event was cancelled; however an additional two 'Snack Stations' meant that walking commuters were still reached during the morning. Although exact numbers as difficult to measure, it is estimated that approximately 2,000 people were reached -1,300 apples, 1,000 fruit buns, 1,000 coffee vouchers and 500 bananas were distributed during the morning.

Thanks to members from Living Streets Aotearoa, Greater Wellington Regional Council, Cancer Society Wellington and Regional Public Health for their efforts as part of the organising group.

#### **Cycle Skills Training Courses**

Two cycle skills training courses were offered January and February, promoted through the Greater Wellington 'Active a2b' project. Evaluation results from the 2010 skills training are included at the back of this report. There was a 50% response rate (taking into account there were a number of children, and their parents responded on their behalf), all respondents found the training either 'useful' or 'very useful', and responded learning a number of different skills from the training.
