MY SUBMISSION IS THAT

We support those aspects of the plan change which recognise the unique setting of the site in a valley surrounded by a residential zone. Particularly those provisions which provide protection for surrounding residents in terms of light, noise and traffic.

2. Noise and lighting

a. This site is surrounded by residential housing. Many residents homes, including ours, is in a 'direct line of sight' (Proposed District Plan Change 77: Curtis Street Business Area - December 2012 Report Proposed Curtis Street District Plan Change Noise Advice ('direct line of sight' description is at the rear of this report with age and section unnumbered) for noise. The sound of a single hammer to erect framing for the KinderCare building can be easily heard from our house. All noise levels, including any fixed plant noise and external ventilation systems machinery, should not exceed that set for residential areas.

b. Lighting – a general limit of 8 lux across the whole site should not be exceeded to to ensure the surrounding residents, green areas and wildlife habitat are not adversely affected. More requirements for screening and limits on lighting may be needed to protect the glow worm colonies and buffer planting and regenerating areas on the fringes of the site.

3. Traffic and congestion

a. The Concept plan should include specific provisions for entry and exit to the site to recognise the narrow character of Curtis Street and immediate neighbouring streets. This should involve greater parking provisions given the minimal lack of parking for current Curtis Street residents and the potential increase in need for short/medium term parking for the Kindercare facility once active. b.With the significant increase in traffic consideration should be given to the placement of traffic lights or one or more pedestrian crossing/s (currently lacking) to allow public to safely cross the street.

We seek council to revisit

Noise and lighting

- All noise levels, including any fixed plant noise and external ventilation systems machinery, should not exceed that set for residential areas.
- More requirements for screening and limits on lighting may be needed to protect residents privacy, the glow worm colonies and buffer planting and regenerating areas on the fringes of the site.

Traffic and congestion

- entry and exit provisions to/from the site
- traffic feeding back into Chaytor and Whitehead Rd
- pedestrian movements to the site from Curtis Street, Whitehead Rd and Chaytor Street
