Whakarāpopoto | Executive Summary

- 3. The Appointments Group unanimously recommend the reappointment of Alan Isaac to as Chair of the Basin Reserve Trust, the appointment of John Apanowicz as Wellington City Council's (WCC) elected member on the Board of the Wellington Regional Economic Development Agency Ltd., and the appointment of Justin Lester as a director of Predator Free Wellington.
- 4. These appointments and reappointment are supported by officers and the respective Chairs of these Boards.

Takenga mai | Background

- 5. The Council, through the Committee, approves the appointment of board members to our Council Controlled Organisations, in line with the Council's Appointments Policy and the Local Government Act 2002.
- 6. In terms of Council's Appointment's Policy, the term for a director/trustee is initially for a period of three years and the total tenure is typically six years.

Basin Reserve Trust

- The Basin Reserve Trust is governed by a Board comprising four trustees, two 7. appointed by Cricket Wellington and two by WCC. The current Board is comprised of:
 - Alan Issac (Chair) appointed by WCC
 - Councillor John Apanowicz appointed by WCC
 - Mike Horsley appointed by Cricket Wellington
 - John Greenwood appointed by Cricket Wellington

Wellington Regional Economic Development Agency Ltd.

- 8. Wellington Regional Economic Development Agency Ltd is jointly owned (80%/20%) by the Wellington City Council and the Greater Wellington Regional Council respectively.
- Wellington Regional Economic Development Agency Limited does not currently have elected members represented on its Board. The pending signing of the updated Shareholders Agreement by both WCC and GWRC will enable the appointment of elected members to the Board.

Predator Free Wellington

- 10. Predator Free Wellington (PFW) is a Council Organisation. PFW's vision is to make Wellington the world's first predator free capital city, a place where our native species and communities can thrive. NEXT Foundation is the majority shareholder with 51%. WCC and GWRC hold the balance of the shareholding.
- 11. As a shareholder of PFW, WCC can appoint one Board member. Celia Wade-Brown is currently WCC's representative on the Board and her term will finish in October of this year. PFW would like to bring on Justin Lester as her replacement early as an observer to enable a smooth transition.
- 12. The director capability, skills and experience sought by the PFW Board are as follows:
 - Demonstrated experience working at very Senior roles across public and private organisations. This is key for building strong relationships with stakeholders, potential partners and potential funding streams.
 - Strong communications and engagement experience, including the development of new tools and approaches.
 - Ability to build very senior relationships across government organisations.
 - Links and relationships in the corporate world. The need here is in continuing to grow PFW's partnership and sponsorship base.
 - Experience in the economic and social outcome space. This is a lesser told part of the PFW story.
 - Demonstrated values alignment with the kaupapa and vision of a predator free Wellington.
 - Ability to understand the wider goals, and objectives, and approaches of the Council's Biodiversity Strategy and how these connect to the work of PFW.

Kōrerorero | Discussion

- 13. Alan Isaac (CNZM) has completed two terms as Chair of the Basin Reserve Trust. It is recommended that Alan is reappointed for a further three-year period ending 30 June 2027. See the attached for his CV.
- 14. Alan is highly regarded as the Chair of the Basin Reserve Trust. Alan is an experienced director and has held governance positions over the past 20 years across a breadth of New Zealand and international businesses, from sporting bodies to commercial and Crown entities. In addition to being Chair of the Basin Reserve Trust, Alan is currently Chair of the New Zealand Community Trust, Deputy Chair of Wellington Free Ambulance and a director of Skellerup Holdings Limited, Oceania Healthcare and Scales Corporation, Alan was also President of the International Cricket Council (ICC) from 2012-2014 and Chairman of Partners at KPMG New Zealand from 1996-2006.

- 15. Justin Lester is being recommended as a new director of Predator Free Wellington, initially coming on as an observer before filling a vacant seat on the Board when WCC's current representative Celia Wade-Brown retires in October 2024. See attached for Justin Lester's CV.
- 16. Justin is an experienced director and businessman, as well as being a former Mayor of Wellington. He has strong connections across both central and local government in New Zealand. Justin is currently Director of Government at Dot Loves Data one of New Zealand's leading data products and services companies. He was a co-owner of Dot Loves Data before it was acquired by ANZ Bank via an investment bank sale in 2023. Justin has held a number of governance roles including being Chair of the Weltec Institute of Technology and Whitireia Community Polytechnic. He is currently a director of Storbie a digital e-commerce start-up trading in New Zealand, Australia and the United States.
