<u>Fitzwilliam Terrace</u> - Below is the inspection summary on Fitzwilliam Terrace Tawa, which was asked about in the previous meeting

- 1. The existing surface is a 11-year-old Rack 4/6 chipseal. It is due for a reseal as has moderate binder rise and driveway areas with bleeding/tracking.
- 2. The reasons for the defects are:
  - a. The type of seal used (Racked in seal, which is known to have binder rise issues). Moreover, the previous seal to that was also the same treatment.
  - b. 4 layers of seal indicates potential layer instability however not quite as the binder rise is not severe
  - c. Potential design failure due to parked vehicles, the binder application should have been modified Tracking is common in the peak of summer where there is excess binder as in this street
- 3. The solution would be to chipseal with the right seal design (Two coat seal and one-lane design). Considering the age of the seal, it will be added for condition grading on our next year's program to prevent further binder issues and confirm treatment as chipseal. Some neighboring streets such as Gonville St and St Johns Terrace could also be investigated as they are of the same age.

#### **Remedial Works**

- Main Road Linden Avenue to Gee Street to Wall Place intersection Excessive moisture from the base layer is affecting the road, creating "rutting" and seal failures. This is still being investigated with the previous utility for damages and mitigations.
  - **Transport Structures Team** are currently investigating strengthening works on McLellan Street Bridge no definitive plan of works as yet but programmed maintenance for next financial year 2025/2026.

**Main Road Roundabout** - The Main Rd/Cambridge St intersection safety improvements are near completion of construction, hopefully this week, weather dependant.
