Information: Wellington Town Hall and part of Council's basement parking are

closed due to the severe earthquake that occurred on 21 July 2013. An earthquake strengthening programme will be undertaken over the next two to three years. The existing tour bus stops on Wakefield Street and loading zone in Council's basement will be significantly impacted by the restrengthening programme. As a result it is proposed that the displaced tour operators and a loading zone be accommodated on Victoria Street outside the library. This location is close to the City Information Office and provides good protection for tourists waiting for operators; it also provides easy access for goods

vehicles.

In order to facilitate this change it is proposed to change the order of existing parking spaces. The Loading Zone will be moved into the area designated for two hour parking and the tour bus parking will take up the front three P5 spaces. This still allows for short term visitors to the library and provides good access for the tour operators and goods vehicles.


