It is proposed to convert one existing P10 parking space to a mobility parking space for the resident to access the footpath and nearby ramp.

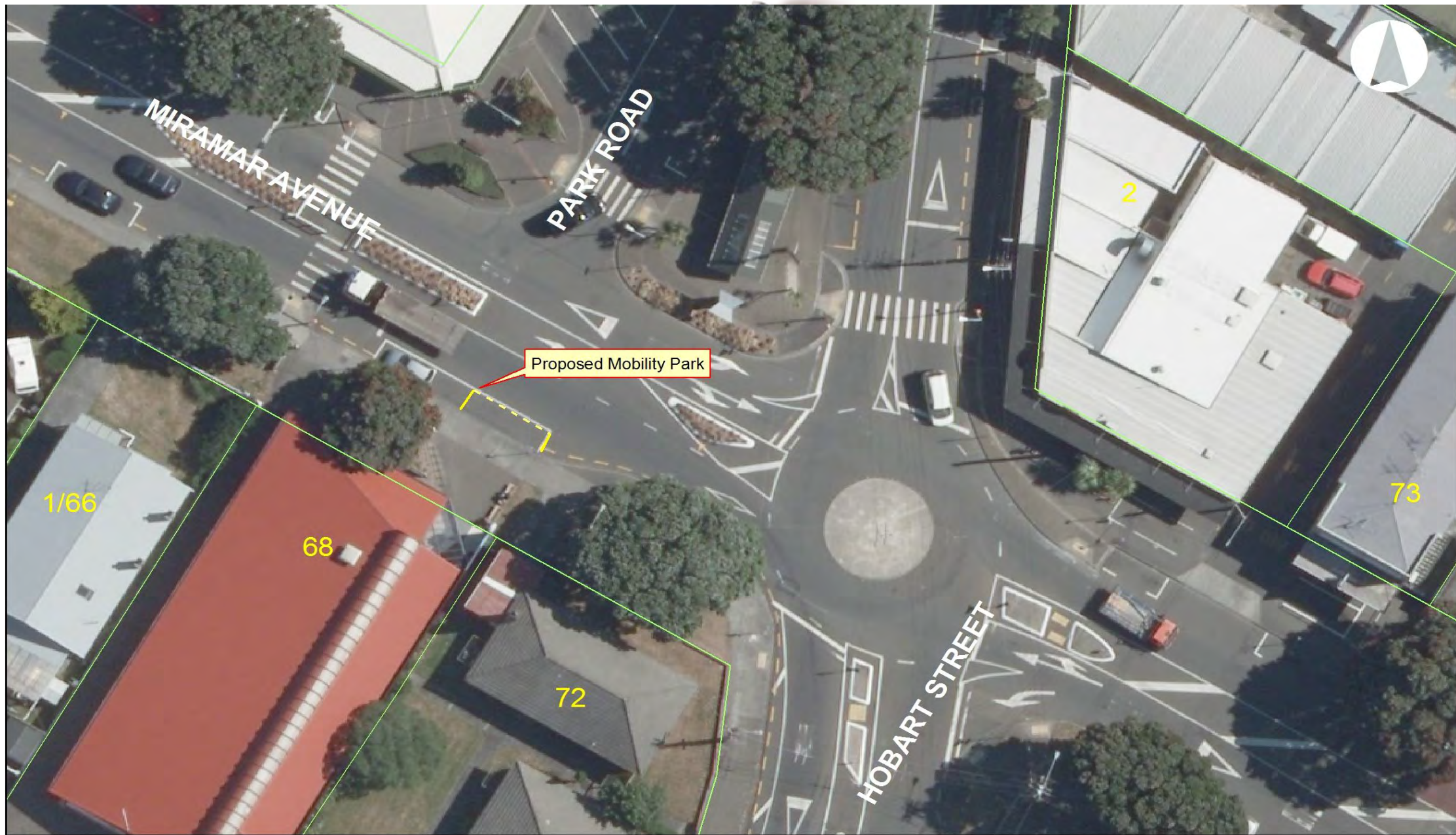
