

Why we are proposing the change	 We have received confirmation from Hey Day that the southern vehicle crossing is no longer used or required and is safely blocked off with the installation of bollards. We propose a metered parking space to be installed in this location which is consistent with the surrounding on-street parking restrictions. 	
Location – where we propose to make the change	Cuba Street, Te Aro – outside no.264	
Impact	 Improves accessibility with greater availability of parking. Net parking impact - addition of one metered parking space. Pedestrian impact - no change. 	
How this relates to the parking policy	 This proposal reflects the existing metered parking along this street. Support business wellbeing – ensure parking management and pricing controls support economic activity in the central city, suburban centres, and mobile trades and services. 	
Additional Information	 Average daily traffic count – 2,650. Monthly parking revenue impact – estimated increase of \$583.10.
