Coupon parking scheme

Eligible residents can apply for a Coupon Parking Exemption Permit which exempts them from daily parking charges associated with the commuter coupon parking scheme. The cost of this service is \$122.50 per year. The exemption permit will enable bona fide residents to park near their homes without displaying a coupon, but not in areas specially set aside for residents-only parking. If you wish to use residents-only zones, please phone for more information. Possession of a permit does not guarantee a parking space.

Permits are not refundable. If the information you supply is not correct, your application will be declined. Remember to sign the form.

Information for permit applications

- 1. If you are a tenant** you must provide evidence that shows you live at the address applied for. This **must** be in the form of either:
 - a copy of a current/recent tenancy agreement with your name on it, signed within the past 12 months; or
 - a copy of a letter from the owner of the property stating you are a tenant of the property, signed within the past 12 months; or
 - a current (within the past 3 months) electricity/gas or landline phone bill sent to you at the above address.
- 2. If you don't own the vehicle**, please provide a letter from the owner authorising you to use the vehicle. You must provide a valid reason why you are going to be the primary driver of the car.
- 3.** A Coupon Parking Exemption Permit does not allow you to exceed any time restrictions when parking in a time-restricted space in a coupon parking area.
- 4.** If you purchase a new car or move to another suburb that has coupon parking, you may transfer the permit to the new car/suburb but the old permit must be scraped off the vehicle and brought back to our office. The permit may come off in pieces, but it is important that we view all or parts of the old permit so we know that it will not be in use. Only the original applicant can transfer their permit.
- 5.** The fee is \$122.50 per year. Permits are **NON-REFUNDABLE**.
- 6.** All motor vehicles must have a current warrant of fitness and registration. A Coupon Parking Exemption Permit does not exempt you from that responsibility.
- 7.** The vehicle must be registered to the same address as on this application form. If it is not, please update your details with NZTA online at nzta.govt.nz or phone 0800 108 809.
- 8.** Permit approval is not guaranteed. For more information, phone our Contact Centre any time on 04 499 4444.
- 9.** Parking availability is not guaranteed and can be affected by roadworks or construction.
- 10.** If you do not comply with the parking provisions of the Traffic and Parking Bylaw 2021, your permit will be cancelled. The permit must be displayed on the front windscreen of the vehicle for which it was issued.
- 11.** The permit must be removed if you move from the area or dispose of the vehicle. It must also be removed when it expires. It is your responsibility to renew your permit annually.
- 12. It is important that we receive all supporting documentation with your application (new, renewals and transfers) in order for us to process it.**
