	<ul> <li>Commercial (licenced) parcels will be double wrapped/bagged with no less than 200 μm polythene wrap/bag. Parcel size will not exceed 2500mm x 2000mm x 0.500mm in size and not exceed 1000kg (1 tonne).</li> </ul>				
<ul> <li>All asbestos containing material (ACM) needs to be secured and presented in such a manner that it can be manually and or mechanically unloaded off the transporting vehicle and placed into the required area. Tipping of loads is not permitted.</li> </ul>					
<ul> <li>Transporter will be required to assist with the unloading of ACM at the disposal area. Appropriate PPE must be worn by this person(s). Please visit: worksafe.govt.nz/topic-and-industry/asbestos/ppe-when-working-with-asbestos/ for further advice.</li> </ul>
