Thank you for your request made under the Local Government Official Information and Meetings Act 1987 (the Act), received on 4 February 2023. You requested the following information:

- 1. All correspondence between the developer or any of his representatives or any group or individual that led to Mr Liam Hodgetts attendance at the event.
- 2. Any correspondence between the parties mentioned and Mr Hodgetts for other nonplanning department activities or relating to any other social meetings that have happened or are planned.
- 3. Any correspondence in the Wellington City Council's (the Council's) email system between Kurt Gibbons and Liam Hodgetts relating to any social engagements or meetings held at any location that is not a council building or active development site.

Request one:

Mr Hodgetts, Chief Planning Officer, as with any executive role, holds a range of responsibilities. The sod-turning ceremony at Shelly Bay was a symbolic acknowledgement of the start of a project of significance to Taranaki Whanui Limited and Port Nicholson Block Settlement Trust (PNBST), which the Council approved in 2020. Given the importance of the relationship with Mana Whenua, as reflected in Tākai Here (see here), the binding agreement between Mana Whenua and Wellington City Council. At the request of the Chair of PNBST and as a representative of the Council, it was appropriate on this occasion that Mr Hodgetts took part in this ceremony, on behalf of Barbara McKerrow, Chief Executive Officer, as Ms McKerrow could not attend.

The only correspondence between the developers or any of representatives of any group or individual that led to Mr Hodgetts attendance at the event is the invitation from The Wellington Company sent to Ms McKerrow which was forwarded to Mr Hodgetts to attend on her behalf.

Please see appendix one which is communication between Council that led to Mr Hodgetts to attend the event. Some information has been withheld under section 7(2)(a) of the Act to protect the privacy of individuals.

Request two and three:

Your second and third request has been refused under section 17(e) of the Act that the document alleged to contain the information requested does not exist. There is no correspondence between Mr Hodgetts and the developers (either The Wellington Company and GibbonCo) regarding social meetings/engagements that have happened or planned that were held at any Council location or active development site.


Right of review
