#### Shelly Bay water main

Thank you for your request made under the Local Government Official Information and Meetings Act 1987 (the Act), received on 23 June 2023. You requested the following information:

Can I get all correspondence between WCC, Wellington Water, and Shelly Bay developers and contractors about the broken water main to Shelly Bay (about 2 months ago I'm told) including any efforts to repair it? Can I also get any correspondence about this issue you have - before and after the fire - with Fire and Emergency NZ?

I can advise that the old water main at Shelly Bay was initially damaged by Civil Contractors undertaking ground remediation works at Shelly Bay in early March. The Council was first notified of the damage when CityCare Water discovered the damage during a nearby routine inspection of infrastructure on 9 March.

Investigations by CityCare were undertaken to determine the extent of damages to the main with the intention to repair the main. However, CityCare recommended that it was not considered feasible or necessary to repair the water main due to the age and condition of the asbestos cement pipe that did not service any habitable buildings and was due to be decommissioned and replaced shortly as a part of the works required for the Shelly Bay Development.

Services for the Shed 8 building had been disconnected pending the building's deconstruction. CityCare undertook site investigations to determine the extent of damage to the main with the intention to repair the main. However, due to the age and condition of the asbestos cement pipe that was due to be shortly decommissioned and replaced by the Developer, it was not considered feasible to repair the water main.

As previously advised, Wellington City Council has granted your request for information.

Under section 7(2)(a) of the Local Government Official Information and Meetings Act 1987, some information has been redacted to protect the privacy of natural persons.

Items 5 and 10a provide a breakdown of costings from City Care LTD, this information is commercially sensitive and therefore has been withheld under sections 7(2)(b)(ii) of the Act, however, the final totals have been provided.

#### Right of review

If you are not satisfied with the Council's response, you may request the Office of the Ombudsman to investigate the Council's decision. Further information is available on the Ombudsman website, www.ombudsman.parliament.nz.

Kia ora all,

Happy to assist with facilitating this; the best approach under our agreement with the Developer is to have a meeting with them to discuss performance, processes and expectations moving forward now that there is a greater level of work happening on-site, potentially exposing the public to more risk.

There are a number of obligations under the agreement regarding health and safety that need to be addressed or we need to be more visible to measure their performance under the agreement (see below).

## Health and Safety

#### Compliance with Health & Safety Laws

- 15.1 The parties must:
  - (a) comply, and ensure that its Personnel comply, with all Health & Safety Laws; and
  - (b) not, and must ensure that its Personnel do not, cause WCC and/or the Developer to be in contravention of any Health & Safety Laws.

#### Performance of this Agreement

- 15.2 Without limiting the Developer's obligations under this Agreement or otherwise at Law, the Developer acknowledges and agrees that it is responsible for:
  - controlling and supervising all aspects of the delivery of the ISPA Works (excluding any ISPA Works carried out by WCC in accordance with the terms of this Agreement) and ensuring that such work is only undertaken in accordance with the terms of this Agreement and all Health & Safety Laws;
  - ensuring that each person employed or engaged in the delivery of the ISPA Works, including its Personnel, is aware of and fully complies with all Health & Safety Laws;
  - providing periodic updates to WCC regarding work health and safety performance as reasonably requested by WCC;
  - (d) promptly advising WCC of any hazard or incident with respect to the performance of the ISPA Works which results, or may result, in injury or death to any person; and
  - (e) nominating a suitably qualified person to act as the representative of the Developer with respect to any safety, health or welfare matters arising out of this Agreement.

I think the above will be a good basis for discussion; Jonny (or Leigh), I'll find a time to book in that meeting with the Developer.

1. I have advised Kilbirnie Fire Station that there is no water available along the Shelly Bay Road, that the fire hydrants are impaired due to the damaged water supply pipe.

- 2. In an emergency the area will now revert to a Rural Fire Service.
- 3. The closet fire hydrants are on the ridge line between Main Road and Nevay Road.
- 4. The fire service will go to site today and inspect the fire hydrant services available to them.

Please advised if there are any other concerns.

Katrina was going to advise WCC Insurance. The Shed 8 building is not covered but it is still pertinent that insurance are advised so they can determine the impact, if any.

Thanks for your email, the assumptions below are correct. CityCare Water investigate the pipe broken by the Civil Contractor on site and noted that it was actually leaking in numerous places elsewhere, with the cost associated to fix quite significant and anticipated that due to the shallow nature of the pipes and the use of the heavy vehicals would result in continuous breaks and leaks throughout the Civil works.

The water infrastructure at Shelly Bay is privately owned, and to date has been serviced by WCC contractors (not WWL) to ensure that there is water for Fire and Emergency services on site; however, since the broken pipe we have switched to a rural service and CFC have water coming from elsewhere, so the decision was made to cap the water.

In light of the significant fire event occurring at Shed 8 early this morning, WCC (as landowner and building owner) requires temporary control over the area for health and safety purposes in order to carry out any works immediately required in the aftermath of the fire event. Please see attached letter.

Accordingly, WCC requires the immediate and temporary revocation of the Developer's rights to access and occupy the Shed 8 site and immediately adjoining areas under the Access Agreement until further notice. As such, on and from the date of this email, the Access Agreement (including the parties' respective rights and obligations under the Access Agreement) is temporarily revoked in all respects to the extent it relates to the Shed 8 site until further notice.

This temporary revocation will continue until otherwise agreed by the parties in writing (acting reasonably). Re: Temporary revocation of Access Agreement in respect of Shed 8 site at Shelly Bay Taikuru

We refer to the Access Agreement between Wellington City Council (WCC) and Shelly Bay Taikuru Limited (the **Developer**) dated 7 March 2022 pursuant to which the Developer is granted various rights to occupy and use WCC's land at Shelly Bay. In light of the significant fire event occurring at Shed 8 early this morning, WCC (as landowner and building owner) requires temporary control over the area for health and safety purposes in order to carry out any works immediately required in the aftermath of the fire event.

Accordingly, WCC requires the immediate and temporary revocation of the Developer's rights to access and occupy the Shed 8 site and immediately adjoining areas under the Access Agreement until further notice. As such, on and from the date of this email, the Access Agreement (including the parties' respective rights and obligations under the Access Agreement) is temporarily revoked in all respects to the extent it relates to the Shed 8 site until further notice.

This temporary revocation will continue until otherwise agreed by the parties in writing (acting reasonably). To the extent legally permitted and once WCC has resumed control of the site and having regard to WCC's health and safety obligations, WCC will not unreasonably withhold its consent to any access required by the Developer to retrieve or secure any equipment currently located on the site (subject at all times to WCC's health and safety requirements).

Except as expressly provided for above, the Access Agreement will remain in full force and effect in relation to the other access areas referred to therein.

WCC will keep the Developer updated in relation to the emergency service activities on site as well as any of WCC's proposed actions in relation to the remains of Shed 8 and/or the making safe of the site. We are aware the temporary revocation may cause disruption to the Developer's activities on the site and appreciate the Developer's understanding and cooperation while both parties work through this unexpected event.


