*The reduced figure for the 2024 year reflects the administration function being removed from the contracted service. This function is now undertaken by Wellington City Council.

The shelter at Moa Point is owned by Wellington City Council and fees for the lease are paid to Wellington City Council by Hutt City Council under a separate agreement. The shelter fees paid for the previous five years have been \$32,500 per annum.
