ORAL HEARINGS FOR ALCOHOL CONTROL BYLAW REVIEW

Purpose

1. This report provides the City Strategy Committee with a schedule of individuals and organisations that are making an oral submission in support of their written submission on the Alcohol Control Bylaw, and a copy of the written submissions received.

Summary

2. Public consultation on the Alcohol Control Bylaw review took place from 31 August to 30 September 2018 and a total of 42 submissions were received.
3. Pre-engagement with a number of community groups and residents' associations took place between April and September 2018.

Recommendation/s

That the City Strategy Committee:

1. Receives the written submissions, hears the oral submissions and thanks all submitters.

Background

4. The Council is required to review its existing Liquor Control Bylaw (the Bylaw) by December 2018, at which point it would otherwise expire.
5. The Bylaw is made under the Local Government Act 2002, and allows the Council to set controls on the possession and consumption of alcohol in public places within the areas defined by the Bylaw.
6. The proposed changes contained within the draft Alcohol Control Bylaw include:
 - An adjustment to the boundary (namely to extend the boundary up Marjoribanks Street, along both sides of Brougham Street to Ellice Street);
 - The removal of the CentrePort area on the east side of Waterloo Quay; and
 - Updates to reflect other recent legislative changes and drafting improvements.

Discussion

7. The City Strategy Committee will today hear from individuals and organisations that have made a written submission and wish to speak to their written submission.
8. The schedule of submitters is included as **Attachment 1**.
9. The written submissions from each individual and organisation that will be making an oral submission are included as **Attachment 2**. The complete set of written submissions will be made available under separate cover.

Alcohol Control Bylaw Review:

This submission is made on behalf of Inner City Wellington (ICW) the community group for residents, property owners, and organisations and businesses in Te Aro and Wellington Central.

- ICW supports the continuation of the current bylaw and the proposal to:
 - **maintain the existing area**
 - **with an expansion into Mount Victoria**, based on the evidence of alcohol related harm and disorder in the area

While there is still evidence of alcohol being consumed in public areas covered by the bylaw (eg, bottles, cans, etc lying around), we believe there has been a reduction in alcohol consumption in public places (and associated alcohol-related harm) and that the frequency of drinking in public and associated harm would increase if there was no ban. Our understanding is that enforcement of the alcohol ban is a lower priority for Police. Nevertheless, retaining the alcohol ban provides an essential tool for the Police to prevent escalation of alcohol-related harm. In the absence of the bylaw there would be a return to the frequent and excessive drinking in public places and limited ability for the Police to take action in circumstances of bad/extreme anti-social behaviour as it may not meet the threshold for apprehension under other legislation.

- ICW supports **the removal of the area around Centre Port which is not open to the public** from the current bylaw area.

Additional areas to include in the area of the liquor ban

- **ICW supports the call by Vic Neighbours to include Kelburn Park in the alcohol ban area from dusk to dawn.** The submission provided by the group clearly shows there is a high level of disorder caused by excessive drinking in this public place.

The data provided by Vic Neighbours show there are substantively more instances of people drinking in public over a five year period than recorded by Local Hosts for the proposed extension in Mt Victoria. There may have been a similar number of arrests if Police were resourced to respond to reported incidents.

A partial alcohol ban would help reduce the continued alcohol-fuelled disorderly behaviour in the neighbourhood, while enabling families, sports groups and others to enjoy a drink and picnic in the park during the day. A targeted area is consistent with the application of

the current control areas at the top of Mt Victoria and along Aro St to the Holloway Rd area.

ICW understands and relates to the impact of extreme and regular disorderly behaviour fuelled by excessive alcohol consumption on the wellness of non-student residents in that community.

- **ICW supports the extension into Mt Victoria, but does not accept WCC's view that Vic Neighbours does not have an equally strong case** on the evidence provided in the group's submission. The problems identified by Vic Neighbours are not associated with homelessness as WCC suggests is the issue in Kilbirnie, and the reason for not including it.

Other comments:

Selective engagement and lack of information in consultation document

ICW is concerned to read in Vic Neighbours submission that the group was not contacted during the 'engagement' period prior to WCC developing the draft bylaw, when Victoria University was contacted during that period. There is clearly evidence of sustained engagement by these residents with Victoria University and with WCC on this matter. This is selective engagement by WCC. Victoria University was able to influence the approach to the draft bylaw, but the group known to be raising concerns was not. Now the residents can only submit on a draft proposal, where it is much tougher to change the WCC position.

The consultation document should have included a summary of the rationale for excluding Kilbirnie and Kelburn from the proposed alcohol control areas as these were two options considered. Many people will be unaware that these areas were considered for inclusion.

Need for active enforcement to reinforce the message

WCC must continue to advocate to Police for active enforcement of the alcohol ban to reinforce the message that while not every incident gets responded to, the ban will be regularly and robustly enforced.

There needs to be effective responses by WCC's noise control officers (ie, turn up promptly to the right address) and local hosts to excessive alcohol-fuelled anti-social behaviour that is unreasonably impacting on the amenity of others in the community, calling in the Police where needed. Members of a community should not suffer depression and anxiety due to the excessive socialising actions of others in the community.

Need for increased rubbish removal to avoid empty bottles and cans being used in antisocial behaviour

WCC needs to ensure that the cleaning teams are increased or prioritised to remove the rubbish that occurs. This is particularly an issue in summer and the rubbish bins in places like the corner of Herd St (by the carpark/steps to the boardwalk around the marina) are often over-flowing as they are not big enough to cope. It's great that some people are putting their empty bottles by the bin (though better if they took them home), but it would be better if the rubbish was not left to pile up or be thrown on the ground and broken.

Submission on Alcohol Control Bylaw

The Mount Victoria Residents' Association Inc (MVRA) appreciates the opportunity to comment on the Wellington City Council's Alcohol Control Bylaw. We have previously met with Jim Lewis in relation to the review of the Liquor control bylaw (the liquor ban), and we are heartened to see our comments and feedback have informed the proposed changes to the bylaw. Overall, we are pleased to see the Council is paying attention to the changing drinking patterns in the inner city, and are seeking to establish guidelines to keep all residents safe and well on the streets.

Response to current proposal

1. We support the changes to the boundary to extend the alcohol ban boundary up Majoribanks Street, along both sides of Brougham Street to Ellice Street.
2. Overall, we support a harm minimisation approach to public alcohol consumption in the city, and support an approach which de-normalises alcohol consumption as part of 'everyday activities', especially in spaces where families and children are present, such as Cuba Mall.
3. We note the Kids Cam research¹ has shown that children are exposed to alcohol marketing on nearly every visit to a supermarket. *"The findings are a real concern given exposure to alcohol marketing increases children's alcohol consumption and alcohol-related harm. In particular, research has shown exposure to alcohol marketing within supermarkets increases children's consumption, including starting to drink at earlier ages,"* said Tim Chambers, researcher. This exposure is exacerbated by the consumption of alcohol on our streets. We support efforts to minimise harm of alcohol particularly on children.
4. We would be interested in the Council considering the addition of Roxburgh Street within the Alcohol ban area, as this has been a place where pre-loading occurs.
5. You have asked us "What other actions could the council take to address public safety and alcohol

related incidents that you are concerned about in your local community or other areas in Wellington?”

- MVRA supports the development and hosting of family-friendly, alcohol free events in the city and its surrounding suburbs. Such events create a narrative that removes alcohol from the centre of social activities, and provide models for younger residents in particular.
- MVRA would like the Council to re-consider its support of alcohol-heavy events in the inner city, such as the Jim Beam sponsored Homegrown. These events glamorise and popularise alcohol consumption, promoting negative models of behaviour to their (predominantly young) attendees. We would support much stricter monitoring of alcohol sales and consumption at these events, including ensuring that inebriated attendees were not allowed to leave (unless heading for home in a taxi!), and fines for the organisers if inebriated attendees cause problems outside the event.

We would like to be heard in support of our submission on October 18^h.

Section 1

Summary

Regional Public Health (RPH) appreciates the opportunity to submit on the proposed Alcohol Control Bylaw.

RPH supports the Council's position to renew the bylaw and commend the Council on this proactive approach to reducing alcohol-related harm in the city. This bylaw forms an important part of the alcohol management strategy for Wellington City. Our comments on the proposed areas are detailed in 'Section 3'.

RPH understands that information gathered earlier has informed this proposal. That information will be complimented further by additional or new information from public consultation and that may alter the proposal.

RPH recommends you take particular note of any locations that community cite as of concern, particularly those not covered in the proposed bylaw. Community have direct information on alcohol consumption in public places and play a vital part in insuring the final policy is responsive to the local context and is an appropriate balanced response.

Alcohol bans are generally well supported by residents and businesses. However the details are often not well known especially by visitors. The council should ensure the bylaw is successfully communicated to the public so the details are well understood.

RPH recommends highly visible and simple signage be used to inform the public of the locations covered by the alcohol ban. This should be part of a wider communication and enforcement plan that supports its implementation.

Section 2

Support for Alcohol Control Bylaws

Public place drinking is one of a number of negative influences contributing to alcohol related harm. Public place settings are a common location for low level alcohol related offending, increase the opportunity for more serious alcohol-related violence¹ and increase the opportunities for drunk driving and underage drinking².

Alcohol Control Bylaws are a widely used and well-established tool internationally and in New Zealand. Despite the more stringent criteria under section 147A and 147B of the *Local Government Act 2002* these bylaws continue to be popular strategies to reduce harm. They are known to improve perceptions of public safety and can contribute to the reduction of harm by providing police with a

tool for dealing with antisocial behaviour caused by drinking in public³. They can also contribute to changing people's perception of social norms with alcohol being less visible in public and can help limit consumption to more controlled or supervised environments.

The literature reports some limitations. Displacement can be a problem^{4 5} and disadvantaged and marginalised groups are more likely to consume alcohol in public, either by choice or because of limited alternatives.^{6 7}

Alcohol bylaws are most successful when part of a wider strategy.^{8 9} These should include other regulations for supply control for example elements in a Local Alcohol Policy, as well as community based harm reduction initiatives, social and cultural programmes and access to health services.

Alcohol bylaws are most successful when the underlying causes are understood, that context addressed and the community are engaged in the solutions.

Support for an Alcohol Control Bylaw in Wellington City

Alcohol harm in Wellington City from consumption in a public place is a particular subset of harm that is influenced by low cost alcohol and heavy consumption. It is most often associated with binge drinking, the behaviours of preloading and side-loading and chronic heavy consumption.

In Wellington City the areas at risk of harm from public place drinking can be characterised by several markers including; lower socioeconomic status, a substantial young adult population and higher levels of health harm, particularly acute health harms associated with intoxication and chronic heavy consumption such as alcoholic liver disease.

RPH has used this combination of information to inform our responses to the questions asked in the consultation.

The importance of public consultation

Given the unequal impact that heavy drinking has on different areas within the Wellington community it is important to assess this policy carefully. Robust input from community alongside information from other sources is vital to understanding the local context. Expediency should not be put above consultation and if there are further matters to be explored with community these opportunities should be given the time to be further investigated.

Ensuring effectiveness and meeting legislative requirements

Evaluation of an implemented policy is important to assess its impact both positive and negative. Prior to the next review it may be beneficial for *Wellington City Council* to again collaborate with other agencies involved in alcohol harm reduction and complete an evaluative impact assessment. This would provide policy makers with a high level of evidence supporting the requirements under the *Local Government Act*, support a sustainable approach to the wellbeing of communities and a participatory and consultative approach to policy-making.

Community knowledge of alcohol free zones

Having variable restrictions across Wellington City can cause confusion. Such concerns were raised in the *Law Commission report Alcohol in Public Places*.¹⁰ It is important there is on-going clear communication about the specific locations covered in the alcohol ban throughout the life of the bylaw.

Section 3**Questions**

1. Do you agree to the changes to the boundary to extend the boundary up Majoribanks Street, along both sides of Brougham Street to Ellice Street?

Comments

The proximity of the area to Courtney Place may predispose the area to an increased risk of alcohol related harm. Displacement is raised in the literature as a limitation and could easily occur here. Extension so close to the entertainment area is warranted.

Mt Victoria West also has a significant proportion of young adult residents and our health data demonstrates that intoxication presentations are high, although not quite as high as those areas included in the current bylaw.

2. Do you agree with the proposed removal of the Centre Port area on the East side of Waterloo Quay?

RPH does not hold the appropriate information to either support or reject this proposal. If the area is no-longer covered by the bylaw we recommend an appropriate level of surveillance be maintained to ensure there is no negative impact and the area be reinstated if required.

3. Apart from the Centre Port area, are there any other areas in the existing Liquor Control Area that you think should be removed? Which areas and why?

Comments

Using the aforementioned risk markers we have identified a number of area units which need further investigation and may need inclusion in the bylaw. These areas are Kilbirnie East, Berhampore West and Strathmore Park. These areas are characterised by lower socioeconomic status and high levels of alcohol related harm from both intoxication and long term heavy consumption. Kilbirnie West - Hataitai South also demonstrates similar health harms but has a higher socioeconomic status. It should be remembered the assessment is not a direct measure of alcohol-related public place concerns.

RPH recommend the Council consults directly with these communities to ensure important information has not been omitted due to the community not being aware of the public consultation.

RPH is aware that Kelburn residents approached the Wellington City Council in 2015 looking to extend the liquor ban. Kelburn Park particularly has attracted many community complaints specifically arising from public consumption of alcohol on the site. The location's close proximity to the university, to student accommodation and easy pedestrian access to the CBD makes this location vulnerable. This is an area where displacement or marginalisation is an issue. Students unable or unwilling to drink in hostels gather elsewhere and cause significant disruption.

RPH recommend that the Council consults directly with this community.

5. What other actions could the council take to address public safety and alcohol related incidents that you are concerned about in your local community or other areas in Wellington?

Comments

Local Alcohol Policy:

RPH encourages the Council to continue with its Local Alcohol Policy development. This is an important part of an Alcohol Management Strategy with the three prongs of successful alcohol harm reduction covering supply control, demand reduction and problem limitation. We anticipate the

council will continue to engage with key harm reduction agencies *RPH* and *NZ Police* to support the Alcohol Management Strategy.

Take 10:

RPH encourages the Council to continue to take responsibility for the operation of Take 10. The pilot was a very successful venture and warrants continued implementation. Ideally both Friday and Saturday evenings should be included. Contribution to funding should be explored with the alcohol industry.

6. Are there any other comments you wish to make on any part of the bylaw?

Yes.

Comments

The area units characterised by lower socioeconomic status, a substantial young adult population and higher levels of health harm, particularly acute health harms associated with intoxication coincide with Lambton, Mt Cook - Wallace, Aro Street - Nairn Street, Newtown East and Newtown West area units and to a slightly lesser extent Willis Street - Cambridge Terrace. Being close to *Massey* and *Victoria* universities these areas likely have higher tertiary student populations. Public places and pedestrian pathways that link hostel or rental accommodation to the CBD are public places that demonstrate higher risk. Newtown East and Mt Cook Wallace area units also present with higher levels of disease characterised by chronic heavy consumption which may be suggestive of problem drinking in public by heavy chronic drinkers.

***RPH* supports** the continuation of an alcohol ban in all these areas.

Submission on Alcohol Control Bylaw

The Kilbirnie Business Network welcomes the opportunity to make a submission on the Wellington City Council Alcohol Control Bylaw.

The Kilbirnie suburb includes two supermarkets, an elderly retirement village, a community centre, three colleges, one intermediate school, three primary schools, an indoor sports centre used by children; a swimming pool used by children, a number of early childhood day care centres, a number of churches and other social support agencies.

Our submission is that:

- We support the changes to the boundary to extend the boundary up Majoribanks Street, along both sides of Brougham Street to Ellice Street
- We support the proposed removal of the CentrePort area from the Liquor Ban area
- We request that the Kilbirnie shopping precinct (Business Improvement BID area) be included in the alcohol ban area.
- Our reasons for requesting that the liquor ban be extended into the Kilbirnie Shopping area are as follows:
 - The Kilbirnie Business Network argued strongly for the Kilbirnie shopping area to be included at the last time this was reviewed in 2015 and many of the reasons we argued then are the same today.
 - The issue of alcohol-influenced anti-social behaviour has continued to get worse along Bay Rd and has been identified as the number one concern by both retailers and visitors to Kilbirnie, with many people reporting to us that they have received threats and intimidatory behaviour from people clearly under the influence of alcohol (evidenced by the bottles and cans alongside them)
 - The Council erred in 2015 by not including Kilbirnie at that time as an individual suburb, instead viewing the area as one area.
 - 273 members of the public signed an online petition with the Wellington City Council to have the alcohol ban extended into Kilbirnie to tackle the problem of alcohol consumption in the centre of Kilbirnie and its associated offending.
 - There have been a number of recorded complaints by people to Council over the past 5 years. A spate of broken windows along Bay Rd earlier this year was attributed to alcohol, evidenced by the beer bottles that were left behind.

- In 2015 the Police appeared before a hearing of the Wellington District Licensing Committee, and attached to this submission is data provided by Police for the 12 month period from September 2014 – September 2015, when there were some 282 emergency calls for Police assistance to attend incidents that are commonly known to feature alcohol. We have no reason to believe this number will have dropped, if anything it has most likely increased. 34
- Local residents have reported incidents of drunks causing trouble around Kilbirnie. Anti-social behaviour including aggression and abuse towards members of the public and begging has caused a number of concerned residents to seek solutions from the Police and Council.
- Local businesses continue to report serious concerns with the harm being inflicted on staff and customers as evidenced in the email attachments below.
- We believe that a liquor ban will see this type of behaviour drop significantly. Other behaviour reported are drunks urinating in the street, sniffing glue, hassling shopkeepers and demanding money from people at cash machines.
- In Auckland there is almost a total 24/7 Liquor Ban in all shopping centres and we believe this should also be the case in Wellington. There is no need for members of the public to be drinking on the streets and in public shopping areas.

- 1.00 Group of middle aged men drinking and smoking outside Countdown.
- 2.00 Customer in Flight Centre getting abusive.
- 2.30 5 people drinking and getting very drunk, aggressive and swearing. People scared to walk past.

- 4.00 Drunk guy hanging around in Plaza.

Liquor Ban Proposal for Kilbirnie

To Whom it may concern,

Over the last 12 months there has been a considerable increase in unwelcome behaviour on Bay Road, Kilbirnie. The following incidents all relate to certain members of the public being intoxicated through Alcohol or other substances:

- A Sister (Nun) was exiting the BNZ in Kilbirnie one evening and a member of the public clearly drunk with his top off sat by Warehouse Stationary stumbled across the road, then approached the Sister. Making rude and then racist comments towards her in front of several school children passing by, before attempting to hit her with an empty wine bottle in his hand. Several members of the public came to her end and I had to drop what I was doing to open the doors as we were closed to get her safe inside. The Police were called and took almost 45 minutes to arrive where this person continued to make threatening behaviour before passing out on the bench where he had come from.
- A member of the public who was so intoxicated or on a substance hard to tell, passed out beside the BNZ ATM, and I had to call an Ambulance as he was non-responsive. This was an awful look especially with so many young families frequenting Kilbirnie. An ambulance arrived after 30 minutes and the member of the public had by then come around and stumbled across the road.
- A member of the public clearly worse for wear after drinking once more by Warehouse stationary stumbled against a parked car, beside ASB bank. He then urinated on the car in front of the public and once more young families exposed to this awful behaviour.
- A member of the public made threatening behaviour to one of my staff after attempting to kick in the ANZ door, hard to know if the effects of alcohol were in play? Not a great look need to commend the Police for arriving on site and dealing with brilliantly.
- Members of the public congregate across at Warehouse stationary drinking out of glass bottle sometimes as early as 7.45 am, loud and drunk already. I cannot tell you how bad this looks to school children throughout the day.

Finally, I want to note that Kilbirnie is a family suburb with a lovely elderly generation that frequent Bay Road from Rita Angus retirement home. Should are streets not be welcoming especially for the generation that have paved the way forward for us, and don't we also owe something to our future generation the children to equally feel safe when visiting the local shops.

Thanks for inviting me to the business network meeting.

Just following on from the conversation – I'm not sure what the Business Network is doing or able to do about the amount of people in the Kilbirnie main shopping street that are either homeless or just itinerant but it is a real problem.

There are a large amount of people who are hanging around on the street from early in the morning to late at night and it is putting people off coming to the Kilbirnie area.

They are spending their time sleeping on the street in sleeping bags, openly drinking, smoking and congregating and being fairly intimidating to people that walk past. We are situated right at the centre of the shopping precinct and there is a nice seating area and some shelter right next to us. Which should be able to be utilised by members of the public who come into Kilbirnie to shop. However for example today – we have had about 5 itinerant people drinking smoking, harassing people for money and cigarettes and being extremely loud, swearing which we can hear inside our shop. It's 1.15 in the afternoon now and I have been at work since 8.00 am this morning and the above has gone on so far for all of this time.

Kilbirnie seems to be the worst suburb for this! I don't see the same issue in Miramar where I used to work or in Karori where I live.

I am often in early at work and finish late and it is pretty intimidating to have drunk men hanging around the office where I work, - it makes me feel unsafe!

Surely something can be done about this as it seems to be getting worse by the day.

4. Do you think that we should include any other areas in the alcohol ban area. Which areas and why.

I think Kelburn and Kilbirnie should be included.

Kelburn:

I think it is appalling that Vic university does not want a liquor ban in Kelburn and I feel awful for the local residents. There has been many reported incidents of bad, appalling, and criminal behavior by too many varsity students getting drunk too often and causing sad situations locally and in the CBD.

Do we want Vic university to have a similar reputation to the drunken goings on of Otago?

The varsity executive have finally exercised responsibility and clamped down on some of the appalling behavior caused by too much booze in their Halls of Residences and it is about time, but they haven't gone far enough in supporting the local residents, the CBD, us ratepayers, and also their students in supporting a liquor ban.

My children and I completed study at Vic, and there is some history of drunken events in the past, but in recent years, after the foolish liberalization of the booze laws in the 1989 Sale of Liquor Act the events have got out of hand.

Vic enrolls large numbers of young people from all around NZ, and want to present well for international overseas students to come here, yet we permit a senseless continuation of the booze culture?

There is clear evidence of crime, including sexual harassment, assaults, property damage simple due to the excesses of booze either purchased in large volume from the adjoining close by Supermarkets of Countdown and New World, let alone the giant cheap grog and RTD pushing Off Licenses in the area.

We need issues of too much encouragement by pubs to drink to excess, even though they have "Host Responsibilities" in terms of their license.

The police, MOH and community spirited ratepayers have presented much evidence to the District Licensing Committee in recent years when a number of these grog pushing rich chain stores have been challenged over their booze licenses. The DLC has made a number of decisions to restrict trading hours, and give warnings and that will and must continue.

Lets hear from the Licensing Inspector and the MOH, as to the volume of booze sales in the local area. I estimate that \$15 million of booze each year is being sold in this small area, and the greater amount would be to young people under the age of 25.

Then there is the terrible link of the large Off License sales creating problems of pre loading and side loading, so that these young people who are to be the future of our country, sweeping drunk down in the CBD Fri, Sat and Sunday and causing problems or usually being targets for others. now Vic is thinking of busing the students down? Busing them home is ok. But Christchurch tried busing young people in and out of the city for safety purposes but gave up on the matter. Some universities 'bond' there students for ensure good behavior and I hope Vic does as well.

When Countdown Cable Car Lane built their new booze shop they applied for a booze license. They wanted to open 7 days a week selling booze to 11pm.

I wanted to lodge an objection but did not have 'standing' as live more than 1000 meters away. This is a radius that is drawn up by the Licensing Inspector in terms of policy and case law. It's absolutely foolish of course but won't argue that herein.

But I attended the first day of the public hearing to listen and sat at the back. A Dompost reporter sat next to me and said,
" Bernard, what do you think of this case?"

Well I said: "if Countdown gets a booze license to 11pm it will be *chunder up and chunder down the Cable Car.*"

So the that day an article was written with that headline. Clearly the Commissioner (the Hon Sir Douglas Kidd) of the DLC read the Dompost as at next day's hearing he referred to the issue as Countdown could be providing a "*Conveyer belt of Alcohol - supplying university students.*"

The reporter wrote as if I have made that a "submission" at the hearing, but I had not, as I had no part in the hearing. But I think that quote certainly was influential in the outcome of the case. Countdown were sensitive to public pressure, and newspaper articles, hence put forward the position that that would only seek the license to 8pm trading of booze. That was agreed to by the DLC.

In a following period in the application for renewal of Countdown's Cable Car Lane booze license only one public objection was made, but they were ruled not to have standing. The Licensing Inspector and the reporting agencies did not oppose the renewal even tho Countdown wanted increased hours. So the license could have been dealt with "on the papers alone" but in a interesting direction the DLC (Hon Sir D. Kidd) ruled that he wanted a report to hear from the Chancellor of Victoria University as to the widely reported massive problems of booze incidents in the student body. Most embarrassing for the university!

After getting a report, the DLC decided to renew the license, but retain the close of trading hours of booze at 8pm. Great I say, and I want ALL Wellington Supermarkets to cease selling booze at 8pm.

I recently attended a meeting with senior members of the Inner City Residents Association. We were providing our perspective to a Otago Research Fellow wanting to know our experiences of all things pertaining to booze in our city under the new Act. The discussion certainly included the terrible issues associated with too much grog being available to university students and the grave concern of Kelburn residents.

In conclusion I would recommend a Liquor Ban be established in Kelburn, not to do so would fail the stewardship of our young people.

KILBIRNIE

The need to have a Liquor Ban in Kilbirnie.

I have lived in the Southern and Eastern Wards for 50 years. Taught in the schools. Lived in Coutts, Yule and other streets close to Bay Road Shopping Centre. I started the Kilbirnie Branch of the NZ Labour party. My two daughters attended Lyall Bay primary school, and Evans Bay Intermediate. I have been a Netball referee at the outside courts. I have been a life guard and swim instructor at the Aquatic Centre. I helped out at the Kilbirnie/Lyall Bay Community Centre as elected chair for 6 months in 2016 to maintain operations before we could have someone take on the task to provide continuity. So I think I know the area and its people, and its problems pretty well.

I opposed the booze License renewal of Pak & Save Kilbirnie (twice) and also Countdown Kilbirnie (once). Even tho I lived at that time in Newtown and outside of a 1000mtr radius as drawn by the licensing inspector in the first public hearing against Pak & Crave in 2015 I was granted "standing" by the DLC Commissior Rex Woodhouse.

I think Council should be provided with the decisions in the two cases concerning Pak & Save and also Countdown by the licensing inspector. There is highly relevant data in those decisions that show the massive amount of booze sold, when it is sold and the relative increase in crime and disorder with a 500 meter radius of these supermarkets. Ref 49B/16/1.

Pak & Save Kilbirnie wanted to renew their booze licenses and have closing hours for liquor to be 11pm. I have always oppose supermarkets and want liquor to cease being sold at 9pm. The pressure was on Pak & Save in 2015 to reduce their hours to 9pm as also wanted by the Police & MOH. But Pak & Save's position was to say across the road Countdown has longer trading hours of booze. So in 2015 the DLC indicated that the would bring the renewal dates into line into the same period, hence Pak and Save got a shorter license time frame to be in the same period as Countdown. Remember that Pak & Save also had a 'sting' operation on them and they lost their trading of booze for 4 days as a penalty for selling to minors!

Then in the following year at the time of renewal both Countdown and Pak & Save were approved to sell booze to 10pm, but Pak & Save argued and got 10:10pm on the basis of customers needing to get 10 minutes to get to the cashier!

The bigger point is that in 2015 I estimated that Pak and Save sold \$10million dollars of booze a year in Kilbirnie, and Countdown sold \$4million. So I estimated that these two supermarkets were dumping \$14million dollars per year worth of booze on the local area.

Its any wonder there are problems in the home and in the streets! In the decision by the DLC the amount of booze sold is expressed as "the amount of beer pallets loaded onto a truck." This methodology was invented by Sgt Rapira-Davies. He was the best Community Constable Newtown/Kilbirnie every had, and also went on to be the best Police representative on Liquor Licensing the City has ever had so far but has now been transferred.

Remember prior to the 1989 Sale of Liquor act **NO SUPERMARKETS** sold grog.

So Kilbirnie, with its large placement of Social Housing, both WCC and Housing NZ have been in the area for decades yet the supermarkets brought the excessive booze to Kilbirnie.

The Police and Supermarket data in the Pak & Save case shows:

- a) a spike in booze sales between 8am - 9am being traders buying supplies
- b) a spike in booze sales between 3pm and 6 pm and
- c) a spike in booze sales after 9pm.

GUESS WHAT:

The police data shows a spike in alcohol related crime and disorder relative to the two later spike in sales.

Police data produced at the earlier hearing show that there were 282 calls for assistance in incidents involving alcohol within a 500 meter radius of Pak & Save! I think the Police and Licensing Inspector should up date this information for Council, as it is still at the same high level. The majority of offences were in Bay Road.

Alcohol ONLY purchases from supermarkets, compared with all sales -

Up to 6pm	18 per cent
Up to 9pm	62 per cent

ALCOHOL BUYERS WHO INTEND TO DRINK IT IMMEDIATELY:

Up to 9 pm	74 per cent

(So this is all about pre loading and boozing at home, isn't it!).

The call to have a Liquor Ban in Kilbirnie June 2015

On the 16 June 2015 a public meeting was convened in the Kilbirnie/Lyall Bay Community Centre as facilitated by Swampy Marsh. Other Councilors were in attendance. The Community Centre was packed with angry and concerned citizens.

Everyone spoke of the difficulties of bad behavior, public street drinking, disorder and threatening incidents when all what people wanted to do was shop without being harassed. I attach reports of that meeting. If another meeting was called today people would be twice as irate over the difficulties of Bay Road and close by areas.

I attach a copy of my part of my submission to the DLC in July 2017 against Countdown. This explains what the Community Centre experienced and how they had to react to protect clients. Jenny Rains the Director of Community Centres knows full well of the difficulties faced by this Centre and she should report to Council about that. The problems still exist today.

People in Kilbirnie got sick and tired of complaining to the Council and Police and the City Host people are seldom in the area.

The Social Deprivation Index

The Health authorities and State use a Social Deprivation Index. Wellington City is divided into 40 areas from Tawa to Seatoun & Island Bay.

KILBIRNIE is listed as number ONE out of forty. That is: the worst!

I hope the details of how that is measured is enlarged upon by Council Officers and understood by Councilors. So this is a measurement tool used to established across a number of factors how difficult your life can be.

Social Housing Complexes

Kilbirnie has large social housing complexes in Duncan Terrace and Kotutuhu Flats. They have been there for decades and many years before the two big Supermarkets brought the booze into the area to normalize alcohol as being a necessity food item. They are also close by state housing complexes as well.

Given the criteria that Council has for entry into social houses:

- old people over 65
- refugees
- multi disadvantaged persons
- ex prisoners/rehabilitation/mental health

understandably this poses certain issues.

I am a strong supported of Social Housing, in fact argued with Council not to reduce the number of bed sits and one bedrooms in its housing stock, which has happened in the Council up grade programme. In fact this has meant that single men and women have been pushed out of social housing. I have argued and still do for an increase in our social housing stock.

But this issue remains that a great number who become tenants need social service support. In reality internally us tenants use the phrase that "new tenants with high needs of support are not getting it as they are.....dumped and left alone."

I have worked in a voluntary capacity for 15 odd years to support tenants in social housing situations and one aspect that emerged in the last 5 years has been the network of 'drop in centres' that existed across the city. These were places of destination and did have opportunities for support staff to give needed help.

In the same period IHC closed their day bases. I worked in Newtown in a IHC home and also ran a IHC day base.

This meant that mental health and health users no longer had places to go for support, friendship and useful programmes, so they are now on the street, or washing into our public places of the libraries, streets or overloading the few small drop in centres around the city.

6: Other comments I wish to make are:

PUBLIC STREET LIQUOR BAN AREAS

1) Public Street Liquor Ban

Extend the public street Liquor Ban to ALL suburban shopping centers.

Have a 500 or 1000 meters radius ban from a given point.

This could mean that Kilbirnie would be linked to the wider ban area with Newtown.

But locations like Karori, Johnsonville, Island Bay, Miramar would be separate banned circles. Customers and people want to go to the local shops and Malls and not see or have to put up with people who have been drinking to excess, and then become disorderly.

2) have better enforcement of Liquor Ban areas.

City Hosts must play a more pro active role: eg authorize them to issue fines of \$500 or trespass orders. They must visit the suburban shopping centers more often. Employ more City Hosts.

We need to have a 'move on' order as in Australia, basically a 24 hour trespass order.

3) there must be better publicity of the liquor ban areas.

I think the Council should have full page Dom post notices 4 times a year, as well as the same in the local area newspapers. Wellington City has a large transient population with the number of tourists, student intakes of universities & education centers, and visitors to the Hospitals and they are not informed of the banned areas.

One suggestion was for all Off Licensed premises in a banned area have notices stating that as a reminder the customer is in such a banned area.

Also smaller hand out notices be given with each purchase.

LIQUOR LICENSING and DLC

4) There should be full cost recovery of all the licensing Inspectors cost, as well as the operational cost of the District Licensing Committee. The cost should be put on each and every applicant.

5) Licensing Inspectors MUST address the objectives of the ACT in relation to applicants seeking Off and On Liquor Licenses. They should see their role as "representing the community" in regards "Amenity and Good" order rather than opt out or fence sit as they do now.

6) Licensing Inspectors must see their role as being both educational as well as compliance. It took me 6 years to gain approval to speak some Te Reo at DLC hearings, and one DLC directive was I was only allowed to speak English!

7) Licensing inspectors must engage with communities where Off and On licenses are sought or renewed. If the Licensing Inspector cannot represent the community then the Council should have a lawyer employed to bring about a level playing field before the DLC. Council should promote their web site more in relation to liquor licensing.

With all new licenses and renewals a letter should go from Council to all ratepayers within a 1000 meter radius to advise of the application.

8) I have been active in both Newtown and Kilbirnie in opposing new liquor licenses and also renewals mainly against the big supermarkets but also against stand alone Off Licenses.

Under the new Act I have opposed 9 license renewals (the same supermarkets twice and three times). I have worked strongly to support the Newtown Community in opposing 4 licenses. 3 being new applicants and the community won.

So I have strong experience as to what works and what doesn't in regards liquor licensing. In 10 of the above cases it lead to a reducing in trading hours, and three new applicants who didn't get a license.

I have actively supported people and communities in Wellington, and outside of Wellington to get positive outcomes in regards licenses.

The Police and the Ministry of Health

9) numbers 5,6 & 7 above also applies to the Police and the MOH

CAP LICENSES

10) Council has a reducing CAP on pokie machines with a one to 300 ratio. To have a CAP on liquor licenses of course would be complex but a formula could be developed.

My starting point for booze licenses would be for a CAP of 1:1000.

The national average of liquor licenses is 1:1000 but in some localities within the city there is a much higher ratio than others. I am more interested in OFF Licenses being capped. The issue of density of licenses, and closeness to sensitive sites must be debated and better control measures put in place.

11) Some other communities like Lower Hutt and Palmerston North are considering a CAP.

HOURS OF BOOZE TRADING

CBD

12) I don't particularly care about the CBD. The Council, Hospitality Industry and the food industry (Supermarkets) created the 'absolutely negative Wellington' CBD so you can clean it up. Thank god we saw the back of the rugby sevens. Hamilton is great to take that mess off our ratepayers nightmare.

But I support in the CBD On licenses to be 3am close, revolving door policy, increased 'Host Responsibility' such as pubs pay for drunks to get home (collect the fare next day from the punter).

With Off Licenses in the CBD I say they should all stop selling booze at 9pm to address issues of preloading and crime.

13) There should be more water drinking fountains in the CBD

THE SUBURBS

14) Outside of the CBD I say that:

For On Licenses: 3 am close but in some cases 12 midnight. An example would be the Zoo Bar in Newtown.

For Off licenses in all suburban areas off license bottle stores including small and large supermarkets and dairy stores close of booze sales must be 9pm, and in some cases 8pm.

To reduce the booze selling hours of the supermarkets and stand along stores means there would be a reduction in crime and social disorder in those areas.

RUBBISH VANDALISM GRAFFITI

15) too much booze underscores the issues of too much rubbish, vandalism and graffiti in our city. The Council, as well as communities, and businesses pay huge sums of monies in these three overlapping areas.

16) the majority of wine and beer bottles comes from the big Off License Supermarkets. Why should every ratepayer have to subsidize the drinking to excess of their neighbors in having to have green recycle bins for the booze bottles. I advocate that the Council, together with the Supermarkets should have on site recycle bins in the supermarket car parks. Big bins, like at the dump. Thus every happy supermarket punter could and should take all the bottles and excess packaging and plastic back to that site. Even a 10cents credit per bottle.

SENSITIVE SITES AND LOCALITIES.

17) Council, and all other authorities know where there are sensitive sites and localities. That's Hospitals, schools, mental health facilities or the Zoo.

Wellington needs a LAP. Gisborne has just approved a great LAP.

A LAP must provide protection for sensitive sites.

Consider this statement as an example that could be included in a LAP:

" Grounds of objection to grant of license.....

That the licensing thereof is not required in the neighbourhood or that the premises are in the immediate vicinity of a place of public worship, hospital, or school, or that the quiet of the place in which such premises are situate will be disturbed if a license is granted"

Well that is section 91 (c) of the Licensing Act 1908!
So what has changed in over 100 years!

I advocate that the Council should:

a) have strong policy to stop any more licenses of both Off and On being permitted within 1000 meters of such identified sites and

b) all existing Off Licenses be considered both in the short and long term to be brought out if close to sensitive sites. That is closed down and compensation made. Well that is what NZTA does when it wants to take farmland or houses for motorways!

MUSIC and SPECIAL EVENTS

18) I think that in Wellington, the Council, with the Police, MOH and organizers of Music and special events we have become better at managing them both either excluding or including alcoholic drinks. Its not without problems but a vast improvement on the out of control early days of the Sevens Rugby. The issue for any and every public place event that has alcohol is the disruption caused by pre loading and side loading.

This is where I am adamant that the big supermarkets should have large present availability of trading hours reduced to 8 or 9pm every night. It is the supermarkets that are the biggest cause of pre loading.

(<https://newsouteast.files.wordpress.com/2015/09/kilbirnie.jpg>) The Kilbirnie Business Network reports continued issues with intoxicated people in the suburb and is pushing for an alcohol ban. Not just for Kilbirnie, but also for the entire Eastern Suburbs, on the basis that a ban in Kilbirnie is likely to simply shift the problem further South or East. That ban being no drinking in public, licensed houses and alcohol sales would still be allowed.

It has been a contentious issue in Kilbirnie that so far as seen no resolution.

Drunks urinating in the street, sniffing glue, hassling shopkeepers and demanding money from people at cash machines have sparked calls for a Wellington suburb to impose a liquor ban.

Businesses in Kilbirnie say the shopping area has become a haven for drinkers and beggars.

In Miramar and Strathmore as the weather gets warmer the instances of people drinking on the streets increases as does the number of homeless. While we were researching this article we saw two public drinkers in Strathmore. I talked to the owner of a nearby outlet and he told me that morning he had called the Police.

Three drunks had come in asking for alcohol and he had refused them on the basis they were intoxicated. They refused to leave the shop. The police were called and the three told to leave. One returned and was arrested.

The causes of these problems are deeply rooted in social issues. One of the contributing factors is accessibility of alcohol and when we have seen Pak N' Save breaking the law in relation to selling alcohol once this year (<http://www.stuff.co.nz/business/better-business/70566212/Kilbirnie-Pak-n-Save-in-booze-ban-after-selling-to-pair-of-16-year-olds>) and a outlet in Eastern Suburbs twice, it seems there is a lazy attitude to the law.

Unfortunately, a total ban will mean that responsible drinkers who want to have a beer or glass of wine on the beach over summer will suffer.

We put the questions of a total ban to the local Councillors and asked what it was that the Council was practically doing to address the issue.

Ray Ahipene-Mercer does not support a total ban and told us that there is no single solution that promises to eliminate both public drunkenness and homelessness.

"Our responsibility is to work with the relevant social agencies, and the police to respond. We have engaged with both of these through our community services section. We will continue through our community services to work with both of these to reduce as much as possible these challenges."

Simon Marsh held a public meeting in Kilbirnie back in June, this was the catalyst for Kilbirnie to pursue an alcohol ban, which has now grown to a call for an entire Eastern Suburbs ban.

Simon told us that;

"The meeting was emphatic in its support of the community

pursuing Kilbirnie as an alcohol free area. The meeting was aware that this would not be a panacea for the issues outlined but would be part of a solution. It was also pointed out if such an area were to be created then the issue of public drinking could well move to Strathmore and Miramar.”

Simon has subsequently met with Council Officers, Police, and community support groups which has seen Police increasing foot patrols supplemented by Wellington City Council Hosts. Other work continues to address the issues. Simon would like to see people wanting to support beggars donating to local organisations that are supporting Kilbirnie directly.

Sarah Free is willing to consider a liquor ban in the area, but notes that “It needs to be well thought through however, or else there is a risk of unintended consequences or a legal challenge.” Sarah also notes that

“We are working with the urban design team to make the physical environment more open, and less appealing for people to sit and drink, and we are continuing to collect evidence around drinking behaviour, because if we are to impose a bylaw we need to make sure it is going to do more good than harm.”

In the meantime, Bruce Welsh wants locals to contact him with incidents and evidence in relation to drinking and begging on the streets, particularly in Kilbirnie.

13) In the very recent years, and particularly in reference to this matter before the DLC I have seen how the whole community has changed for the worst since the two local giant booze supermarkets have got their booze licenses.

14) All the local population was there before the supermarkets arrived then got there booze licences. So with Pak & Save taking in more than one big truck a day, and Countdown taking in a truck every three days, means excess booze sold in the area. This equates to levels of crime and disorder in the community.

15) In being the Chair of the Community Centre, the Centre's executive committee and the staff of the centre, as well as the hundreds of customers of the centre suffer from the boozed and aggressive beggars in the street, as well as those that come into the centre for no good purpose.

16) The Police statistics show how there is a peak in alcohol fuelled crime between 3pm and 6pm, and then later between 11pm and the following morning at 3am. Such crime statistics tracing high levels of incidents within the radius of 500 metres centred at Pak & Save. Remember Countdown is within that radius as well!

17) The impact of incidents directly outside in Bay Road, and then within the physical buildings of the Centre is of the up most importance to be considered by the DLC.

18) The Centre has had to employ different staff to cope with these incidents. Beef up security procedures, deploy 'panic alarms' and provide added security to both staff, customers and for the many community focused events that run in the Centre.

19) This effected me personally in terms of having an increased work load as Chair, in having to confront and work through the intense issues caused by the incidents.

20) I needed to seek extra funding from WCC.

21) The Council responded both in a positive and negative way.

22) I had to spend extra time on staff matters and community groups to ensure their safety was protected. We did have, and it is still happening, many changes that have had to be made because of the huge increase in alcohol related incidents in Bay Road. These impact in a negative way on the wellbeing of the community groups, old ladies, men, and young people who attend events at the centre.

People who attend dance, tai chi, music, cards, CAB, and numerous community groups have had to be warned about the need for personal and group safety.

23) Does this effect me personally. Hell yes. It needs extra energy, application to duties and huge support by the community centre staff and committee.

24) I have been with community centre staff and committee members, observed John/Matthew/Paul etc, be in Bay Road, go into Countdown, buy booze, come out and sit in the adjoining Community Centre garden grass area, get under the influence, then come into the centre and be abusive.

25) This minute is to advocate my standing. I have already stated I wish to attend before the DLC, so as to give evidence of these matters. I am advocating as a person. I can clearly show and demonstrate the answer to the applicants point 10.

26) It is in this regards I advocate again that the DLC must hear from Jenny Rains, the Director of Community Centres in the WCC, or the Licensing Inspector must acquit the responsibilities of providing information and data that is available to them from their colleagues.

27) I attended along with more than 100 people from the community when a meeting was held in the Community Centre in June 2015. The meeting was called by concerned citizens for a Liquor Ban to be put in place in Kilbirne because of the escalating drunks, beggars and disorderly behaviour in Bay Road and around the radius of the two booze supermarkets.

28) Area Commander Inspector Chris Bensemenn addressed the meeting and apologised three times as to his forces inaction! Representatives from Health, Mental Health and the Council (Jenny Rain) were in attendance, as well as four Councillors.

29) Even the local beggars called for a liquor ban. See attached.

30) So there is huge information available to draw upon, and the DLC must consider that in making a decision. I will certainly produce more evidence at a hearing as to how this community has been effected by the booze supermarkets.

31) I refer also to the Christchurch MOH and J & G Vaudrey Ltd. Gendall J was rather strong in both his direction to that DLC, as well as dishing out clarity to the lawyers for the applicants. Such applicants and lawyers are again involved in this case.

32) Its important that the DLC address the objectives of the Act.

33) In summary I say:

Booze sold at this supermarket effects me directly
Booze sold at this supermarket effects my community
I live within 1000 metres of this booze supermarket as the crow flies.

Therefore I have the right to have standing as an objector under the Act.

Submission to WCC re proposed Alcohol control bylaw

We propose Kelburn Park (including the adjacent children's playground) be included in the extended boundary of a limited Alcohol Ban area

The Local Government (Alcohol Reform) Amendment Act 2012, which amended the local government act 2002 (the Act), increased the threshold for introducing alcohol control areas. S147A of The Act requirements on local authorities, including that the authority must be satisfied that:

- A bylaw can be justified as a reasonable limitation on people's rights and freedoms
- There is evidence that the area to which the bylaw is intended to apply has experienced a high level of crime or disorder that can be shown to have been caused or made worse by alcohol consumption in the area; and
- A by law is appropriate and proportionate in light of that crime or disorder.

Our request to have Kelburn Park (KP) designated as an alcohol-controlled area meets the requirements as set out in the local government (alcohol reform) amendment act 2012.

1. KP has experienced a high level of disorder.
2. The problem is caused by alcohol consumption.
3. A bylaw is appropriate in light of the disorder.

A bylaw can be justified as a reasonable limitation on people's rights and freedoms

- We believe there would be no loss of rights and freedoms to the users of KP if an alcohol ban was in place from dusk to dawn. It would not stop spectators / players enjoying a beer watching rugby, cricket etc. Family picnics (non-existent) would not be caught up in the ban. Sports clubs premises could be exempt from the ban.
- The only amenity loss will be for students who use the park at night for binge / harmful drinking and preloading.
- The residents' rights to peace and quiet have been severely limited by the alcohol-fuelled behaviour at KP.

There is evidence that the area to which the bylaw is intended to apply has experienced a high level of disorder that can be shown to have been caused or made worse by alcohol consumption.

- Some years ago the council decided to disestablish the live in resident caretaker's position at KP. Almost immediately students started congregating at the fountain for late night drinking sessions and preloading. That was the start of many years which can only be described as a living hell for KPs neighbours and myself.
- The screaming, chanting, fighting, vomiting, and urinating at the fountain become commonplace up to three nights a week. Inclement weather doesn't deter them. The drinking would continue till midnight and beyond. Up to two hundred plus students would attend, rarely would there be fewer 50. There were times the drinking would start early morning and go through to the next day.
- The piercing screaming from the very drunk girls, many of whom could hardly stand, sounded like they were being assaulted, the boys would yell and chant. Vomiting appeared

to be a badge of honour. Weir house students were the main culprits but were often joined by Te Puni and other halls of residents.

A bylaw is appropriate and proportionate in the light of that disorder

- Council's own alcohol policy states "an alcohol ban is considered to be an effective tool to help the council and police maintain public safety from **alcohol related harm**". Drinking at KP for the most part is not social, (why would you socialise in almost complete darkness?) it is to get drunk, it is to preload. These are mainly first year students around 18 years old, they are binge drinking, and they are causing harm to themselves. In between January and September 2015, 33 intoxicated first year students presented to Wellington Hospital ED, 3 were from Weir house and 8 from Te Puni. (Refer to Appendix One).

Alcohol Related Harm

- The stress caused by continuing disturbed sleep, frustration and despair has taken its toll on our group. Depression and anxiety has been diagnosed. Neighbours have sold up and others are considering selling. So very real harm is happening to both the students and the residents.

Victoria University Wellington (VUW)

- Victoria University originally didn't want to know about the problem, we were passed off told they had had no other complaints etc. There was nothing they could do about it, as the students were off university land. It was an infringement of the students' rights to intervene anyway etc. Eventually VUW would hold neighbourhood meetings, which WCC Safe city representative attended, but these were for show and nothing eventuated.
- The students out of control behaviour made the Dom Post. Articles about the alcohol fuelled riot at Katherine Jermyn hall, along with out of control drinking at other halls and KP

appeared. VUW could no longer ignore the problem or deny it existed. Campus Care now moves students on when they congregate on KP if the neighbours contact them. The problem has not gone away, but it is being controlled to some extent. What authority has Campus care over the students (they were unable to get students to turn down a ghetto blaster last Saturday as they partied for the fourth time during the week).

- Given VUW only acted when the negative publicity was likely to have an effect on enrolments and their flagrant disregard for the neighbours in the past, we have no faith or surety that the present policy may not be changed to our detriment. VUW's ambitious expansion plans, in both numbers of students and student accommodation, in the adjacent area gives real cause for alarm. We are totally in the hands of VUW policy, which is not an acceptable situation. And given the councils total impotence in dealing with this in the past, it is essential a partial alcohol ban be applied.

Wellington City Council (WCC) Response

Frequent calls to noise control were either not recorded, (this was borne out by council's official numbers of noise complaints which was vastly different to Vic neighbours records), or not acted upon, or turned up to an hour after the students had left, or we simply couldn't get through to noise control.

- Councillor Nicola Young did her best to get VUW to act upon what was their problem of their student's drinking on KP, (the ratepayers picking up the cost of extra rubbish collection, the removal of broken glass on the sports field and in the Children's playground! and the cost of repairs caused by vandalism.) In the end she admitted defeat and advised there was nothing more she could do. WCC repeatedly told us there was nothing they could do without an alcohol ban.
- The police were the only authority to respond, however that was highly dependent on our being able to get through to them on the non-emergency line or them having manpower available. And again, they were hampered by not having an alcohol ban in place.

The Residents Group (Vic Neighbours)

- Vic Neighbours was informally formed by a group of exasperated locals who are badly affected by the frequent antisocial behaviour by the students. Many of us have put in hundreds of hours cleaning up rubbish, lobbying VUW, the council, police and reporting incidents on the park. We know that it is essential that Kelburn Park be added to the alcohol ban zones.
- We are surprised Kelburn Park was left off the list of proposed alcohol ban zones. We are concerned the council did not see fit to advise us of this review and have been hampered by the short time frame with which to make submissions.
- Appendix Three – Relevant parts of original submissions concerning the harm caused by binge drinking / preloading at Kelburn Park as per the submissions on the rezoning of 320 The Terrace which shows the considerable harm and disorder at KP.
- We believe there is ample evidence to support a partial ban on alcohol on Kelburn park.

- WCC should take action to have Parliament return the criteria for liquor ban areas to what they were before 2013. We explored the possibility of such a ban for Kelburn Park and adjacent areas but discovered that changes to the Local Government Act 2002 (sections 147A and 147B) now require that there be “a high level of crime or disorder” associated with alcohol consumption. This threshold seems so onerous that even WCC’s existing liquor bans might be in doubt when the relevant bylaws are reviewed. Losing those bans would be a seriously retrograde step.



Thank you for your e-mail received by Capital and Coast District Health Board (CCDHB) on 19 June 2017, in which under the Official Information Act 1982 you requested information relating to students who turn up drunk and disorderly to Wellington Hospital Emergency Department (ED).

The request asks for data on all students who turn up drunk and disorderly at Wellington Hospital ED from 1 September 2015 to 31 August 2016 and 1 September 2016 to 31 May 2017. The request also asks for the data to be broken into the various student halls and include alcohol and drugs.

Wellington ED does not collect data specific to drug use as part of a person's presenting problems. We have provided information related to alcohol.

For the period 1 September 2015 and 31 August 2016, there were a total of 34 patients presenting from Victoria Halls of Residence with any type of alcohol presentation. Please refer to the table below.

19.09.2015

Our Kelburn Park group has formally met with representatives of Victoria University, Weir House, Wellington City Council and the Police on multiple occasions, and often exchange emails around concerning events. We continue to attend these meeting, but to date we and the other residents have been dissatisfied with the university's and the Council's responses to our concerns.

Indeed, we consider the Council and the university appear to be more interested in the income generated by an increasing student residential population, than encouraging a vibrant, attractive and diverse neighbourhood that includes considerate, law abiding families and young professionals. It feels like Wellington is being supported to become the 'new Dunedin', the 'premier' destination for students whose primary focus is to party rather than study.

Our home was our sanctuary.

Liquor bans or managed events on university property: While the Kelburn Park residents' group has supported having a liquor ban in the park, and surrounding streets, to date there has been no support from the Council or the university. If a liquor ban is not possible we recommend the university encourages students to *drink moderately* in its own indoor areas, under responsible supervision and *with effective noise control* in place. If the plans for a large lawn at 320 The Terrace is met, we can only imagine how popular it would be for drunken student outdoor parties that will disturb the local residents over an extensive area.

Remove alcoholic litter discarded in residential areas: To date no effort has been made by the university or the Council to remove alcoholic litter discarded by students in Salamanca Road, down the walkway below Weir House and on the footpaths and adjoining gardens down Everton Terrace following drinking events in Kelburn Park. In the absence of a liquor ban, local residents must not have to manage this problem or have to live in a degenerated environment.

Peace and quiet are particularly important for people's wellbeing, and the District plan contains specific rules to control noise. Council is particularly concerned to protect residents from the effects of noise. As well as these rules enforcement orders and abatement procedures will be used to control any excessive noise"

Both the council and Victoria University score an epic fail in protecting residents from the effects of excessive noise and nuisance caused by students in Residential Halls. My neighbours and I have endured the drunken antics of students (mainly from Weir House) at the Kelburn Fountain EVERY Saturday night and MOST Wednesday and Friday nights of this University year, screaming yelling and chanting along with urinating in the fountain vomiting, broken bottles , rubbish and wanton vandalism, starting at around 10pm and going on to midnight.

The University has treated its surrounding neighbours with arrogance and contempt. It has done nothing to address the ongoing anti-social behaviour of its live-in students. It denies it has responsibilities for student misbehaviour off campus but at the same time creates rules and regulations that encourages exactly that. Otago University fines its students for bad behaviour off campus. Victoria won't even contemplate this suggestion.

As Victoria University has spectacularly failed to meet the council's objectives in its existing Institutional Precinct, to rezone 320 The Terrace to institutional Precinct would totally unacceptable.

Considering Courtnay Place is the epicentre of drinking culture in Wellington City, extending the liquor control area from Cambridge Terrace to Brougham Street will benefit the safety of those residing in close proximity to the city. Furthermore, expanding the zone can reduce alcohol related crime in residential areas and be reassuring to residents who may have experienced alcohol related crime. Suggested in the Bylaw Statement of Proposal, alcohol related crime consists of urinating, loud screaming and violence. Of the 174 alcohol related arrests in Mt Victoria in the past five years, 80 were made in the existing Liquor Control Area and 51 carried out on the other side of the border. We believe this is sufficient data to show that the level of alcohol related crime and disorder is currently high in this relatively small geographic area. The Alcohol Ban would restrict people being able to drink in this area which will reduce this high level of crime, ultimately helping to protect public safety. Youth Council also recognises that the current boundary of the existing area between the city and Mt Victoria is inconsistent, only covering one side of some streets. We support extending the boundary to eliminate this confusion for citizens and ease enforcement.

Currently, council has no information to show there is any alcohol related crime in this area. As the area has been deemed inaccessible to the public, we believe Council should remove this area from the existing zone. As most of the activity happens in town, i.e. Courtney Place, Taranaki Street and Mt Victoria, it is best to have more enforcement within those areas, thus reducing the high amount of alcohol related arrests.

Apart from the CentrePort area, are there any other areas in the existing Liquor Control Area that you think should be removed? Which areas and why?

We believe the Liquor Control Area ultimately has positive impacts for communities and public safety. The most prevalent areas where alcohol is consumed either irresponsibly or of excessive amounts are covered nicely. Youth Council does not believe any other areas of the existing ban zone should be removed.

What other actions could the council take to address public safety and alcohol related incidents that you are concerned about in your local community or other areas in Wellington?

Being a city where alcohol is consumed in large portions by a diverse populous, we believe Council is already doing their part to reducing levels of crime and conflict within public and residential areas. As long as Wellington remains a region known for its vibrant university culture and its attractiveness to younger generations, there is always going to be alcohol contentions. Continuing with discourse around the negative impacts alcohol has and implementing strict control measures within alcohol zones is the best way to lessen prevailing contentions and can help reduce some of the issues discussed within the proposal. We would also like to see more lighting particularly around Mt Victoria to discourage crime and increase public safety. Youth Council believes in and supports initiatives such as 'Take 10 assistance' to help prevent alcohol related harm.
