FRANK KITTS PARK A WATERFRONT PARK- ONE OF ONLY TWO.

A green public open space recreational park

#### **SUMMARY**

- Frank Kitts Park is a park not a building site for development.
- The Wellington Civic Trust has fought for the public's waterfront for over 40 years.
- The Wellington Civic Trust supports a fale malae on the Waterfront but not on Frank Kitts Park.
- The Council has made no decision to release the Park to become a site for this building. (contrary to perception)
- Therefore we request that Council investigate thoroughly an alternative site for the Fale malae: the Transition site between Te Papa and Waitangi Park
- We request that the mayor and councillors, move a resolution asking the officers to investigate thoroughly an alternative site for the Fale Malae the Transition site between Te Papa and Waitangi Park and report back to the Council and the public.

#### **BACKGROUND**

#### COUNCIL DECISION FALE MALAE

On 23 September 2021, "3. Subject to landowner and resource consent processes, endorse in principle the Fale Malae Trust proposal to continue investigating Frank Kitts Park as the preferred site for the Fale Malae, being the south west corner of the park where the carpark building is currently located." (The carpark is underneath the Park. Council has agreed to demolish it, and with it the pedestrian bridge over Jervois Quay destroying that access to the Waterfront.)

At least two current councillors from the former council advocated against this building on Frank Kitts Park

#### COUNCIL DECISION: FRANK KITTS A PARK

Contrary the above decision and within less than a month: On 26 October 2021: Wellington Central Green Network Plan approved by Council: Frank Kitts Park was approved as a key city park - one (of only two) Waterfront park.

#### CIVIC TRUST BOARD RESOLUTION AND POLICY

"At our Meeting on December 6 2021, the Civic Trust Board was presented with argument which supported the Transition site (called 'Te Papa Transition' in the Waterfront Framework), as a more readily suitable and available site, for a range of reasons. After discussion we confirmed:

- That the Trust's long held approach and policy regarding Frank Kitts Park is that the entire area remain green public open space, with no major buildings or excluded spaces;
- ii. That the Trust will continue to seek that the whole area (including the part of the Park area which is currently located above the to-be demolished car park) remains green open public space; and
- iii. That the Trust supports a fale malae

That the Trust write to Wellington City Council, asking that there be a parallel investigation by the Council, regarding the suitability of that part of the Waterfront, called the Te Papa Transition site as a possible alternative site. This expert investigation of the Transition site should also report back to the public and Council, at the same time as the Fale Trust investigation into Frank Kitts Park. "

#### COMMENT

A building on this rare and scarce Waterfront Park is contrary to Council policies eg. 'The Wellington Central City Green Network Plan - October 2021 and 'The Waterfront Framework' (reconfirmed only recently)

A major building there would be contrary to Council and Civic Trust policy and not in the public interest.

We therefore do not support this building on Frank Kitts Park.

The Wellington Civic Trust wishes to work with, not against the Fale Malae Trust, the mayor and councillors, to achieve for the public the most cost and environmentally successful outcome in the shortest possible time.

#### **CORRESPONDENCE WITH COUNCIL**

We wrote to the mayor, councillors and relevant staff several times in late 2021 of the last triennium and received far from satisfactory response from any.

We urge the current mayor and all councillors to seek out that correspondence and detail from officers. We are also available to discuss and would welcome each and all of you. We wrote requesting a thorough investigation of the suitability of an alternative Waterfront site and have suggested the 'Transition' site between Te Papa and Waitangi Park.

#### **'DEVELOPMENT PLAN'** (in Forward programme 8 Dec 2022)

Where is the resolution for a 'Development Plan' for "Frank Kitts carpark and Fale Male" to proceed at all? (See P. 328 of the Forward Plan for this committee: "Until final development plan is confirmed this work will not fully progress")

Who resolved that Council create a development plan? Who approved that a development plan by anyone be created? By whom? For what?

#### WORKSHOPS: DEVELOPING PURPOSE AND PRINCIPLES: OPTIONS FOR THE PARK

We have participated in Council workshops which we were led to believe related to a landscape plan for Frank Kitts Park not to a Development Plan. But there seemed to be an underlying but covert assumption that a building (the fale malae) would be going on Frank Kitts Park and that this workshop and outcome(s) were to accommodate that.

#### SOME ADVANTAGES OF THE TRANSITION SITE.

The fale malae may never be able to be achieved on Frank Kitts Park.

The advantages that the transition site might have over Frank Kitts Park seem obvious to us

- **Structural**: The transition site is available and therefore no need to wait to demolish a carpark (with attendant public opposition);
- **Financial**: Less cost the ratepayers in eg. Court fees. (The fale malae Trust has said it intends to pay for the building).
- Timeline: Earlier completion and opening and without Court appeals
- **Environmental**: adds another (smaller) Waterfront park in the malae fronting the Fale
- Environmental and Recreational: Protects Frank Kitts Park for recreational purposes and green open public space
- Adherence to Council policy: to enhance and protect one of two only green open public space on the waterfront
- Location: next to the moana for incoming vaka and celebrations
- Location: Cultural, scientific and educational: close relationship with Te papa the National Museum
- Location: Cultural: close relationship to Waitangi park and Festivals
- **Location**: Cultural: Interrelationship with the market enabling infusion and inclusion of Pacific Island food
- Location: Proximity Closer to most of Wellington's Pacific Island Churches
- **Location**: Economic and tourism : closer to the Tourism hub of Te Papa and Takina (the convention centre)
- LEGAL: Minimising significant public opposition with court delays and cost

#### IN CONCLUSION

The Trust prefers to work in collaboration with the Council and organisations rather than take an adversarial stance.

However, when necessary we have in the past taken matters to the Court.

Our concern for the Waterfront as a public open space asset has been core to our campaigns and success since founding over 40 years ago.

The fight to retain Frank Kitts Park as green public open space has ever been.

That recreation park status needs to be protected for our children grandchildren and all.

We urge the Council to resolve to thoroughly and as a matter of urgency, investigate the Transition site as an alternative site for the Fale malae.
