OBJECTION TO A CLASSIFICATION UNDER THE DOG CONTROL ACT 1996

Purpose

1. This report asks the Pūroro Hātepe | Regulatory Processes Committee to determine whether to uphold or rescind a classification as a menacing dog under the Dog Control Act 1996 (the Act).

Summary

- 2. Under the Act, Council may classify dogs as dangerous (section 31) or menacing (section 33A).
- Council's Public Health team has classified a dog as menacing and the dog owner has objected to this classification.
- 4. Both parties have submitted evidence, which is attached to this report.
- 5. This committee must determine whether to uphold or recind the original classification as a menacing dog.

Recommendation/s

That the Pūroro Hātepe | Regulatory Processes Committee:

- 1. Receive the information.
- 2. Note:
 - a. the evidence which formed the basis for the classification
 - any steps taken by the owner to prevent any threat to the safety of persons or animals
 - c. the matters relied on in support of the objection
 - d. any other relevant matters
- Agree to uphold the classification as a menacing dog OR
 - Agree to revoke the classification as a menacing dog.
- 4. Delegate to the chairperson of the Pūroro Hātepe | Regulatory Processes Committee: the authority to issue a written decision, which will be sent to all parties and attached to the minutes of this meeting.

Background

- 6. Under the Act, Council may classify dogs as dangerous (section 31) or menacing (section 33A).
- 7. Council may classify a dog as menacing if it has not been classified as dangerous, but considers that the dog may pose a threat to to any person, stock, poultry, domestic animal, or protected wildlife because of:
 - · Any observed or reported behaviour of the dog, or
 - Any characteristics typically associated with the dog's breed or type.
- 8. If a dog is classified as a dangerous or menacing dog then the dog owner has the right under section 33B of the Act to object to the classification and has the right to be heard in support of the objection.
- 9. At Wellington City Council, the Pūroro Hātepe | Regulatory Processes Committee has the delegation to hear objections to classifications under the Act.
- 10. The only decision that the committee can make is to uphold or recind the original classification. The committee cannot propose any further restrictions on the dog or dog owner and cannot classify the dog as a dangerous dog.
- 11. When making it's decision, the Act requires the committee to have regard for the following four factors:
 - The evidence which formed the basis for the classification
 - Any steps taken by the owner to prevent any threat to the safety of persons or animals
 - The matters relied on in support of the objection
 - Any other relevant matters
- 12. If a dog is classified as a menacing dog then the owner of the dog:
 - must not allow the dog to be at large or in any public place or in any private way, except when confined completely within a vehicle or cage, without being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction; and
 - must, if required by the territorial authority, within 1 month after receipt of notice
 of the classification, produce to the territorial authority a certificate issued by a
 veterinarian certifying
 - o that the dog is or has been neutered; or
 - that for reasons that are specified in the certificate, the dog will not be in a fit condition to be neutered before a date specified in the certificate; and
 - must, if a certificate stating that the dog is not in a fit condition to be neutered is
 produced to the territorial authority, produce to the territorial authority, within 1
 month after the date specified in that certificate, a further certificate under
 paragraph that the dog is or has been neutered.
- 13. Any classification as a menacing dog is in force throughout New Zealand.
- 14. If the dog owner fails to comply with the above conditions, they would be in breach of the Act and could face a fine of up to \$3,000. Additionally, if the dog owner fails to comply with the above conditions, a dog control officer or dog ranger may sieze and remove the dog concerned from the person's posession and retain custody of the dog until they are satisfied that the conditions will be complied with, or until the dog is destroyed in accordance with section 71A of the Act..

Discussion

- 15. Council's Public Health team has classified a dog as menacing and the dog owner has objected to this classification.
- 16. Both parties were asked to submit evidence, which has been attached to this report.
- 17. The committee will sit in a quasi-judicial capacity for this hearing. The meeting will proceed as follows:
 - The WCC Public Health team will present their evidence and any witnesses and answer any questions from committee members.
 - The dog owner will present their evidence and any witnesses and answer any questions from committee members.
 - The WCC Public Health team will have the opportunity to respond to the dog owner's case
 - The dog owner will have the opportunity to respond to the WCC Public Health team's case.
- 18. No cross-examination of one party by the other will be permitted.
- 19. Following hearing from both parties, the committee will adjourn to deliberate on the matter. The deliberations will take place with the public and both parties excluded but will be minuted in detail. These minutes will form the basis of the determination issued by the chairperson.
- 20. Following the deliberations, the committee will reconvene, and a motion will be moved, seconded, debated, and voted on. Standard committee procedures for debate and voting will be used. The vote will be by simple majority.
- 21. Following the meeting, the chairperson will issue a determination which will be attached to the standard meeting minutes.

Options

- The committee can uphold or rescind the original classification as a menacing dog.
- 23. The committee cannot propose any further restrictions on the dog or dog owner and cannot classify the dog as a dangerous dog.

I appreciate the opportunity to speak to the Council Regulatory Processes Committee in relation to my objection to the classification of our dog, Breaker, as a menacing dog under the Dog Control Act 1996 (Act).

First, however, I agree the complainant would not have been hurt if Breaker had been on a lead. I feel regret that Breaker being off-leash lead to a person being hurt. I have received and paid the \$300 fine for an infringement in relation to s 20 of the Dog Control Act. I now walk Breaker on-lead only (outside off-lead areas) and he wears a muzzle around his neck on a temporary basis pending the outcome of the Committee's decision.

I am asking the Council to rescind the classification of Breaker as a menacing dog as:

- the Council lacked evidence to decide that Breaker attacked the complainant or his dog George (see no. 1),
- the Council seems to have acted unfairly, predetermining the classification without an open mind (see no 2), and
- the main issue is that Breaker was off-lead resulting in the injury and to prevent any further threat to the safety of people or animals I, now, and will continue to, walk Breaker

on-lead.

1. Lack of evidence for dog attack offence.

For the detailed reasons at 1.1 and 1.2 below I believe the Council:

- lacked evidence to decide that Breaker attacked the complainant or his dog George,
- should not have scored a level 13 'attack person causing injury' for Breaker in its 'Attack rating report' (attached as appendix A), and
- should rescind the classification of Breaker as a menacing dog under s 33A of the Act.

First, I would like to comment generally that:

- the Council seems to have relied on the complainant's version of the facts as the only
 evidence for its decision that Breaker attacked George and the complainant,
- the only other witness to the complete interaction between the dogs, the complainant's wife, has not made a statement,
- there is no video or photograph of Breaker attacking George or the complainant, and
- no Council officer witnessed Breaker attacking George or the complainant.

1.1 Did Breaker attack George?

The complainant stated "...the large Collie... suddenly rushed out onto the street and began to attack [George] in a vicious manner. My wife was trying to pull [George] and was in danger of being pulled over."

The investigating officer then stated² as a fact "[the complainant's dog] was attacked by Breaker."

Although I did not witness the complete interaction between the 2 dogs, I ask the Committee to take into account the following points:

- Breaker is a friendly well-socialised rough coat collie who has been a much-loved member of our family for 6 years and lives harmoniously with a free-range parrot and a cat (please refer to references about Breaker from Alla Baider (attached as appendix B) and Raewyn Mullan and my neighbour Terry both sent separately to the Council),
- rough coat collies are known for their sensitivity, intelligence, friendliness towards other dogs and strangers, loyalty, gentleness and compliance – they are not known for attacking people and other dogs,
- I have some experience with dog behaviour as I grew up on a sheep farm with working dogs,
- I have often walked Breaker off-lead in the past 6 years (without incident) as he is well trained, gentle and compliant (although I now appreciate my mistake see above),
- in this case I believe that Breaker (who was in the lookout park with me) ran to see
 George (on the footpath) not to attack him but to do his usual friendly dog-greeting,
- as mentioned in my statement³ when I saw the complainant and his wife walking George down the footpath (heading south) (as George has sometimes responded aggressively to Breaker's friendly greetings) I turned and walked away from the footpath side of the lookout and George (holding a stick out for Breaker and expecting him to follow me)

- I turned when I heard growling and saw Breaker (face-to-face with George and pointing south) was blocked:
 - from the front by George (who had turned to face north) lunging at him aggressively (the complainant states⁴ his wife struggled to restrain George to the extent that he feared George would pull his wife over),
 - o from the left, by an upward rising bank and the lookout fence,
 - from the right/back by the complainant (facing south-east) kicking his right leg into the right side of Breaker's mane, and
 - o effectively from the back, as dogs find it difficult to move backwards.
- I called Breaker twice in quick succession,
- · as Breaker was trapped, he did not turn around normally but:
 - o reared upright on his back legs,
 - swivelled 180 degrees upright to his left anti-clockwise (towards the bank not right towards the complainant) (note he also looked directly at me during the swivel and he was not snarling or growling but looked confused),
 - o 'landed' with his front paws facing north, and
 - o ran straight back to me through the northern gap in the lookout fence.
- I believe it is more likely that George, a labrador, attacked Breaker as:
 - o labradors, as a breed, are known for attacking people and other dogs.
 - George has several times in the past behaved aggressively towards Breaker (as noted above and in my statement),
 - o after turning, I saw George lunging toward Breaker, and
 - after the interaction, I saw that George was unhurt but had a large clump of Breaker's fur in his mouth (as noted in my statement).

1.2 Did Breaker attack the complainant?

The complainant stated⁵ "I ran up immediately to try to get the dog off [George]...The dog then viciously turned its attention onto me and tore my right leg very badly in two places." The investigating officer then stated as a fact in his report⁶: "During the attack [the complainant] ran to break the dogs up. As he did this Breaker..turned and attacked the [complainant] biting hm on the right calf. ... When asked, [the complainant] was adamant that he was bitten by Breaker." Inconsistently with this statement (the investigating officer does not conclude in the report that Breaker attacked the complainant but rather "as a result of this investigation I find that (the complainant) received an injury while trying to break up the dogs fighting possibly redirected aggression from the dog fight."

I ask the committee to take into account my comments in 1.1 above in relation to the Council decision that Breaker attacked George and also the following:

- I witnessed the interaction between Breaker, George and the complainant during the
 period beginning when I turned around (on hearing the dogs growling) and ending when
 Breaker starting running back to me,
- I saw the complainant standing next to Breaker as described above, facing south-east, hold his arms outstretched in a 'T' shape (maybe for balance?) and kicking his bare right leg (he was wearing shorts) back and forth into the right side of Breaker's mane with

George lunging north toward Breaker (and effectively the complainant's bare right calf),

- during this period I did not see:
 - o Breaker attack the complainant, bite or tear his leg,
 - o the complainant notice any injury to his leg, or
 - the complainant's wife showing any concern that the complainant had been attacked or injured,
- I did, however, see Breaker rear up and swivel 180 degrees on his hind legs as described in no. 1.1 above in response to my verbal command,
- during the 'swivel', in theory, Breaker could have touched the complainant at 3 points:
 - o scratching with the claw of his right paw as he reared upward,
 - o with the fur on his back as he turned anti-clockwise, and
 - o scratching with the claw of his left paw as he landed.
- none of these contact points, however, seem consistent with the injury to the complainant's right calf being several puncture marks and an open flap of skin as the result of a dog bite,
- the complainant did not realise he was injured until after Breaker had returned to me so I
 am confused as to why the complainant believes Breaker, rather than George, bit him.
- it seems more likely to me that George bit the complainant accidentally because:
 - o George, facing north, was lunging aggressively toward Breaker, and
 - the complainant, facing-south east, was kicking his leg back and forth into the right side of Breaker's main and effectively in the path of George's jaws.

2.Predetermination

I am also concerned that the Council has acted unfairly without an open mind in this matter-collaborating with the complainant but keeping me 'in the dark", accepting the complainant's version of the facts and distorting my words.

2.1 Complaint

I first learned of the complaint on 25 May when Council officer Mr Batty visited my house and informed me. Mr Batty was unnecessarily officious and unfriendly. He said:

- the complainant had complained that Breaker had bitten him, and
- the Council required a statement from me of time, place and what I thought had happened.

He did not ask for my email address or offer to put the request in writing (I note the Council put its request for a statement to the complainant in writing clearly stating the details required⁷).

I responded that the injury would have been a scratch only (meaning rather an intentional bite). Mr Batty seemed to misunderstand responding brusquely (as if I was trying to minimise the complainant's injury and distress) that the injury required several stitches.

Mr Batty did not provide me a copy of the complainant's statements.8

Mr Batty started to leave my house without giving me information about who to send the statement to (address) or timeframe. It was only when I asked him for these details that he

gave me the information by providing his business card.

On the same day (25 May) I emailed my statement to Mr Batty. The Council did not acknowledge receipt of the statement or communicate with me in any other way on the matter until I received, by post, the Council's letter and attachments (of 30 June 2021) signed by Mr Nunns. The letter and attachments notified me of the infringement, fine and Breaker's menacing dog classification (and right to object to the classification).

On 7 July 21 I notified Mr Nunns by email of my objection to the menacing dog classification attached and requested a copy of the complainant's statement but again received no acknowledgement from the Council or information about next steps.

In late July (perhaps 27 July?) we were in a position to pay the fine but could not find any clear information about how to pay it on either the Council's correspondence of 30 June or the Council's website. My wife, accordingly, telephoned and left a phone message for Mr Nunns who responded that day and mentioned to her 2 methods of paying the fine. Neither method was clearly and transparently provided in any Council communication/website (she paid the \$300 fine on 27 July). I then took the phone and talked to Mr Nunns asking if he had received my email of 7 July objecting to the menacing dog classification, my request for the complainant's statement and, if so, next steps. Mr Nunns confirmed receipt and noted that he should have told me that a different unit of the Council was dealing with the matter. He said it would be in touch with me soon.

On 29 June I received an email from Judy Austin of the Council seeking confirmation of my email address for receipt of the Council's 'animal services report'. I confirmed and received all of the correspondence attached as appendix A. I comment on some of that correspondence below.

2.2 Correspondence

Re the complainant's statement of 6.33 pm 24 May (appendix A),:

- I was absolutely astounded that the complainant stated as a fact that Breaker attacked George and bit the complainant (which for the reasons noted at no. 1 above is not a reasonable assertion), and
- I was surprised by:
 - the emotive language (use of the word 'vicious' in relation to Breaker's behaviour),
 and
 - the negative implication of Breaker and myself being 'well known" in Barnard St, and reference to the incident last January in which Breaker accidentally scratched my leg while we were play fighting (which in the context of the statement could imply that Breaker 'viciously' attacked me - which is absolutely not the case).

Re the addendum to complainant's statement of 9.31 pm 24 May (appendix A), I was disappointed to read the complainant's misleading statements that I did not:

assist the complainant to get Breaker off him, or

move off the lookout onto the street.

In relation to the first statement, I would like to add that:

- as noted at no. 1 the complainant had voluntarily put himself between the 2 dogs,
- I realised that the complainant's behaviour was foolish and it would be equally foolish to
 physically intervene myself, and
- knowing Breaker as a consistently compliant dog, I knew he would return if called (which
 he did immediately after the delay of pivoting out of his boxed in position as described at
 no. 1).

Re the second statement, it is true that I did not move off the lookout onto the street. This was quite clearly because the complaint and George were on the street. My intention was to keep Breaker on the lookout at a distance giving the complainant and George the space to move away peacefully.

It was however even more astounding to read the investigating officer's report¹⁰ as:

(under the heading 'circumstances') the report relies on the complainant's statement that
Breaker attacked his dog and attacked and bit the complainant as facts (see my
concerns about the evidence about no. 1 above). This reliance inflated Breaker's score
Attack rating report at appendix A. The Council did not seek my view on the
complainant's interpretation of the circumstances or seem to test the interpretation
thoroughly enough before finalising the report.

the report:

- o (under the heading 'alleged offender') seems to distort my reference to the injury as 'a scratch' and misleadingly implies I did not care about ,or was trying to minimise, the complainant's injury and distress. The report notes that I stated during Mr Batty's visit to my house that the injury was "only a scratch" but fails to put this in the context of my statement of 25 May in which I was clearly referring to a scratch in relation to the injury being accidental via a 'stray claw' rather than an intentional bite,
- does not mention or explore the key point in my statement of 25 May that neither the
 complainant nor the complainant's wife realised the complainant was injured until
 after the dog interaction (see no 1 above) which undermines the complainant's
 assertion, and the Council's resulting decision, that Breaker bit the complainant,
- does not mention the comment in my statement that after the interaction I offered to help but that the complainant yelled back "just keep that dog away from me." I note also in passing that:
 - on 21 May, the day after the incident, I put a card apologising for any distress and a small box of chocolates in the complainant's mail box, and
 - a few days later while driving down Barnard St I noticed the complainant talking with a group of people on the street (perhaps neighbours?). I immediately parked the car and walked over to show my concern and ask how the complainant was faring. Again the complainant yelled at me in front of the people saying things along the lines of Breaker was a vicious dog and the injury was serious. He abruptly walked away from the group of people and myself (in what appeared to

- email correspondence 25-28 May re medical centre records which seems to be initiated
 by Council to the complainant about getting the complainant's medical records from his
 medical centre which suggests that the Council went to the extent of ringing the medical
 centre and asking for the records directly a request declined by the medical centre.



Written warning for breach of bylaw requirement for dog to be on-lead Wellington Consolidated Bylaw - Part 2,

On 02/12/2020 at 16.25hrs you were sighted walking your dog Breaker off-lead on Oriental Bay. This area is designated as a controlled public place where dogs are allowed, as long as they are on a leash. It is an offence to allow your dog in this location with no leash.

As a result of the investigation there is enough evidence for the Animal Control Officer to have reasonable grounds for believing the offence did occur.

However Breaker's registration has not been renewed this year, \$262.75 is outstanding. Provided you reregister within 7 days the infringement will not be issued. If you fail to register, the infringement will stand.

Please be aware that if you allow your dog to be off its leash again in a controlled public place, it may lead to you being issued with an infringement notice and a \$300 fine being incurred.

I've had the chance to observe Breaker's behaviour around both my dogs and dogs belonging to others. Under no circumstances has Breaker ever been unfriendly around other dogs or shown the least sign of aggression towards people. Whenever he would approach other dogs, it was with curiosity and good will. He has really good rapport with Bryan, listens to commands and shows excellent recall manners, never leaving his owner's sights.

Having owned rough collies myself for 12 years I know first hand that their (Lassie) breed is exceptionally gentle and non-threatening to others. They are very intelligent and social dogs that always try to avoid confrontation and are only known to attack when provoked.

Executive Summary

On 24 May 2021, Mr Gary Evans contacted Animal Services advising that he and his dog had been attacked by an off-lead dog ("Breaker") and he had been bitten (Appendix 1). In an attempt to separate the two dogs, Mr Evans sustained several puncture marks and a large open flap to his calf, that required approximately six stiches. The incident occurred on Barnard Street, a public street in Wadestown.

On 24 May 2021, Animal Control Officer (ACO) Wayne Batty commenced his investigation (Appendix 2).

On 25 May 2021, ACO Batty received a statement from Mr Bryan Tresidder, the owner of "Breaker", confirming the incident between the two dogs. He advised that "Breaker" was off lead and he didn't see exactly what happened, as he was walking away from the park. When he turned around, he saw Mr Evans attempting to separate the dogs. (Appendix 3).

On 30 June 2021, Team Leader ACO, Damien Nunns issued Mr Tresidder with a 'Notice of Infringement, Breach of Section 57 and Menacing Dog Classification' (Appendix 4) under the Dog Control Act 1996 (The Act).

On the 7 July 2021, Mr Tresidder notified Wellington City Council (WCC) that he objected to the classification of "Breaker" as a menacing dog under The Act and that he was exercising his rights to be heard in support of the objection (Appendix 5). As a result of this request under Section 33B a hearing has been set with the Regulatory Processes Committee on 15 September 2021 at 1:30pm.

The offending dog owner has a previous history of failing to have a dog on-lead on 2 December 2020 for which he received a written warning (Appendix 6).

20 May 2021 Incident

On 24 May 2021, the Mr Evans contacted Animal Services via email (Appendix 1) at 6:33pm, to report that he had been attacked by a large collier dog. In his email Mr Evans has stated that:

Whilst out walking their Labrador (George) on leash on Barnard Street a large Collie dog (off-lead) owned by Mr Bryan Tresidder suddenly rushed out onto the street and began to attack George in a vicious manner. I immediately tried to get the dog off George when the dog turned its attention onto me and tore his right leg "very badly in

two places, requiring immediate medical attention to stem the bleeding and six or more stiches.

Mr Evans stated that he was presently immobilised and his wife, Isobel, is frightened to walk "George" alone "in case she should run into Mr Tresidder and his dog again".

On 24 May 2021, Team Leader ACO Nunns followed up with the Mr Evans requesting further information. Mr Evans supplied the time and date of the incident and noted that "Mr Tresidder did not assist me to get his dog off me and "George". He did not move off the lookout onto the street" (Appendix 7).

On 25 May 2021, Team Leader ACO Nunns contacted Mr Evans, seeking his medical records relating to the injury received by "Breaker" (Appendix 8).

On 25 May 2021, ACO Batty received an email from Mr Tresidder outlining his recollection of the event. In this email he advises that he was "throwing ticks for his dog, "Breaker" and had seen Gary and Isobel Evans walking down Barnard Street towards him with "George", their dog. He states that "George" often gets aggressive when "Breaker" does the usual dog greeting". "I walked away into the park thinking "breaker" would follow". Mr Tresidder goes on to advise "Then I heard a growl behind me, turned around and saw "George" and "Breaker" fighting. "I didn't see exactly what happened, but it appeared Gary was trying to break them up". He notes that he saw Mr Evans was injured but believed that the "injury was purely accidental perhaps caused by a stray claw". (Appendix 2).

On 28 May 2021, Mr Evans provided his injury and treatment report from Wadestown Medical Centre. This was accompanied by a photo of Mr Evan's injured leg. (Appendix 9). The medical report states;

- "Dog bite to right calf".
- "Sustained several puncture marks and x1 large open flap"
- "Large wound to R Calf proximal flap with ragged edges".

On 30 June 2021 Team Leader ACO Nunns, on completion of his investigation issued to Mr Tresidder (Appendix 4);

- Infringement Notice 3676 for failure to comply with any bylaw (requirement for dog to be on-lead) authorised by Section 20 – Dog Control bylaws under the Dog Control Act 1996 (The Act)
- Notice of Breach of Section 57 Dog attacking persons or animals for committing an offence on 24 May 2021, of the Act
- Notice of Classification as a Menacing Dog under Section 33A of the Act.

On 7 July 2021 Mr Tresidder advised Wellington City Council (WCC) that he objected to the menacing dog classification under s 33B and that the council's letter of 30 June is factually inaccurate. His second account of the attack varies from his first statement, in this statement he advises that he saw "Breaker" approach "George" and it was "George" that attacked" Breaker". He also confirms again, he didn't see what happened (Appendices 5 & 10)

On the 30 June 2021, ACO Team Leader assessed "Breaker" against the Attack Rating Report assessment chart (Appendix 11). The assessment chart applies risk levels based on the following criteria;

- Public Interest,

- · Classified (unleased or muzzled)
- Victim Impact
- · Dog Surrendered or Destroyed
- Observed aggression
- Negligence
- Co-Operation
- · Previous history
- · Dog registered at the time of incident

- · Known by owner to be dangerous
- Recurrence Likelihood
- · Trained to be aggressive
- Damages
- Breed characteristics

The outcome of "Breaker's" rating is a risk level of 27 requiring ACO's to issue; warning notice, Menacing Classification and/or Infringement. This was undertaken on 30 June 2021.

WCC is satisfied that:

- · Five offences had occurred under of the Dog Control Act 1996.
- The incident occurred on public property.
- The dog "Breaker" was off lead and uncontrolled.

- The dog "Breaker" rushed and attacked Mr Evans and his dog.
- · Mr Evans suffered a significant bite to his calf.
- Based on evidence provided, the menacing dog classification was robust and justified.

Conclusion

Animal Services have an obligation under section 33A to classify a dog as menacing, to ensure that further aggressive and uncontrolled animal behaviour is prevented.

The dog "Breaker", when uncontrolled is a risk to the public.

Animal services are familiar with the dog of it being uncontrolled and aggressive as presented in this report.

Based on a sufficient set of facts, the Attack Rating Report assessment was an appropriate cause of action.

The defendant is obligated under the Act and the Bylaw to ensure that the dog is kept on lead and under control in any public place.

The defendant is obligated to ensure that he takes all reasonable steps to ensure that the dog does not injure, endanger, intimidate or otherwise cause distress to any person.

WCC must keep in mind the public interest test, given the number of times complaints have been received and infringements issued in relation to significantly similar offences. It is in the public interest where WCC believe there are grounds for believing that the offence is likely to be continued, or repeated, for example where there is a history of recurring conduct (Solicitor-General's Prosecution Guidelines).

Wellington City Council has a responsibility that members of the public are protected from aggressive animals that can cause serious harm.

Wellington City Council must be confident that no further harm will occur to members of the public and therefore require the menacing dog classification remain.

My wife and I were walking our Labrador, duly registered, on a leash on Barnard Street. There is a lookout at the corner of our street and Lennel Road. My wife and George, our dog, were a little ahead of me. As they walked towards the lookout the large Collie dog, owned by Mr Bryan Tresidder and unleashed as always, suddenly rushed out onto the street and began to attack George in a vicious manner. My wife was trying to pull George away and was in danger of being pulled over. I ran up immediately to try to get the dog off George. The dog's name is Breaker. It is well known in our Street, as is its owner Mr Tresidder. The dog then viciously turned its attention onto me and tore my right leg very badly in two places, requiring immediate medical attention to stem the bleeding and six or more stitches. I continue to require regular dressings of the wound and am on strong antibiotic therapy for the infection that has ensued. My GP, Dr Christine Van Dalen has registered an ACC claim on my behalf. I am presently immobilised and my wife, Isobel, is frightened to walk George alone in case she should run Into Mr Tresidder and his dog again. He himself had suffered an incident of some kind with his dog, whilst exercising him on the lookout and made his way home bleeding profusely,. The blood left in the street occasioned subsequent Police attention. I do not want to see his dog put down but it needs to be muzzled and kept under strict control. The following is my recollection of the dog incident that happened on the 20th of may around 10am beside the small park at the corner of lennel rd and Barnard st. I was throwing sticks for my dog Breaker and saw Gary and Isabel walking down Barnard towards us with George their dog. As George often gets aggressive when Breaker does the usual dog greeting I walked away into the park thinking Breaker would follow. Then I heard growling behind me turned around and saw George and Breaker fighting. I didnt see exactly what happened but it appeared that Gary was trying to break them up . I called Breaker and he came back . Then Gary said he was bleeding and telling Isabel who was laughing ,that it was not funny but serious and showed that he had a reasonable amount of blood on his handkerchief. I offered to help but he yelled" just keep that dog away from me " . I don't know how he (gary)got the injury . I would assume that George was the aggressor although admittedly Breaker wouldn't have "got in his face" had he been on a lead .At no time did either dog pay any attention to Gary and I think the injury was purely accidental perhaps caused by a stray claw. The actual fracas lasted around 5 seconds and ended with Gary bleeding and George (Gary and Isabel's dog) with a mouthful of Breakers fur . If you would like independent comment on Breakers .He walked Breaker on a professional overall Behaviour you could contact basis for over a year and I'm sure would remember him as Breaker, Rough Collie, Barnard st . 

Investigation of Complaint 169295

We have now completed an investigation into this incident. The complainant alleged that at about 1000hrs on Thursday the 20th May 2021 a Grey, Collie type dog caller Breaker attacked his dog and also bit them leg while walking on a public street in Wadestown.

Based on the information obtained it would appear that your dog Breaker a male Grey and white Rough Coat Collie was that dog.

Although this type of offence is always considered serious, it was agreed that this particular case did not warrant prosecution. In view of the circumstances we have <u>enclosed</u> an infringement notice for \$300 issued undersection 20(5) of the Dog Control Act1996 for failing to abide by the Wellington City Council.

Your dog Breaker will also be Classified as a Menacing dog under section 33(A) of the Dog control Act 1996 due to the reported behaviour and injuries inflicted on the victim.

Please read the following sections of the Dog Control Act, which relate to your obligations as a dog owner.

Section 57 & 58 Dog Attacks

The owner or any person in charge of a dog, which attacks, can be fined up to \$20,000 and imprisoned for 3 years. The Court is likely to make an order for the dog's destruction unless the circumstances of the attack are exceptional.

Section 63 Owner Liable for Damage Done by Dog

The owner of a dog is liable for any damage done by their dog.

Section 57 & 58 Dog Attacks

The owner or any person in charge of a dog, which attacks, can be fined up to \$20,000 and imprisoned for 3 years. The Court is likely to make an order for the dog's destruction unless the circumstances of the attack are exceptional.

Section 57(A) Dog Rushes

The owner or any person in charge of a dog which rushes at a person, animal or vehicle in a public place can be fined up to \$3,000. The Court may make an order for the dog's destruction.

Section 5 Obligations of Dog Owners

- The obligations imposed on dog owners by the Dog Control Act require every owner:
 - to ensure that the dog is kept under control at all times;
 - to take all reasonable steps to ensure that the dog does not injure, endanger, intimidate, or otherwise cause distress to any person;
 - to take all reasonable steps to ensure that the dog does not injure, endanger, or cause distress to any stock, poultry, domestic animal, or protected wildlife;
 - to take all reasonable steps to ensure that the dog does not damage or endanger any property belonging to any other person.

As you will see, the penalties which may be imposed under this Act are severe. Therefore, it is important that you understand the need to keep Breaker under proper control at all times.

You-

- (a) must not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction; and
- (b) must, if required by the Council, produce to the Council, within one month after receipt of this notice, a certificate issued by a registered veterinary surgeon certifying-
 - (i) That the dog is or has been neutered; or
 - That for reasons that are specified in the certificate, the dog will not be in a fit condition to be neutered before a
 date specified in the certificate; and
- (c) Where a certificate under paragraph (b)(ii) is produced to the Council, produce to the Council, within one month after the date specified in that certificate, a further certificate under paragraph (b)(i).

You will commit an offence and be liable on conviction to a fine not exceeding \$3000 if you fall to comply with all of the matters in paragraphs (a) to (c) above.

A dog control officer or dog ranger may seize and remove the dog from you if you fail to comply with all of the matters in paragraphs (a) to (c) above. The officer or ranger may keep the dog until you demonstrate that you are willing to comply with paragraphs (a) to (c).

As from 1 July 2006, you are also required, for the purpose of providing permanent identification of the dog, to arrange for the dog to be implanted with a functioning microchip transponder. This must be confirmed by making the dog available to the Council in accordance with reasonable instructions of the Council for verification that the dog has been implanted with a functioning microchip transponder of the prescribed type and in the prescribed location.

You will be committing an offence and be liable on conviction to a fine not exceeding \$3000 if you fail to comply with this requirement-

- within 2 months from 1 July 2006 if your dog is classified as menacing on or after 1 December 2003 but before 1 July 2006; or
- within 2 months after the dog is classified as menacing if your dog is classified as menacing after 1 July 2006.

If the dog is in the possession of another person for a period not exceeding 72 hours, you must advise that person of the requirement to not allow the dog to be at large or in any public place or in any private way (other than when confined completely within a vehicle or cage) without the dog being muzzled in such a manner as to prevent the dog from biting but to allow it to breathe and drink without obstruction. You will commit an offence and be liable on conviction to a fine not exceeding \$500 if you fail to comply with this requirement.

Full details of the effect of the classification of a dog as menacing are provided in the Dog Control Act 1996.

- must dispose of every unregistered dog the person owns.

During the period that a person is classified as a disqualified owner, the person-

- must not own or become the owner of any dog; and
- must dispose of all does the person owns; and may have possession of a dog only for certain purposes (eg, returning a lost dog to the territorial authority).

A person may object to being classified as a probationary or disqualified owner by lodging a written objection with the Wellington City Council. There is a further right of appeal to a District Court, if a disqualified person is dissatisfied with the decision of the Wellington City Council on his or her objection.

Full details of classification as a probationary owner or a disqualified owner, and the effects of those classifications, are provided in the Dog Control Act 1995

Thank you for your letter dated 30 June 2021 (which I received by post on Monday, 5 June 2021) in relation to an allegation that, on 20 May 2021, my dog Breaker:

attacked the complainant's dog, and

bit the complainant on the leg.

Your letter and attached notice under s 33A of the Dog Control Act 1996 stated that, as a result of the allegation, the Wellington city council has classified Breaker as a menacing dog under section 33A(2) of the Act.

This email is written notice to the Wellington city council that, under s 33B(1) of the Dog Control Act, I, Bryan James Tresidder,:

- object to the classification of Breaker as a menacing dog under the Act; and
- exercise my right to be heard in support of the objection.

My objection relates to the evidence which formed the basis of the classification - which I assume is the complainant's report of Breaker's behaviour on 20 May 2021 (together with my written statement of 25 May 2021sent by email to the council in response to the council's request (see below)).

aggressor although admittedly Breaker wouldn't have " got in his face" had he been on a lead .At no time did either dog pay any attention to Gary and I think the injury was purely accidental perhaps caused by a stray claw . The actual fracas lasted around 5 seconds and ended with Gary bleeding and George(Gary and Isabel's dog) with a mouthful of Breakers fur . If you would like independent comment on Breakers overall Behaviour you could contact _______. He walked Breaker on a professional basis for over a year and I'm sure would remember him as Breaker, Rough Collie, Barnard st .

- It was George who first lunged at Breaker as he has done several times in the past (the complainant may not be aware of this as it is his wife who normally seems to walk George).
- -Breaker then reared back and swivelled to avoid George's attack.

Breaker would not have bitten the complainant's leg.

- -The complainant was standing directly behind Breaker as Breaker swivelled away from George
- -I didn't see exactly what happened but I assume that Breaker's claws on 1 of his front legs accidentally scratched the complainant's bare leg as Breaker dropped from the swivel backwards (Breaker accidentally deeply scratched my ankle during a play fight in January)
- -The complainant did not immediately realise he had been injured. If Breaker had bitten him he would have known immediately.

In terms of evidence of the alleged bite it would be helpful if the complainant could provide a photograph of the wound showing teeth puncture marks. If a photo of the wound shows a scratch or scratches, then it is likely that Breaker accidentally scratched him and did not bite him.

Another relevant matter is that Breaker is a lovely, gentle, and well socialised dog.

He was bred and raised by Raewyn Mullan of Braemist Collies in Foxton and became part of our family 6 years ago.

James Nepia of Kuri Companion who walked Breaker several times a week for at least a year always spoke highly of Breaker's interactions with people and other dogs.

Breaker currently lives harmoniously with our other pets - a cat, 2 free-range parrots and a free-range dove. We have never had any problem with Breaker manacing any of them.

Breach of bylaw requirement for dog to be on-lead Wellington Consolidated Bylaw - Part 2,

On Thursday 20th May 2021 at 1000hrs you were sighted walking your dog Breaker off lead on the corner of Barnard street and Lennel road . This area is designated as a controlled public place where dogs are allowed, as long as they are on a leash. It is an offence to allow your dog in this location with no leash.

On the 2nd December 2020 you were sighted walking you dog off lead on Oriental Bay Parade and issued with a written warning for the same offence.

As a result of the investigation there is enough evidence for the Animal Control Officer to have reasonable grounds for believing the offence's for did occur. The Council has considered the circumstances and it has decided to issue an infringement notice for this offence.

Please be aware that if you allow your dog to be off its leash again in a controlled public place, it may lead to you being issued with an infringement notice and a \$300 fine being incurred.

My wife and I were walking our Labrador, duly registered, on a leash on Barnard Street. There is a lookout at the corner of our street and Lennel Road. My wife and George, our dog, were a little ahead of me. As they walked towards the lookout the large Collie dog, owned by Mr Bryan Tresidder and unleashed as always, suddenly rushed out onto the street and began to attack George in a vicious manner. My wife was trying to pull George away and was in danger of being pulled over. I ran up immediately to try to get the dog off George. The dog's name is Breaker. It is well known in our Street, as is its owner Mr Tresidder. The dog then viciously turned its attention onto me and tore my right leg very badly in two places, requiring immediate medical attention to stem the bleeding and six or more stitches. I continue to require regular dressings of the wound and am on strong antibiotic therapy for the infection that has ensued. My GP, Dr Christine Van Dalen has registered an ACC claim on my behalf. I am presently immobilised and my wife, Isobel, is frightened to walk George alone in case she should run into Mr Tresidder and his dog again. He himself had suffered an incident of some kind with his dog, whilst exercising him on the lookout and made his way home bleeding profusely,. My name is Stephen Raynes, and I reside at a confirm that approximately late last year (Nov-Dec), while riding my electric scooter along the side of the road on Barnard Street, I stopped to check my phone. At this time, a medium-large sized dog ran towards me in an aggressive manner and made biting motions towards my legs. I kicked the dog away which did not deter it and it attempted to pursue me as I scootered away, whilst barking at me. At that time I also heard someone (unseen) calling out to what I assumed was the dog.

This is not the first time I have seen this dog on Barnard street. I can recall seeing it three of four times, and believe on one occasion the dog being attached to a lead. One of these times was post the attempted attack and I found it distressing to see it again, despite riding on a scooter. I do not remember details about the owner of the dog.

I cannot provide an exact colour description of the dog, however the below picture is a general approximation of type of dog that attempted to attack me:
