CONSULTATION AND COMMUNICATION PROGRAMME: DRAFT LONG TERM COUNCIL COMMUNITY PLAN 2009-2019

1. Purpose of Report

This report seeks approval of the consultation and communication programme to be undertaken for the draft Long Term Council Community Plan 2009-19.

2. Recommendations

Officers recommend that the Committee:

- 1. Receive the information.
- 2. Note the communication activities that will be used to support the consultation on the draft Long Term Council Community Plan 2009-19.
- *3.* Agree to delegate the hearing of oral submissions on the draft Long Term Council Community Plan 2009-19 to a subcommittee.
- 4. Recommend to Council that it agree to establish the Draft Long Term Council Community Plan Hearings Subcommittee with the terms of reference attached in appendix 1 and that it elect a chairperson for the subcommittee.
- 5. Agree that the special consultative procedure period commences on Thursday 16 April 2009 and closes on Monday 18 May 2008 with hearings scheduled between 25-29 May 2009.

3. Discussion

3.1 Background/context

The draft Long Term Council Community Plan 2009-19 (draft LTCCP) is the Council's primary strategic planning document. The draft LTCCP is being prepared in a challenging context of global economic recession, reduced household affordability, and increasing Council costs. As such, a programme of early engagement was established to test some initial thinking with the community prior to deliberating on the content of the draft LTCCP. The programme utilised a variety of techniques to increase awareness about the draft LTCCP and to elicit feedback from the community including:

- Mayor and Councillor phone hotline, roundtables, ward clinics, road shows, workshops, and presentations
- discussion boards, budget simulator, and social networking (Facebook)
- discussion document, feedback sheets, and a residents' panel.

The programme has created heightened awareness in the community about the draft LTCCP and many organisations have an expectation of being involved in the consultation process.

3.2 Timing

The formal consultation period is scheduled to run for one month in keeping with the requirements of the Local Government Act 2002. It is set to run from Thursday 16 April 2009 until Monday 18 May 2009. This will be followed by oral submissions, which are scheduled between 25-29 May 2009.

The schedule will provide sufficient time for the public to prepare submissions and for officers to evaluate them and prepare any commentary ahead of the final plan being agreed in late June (deliberations are scheduled for 16-18 June with adoption by the Council scheduled for Wednesday 24 June 2009).

3.3 Hearings Subcommittee

It is recommended that a subcommittee be formed to hear all oral submissions. The less formal environment of a subcommittee reduces barriers to participation and provides elected members the opportunity to engage in a discussion with the submitter to get a more detailed understanding of their views.

It is recommended that as part of their portfolio responsibilities, Portfolio Leaders along with the Mayor form the membership of the Draft Long Term Council Community Plan Hearings Subcommittee. This will ensure that the breadth of Council activities is represented. All elected members will be able to attend the hearings.

The Draft Long Term Council Community Plan Hearings Subcommittee will report to the Strategy and Policy Committee. Its terms of reference are attached as appendix 1.

3.4 Communication activities

The following communication tools will be used to support the draft LTCCP. The tools have been chosen as collectively they have a substantial 'reach' – they allow citizens to become aware of the key issues and participate in the process.

3.5 Engagement activities

While generating formal submissions to the draft LTCCP will be the predominant focus of the consultation programme, it is proposed to undertake a series of engagement activities that will encourage people to discuss the content of the draft LTCCP amongst themselves and to provide supporting feedback.

3.6 Workshops and Presentations

The proposed programme of workshops and presentations on the draft LTCCP is a mixture of presentation to Council's networks, revisiting sector-focused workshops, and holding ward clinics. Elected members will be asked to host face-to-face activities.

The Federation of Wellington Progressive and Residents' Associations hosted workshops and a wiki on the LTCCP during the early engagement programme. Officers will work with the Federation to ascertain whether there is role for the Council to support to their engagement activities during the consultation period.

3.7 Māori Engagement

The Council acknowledges the special position of mana whenua by working with Wellington Tenths Trust and Te Rūnanga o Toa Rangatira Incorporated and the wider Māori community.

The early engagement programme established some interest in the LTCCP and it is proposed to build upon this momentum during the draft LTCCP consultation process. It is proposed that focus group hui will be extended to include the Māori business community and whānau involved with kōhanga reo and kura kaupapa Māori.

4. Conclusion

This consultation and communication programme provides a range of communication tools and an appropriate mix of opportunities for people to express their views on the draft Long Term Council Community Plan 2009-19.

A full copy of all submissions, a summary report of all the submissions, and the Subcommittee's report¹ on the hearings will be presented to the Strategy and Policy Committee before final decisions are made.

General Purpose:

The Subcommittee has responsibility to hear submissions on the draft Long term Council Community Plan 2009-19 and report to the Strategy and Policy Committee.

Terms of Reference:

The Subcommittee will have responsibility and authority to:

1.0 Accept and hear submissions on Council's Draft Long Term Council Community Plan 2009-19 and report back to the Strategy and Policy Committee.

Delegated Authority

The Draft Long Term Council Community Plan Hearings Subcommittee will have delegated authority to carry out activities within its terms of reference.
