RE: South Coast Reserves Reclassification.

Thank you for your paper on the proposal to apply new reclassifications of Council Reserves on the South Coast. Both the Wellington Tenth's Trust and the Port Nicholson Block Settlement Trust have Mana Whenua in relation to the lands described.

In principle we support the re classification and agree the land should be held in the reserves mechanism so that it is not available for other purposes. The need to preserve the historic nature of the land and its cultural landscape for Iwi in particular is of great importance to the people who whakapapa to the trust. This in turn provides a rich historical record for all Wellingtonians and New Zealand.

A table is included which takes each land parcel in turn and explains our position and preferred re classification. I would be happy for this paper to accompany the officer's paper for consideration by Council.

Each of the reserves is considered in the same order within the WCC paper:
