46	doesn't mention proposed developments	The "have your say" document included any proposed developments at a site if they had been signalled in other Council documents e.g. Reserve Management Plan, Open Space Access Plan, Playgrounds Policy, Sportsfields Asset Management Plan.
46	pest/weed control	There is goat and possum control at Caribbean Avenue Reserve and we have recently started controlling pest plants. At Te Kopahou there are goat and pig control and boneseed and Darwins Barberry are weeds
		that are targeted. There are also key native ecosystem weed control programmes in the Waipapa Stream and Hape Stream catchments.
46	pest/weed control	The current Council policy is to concentrate on pest control within key native ecosystems. In many instances scenic reserve classification reflects priorities for pest control. Key Native Ecosystems (KNE) are prioritised based on their ecological importance, for example, they may contain rare species, be a good representation of pre-human vegetation, or be one of the last remaining areas of habitat. Council currently carries out pest control at 33 sites and continues to increase this programme. As we continue to add new KNE's to the programme, we are able to focus in some of the smaller adjoining reserves. Council also carries out city wide control of old man's beard, banana passionfruit, climbing asparagus and other uncommon weeds. Council also has an extensive possum control programme in partnership with Greater Wellington (covering over 4000 ha of public and private land), as well as goat and pig control around the Outer Green Belt, Te Kopahou, Newlands and Grenada.
46	management	We have noted your comments about the paintball lease at Caribbean Avenue Reserve. The leaseholder is not allowed to construct buildings or earthworks without Council approval. The paintball operation is on a 3-year lease. That is because Council wants to look at the longterm management of Caribbean Reserve and develop a landscape plan.
