 - i. Alexandra Road (between Constable Street and the Lookout Road), on Sunday 14 March 2010, from 7am to 6pm; and
 - b. For the **Real Women's Duathlon** event:
 - i. **Oriental Parade** (between Cable Street and Evans Bay Parade)
 - ii. **Evans Bay Parade** (between Oriental Parade and Cobham Drive), on Sunday 11 April 2010, from 6am to 10am (with resident access only); and
 - c. For the ANZAC Day Dawn Parade and Wreath Laying Ceremony events:
 - i. **Bunny Street** (between Featherston Street and Lambton Quay)
 - ii. **Lambton Quay** (both sides between Bunny Street and Ballance Street)
 - iii. **Bowen Street** (between The Terrace and Lambton Quay), on Sunday 25 April 2010, from 5am to 6.30am for the Dawn Parade event; and
 - iv. **Molesworth Street** (between the Lambton Quay/Bunny Street intersection and Hill Street)
 - v. Lambton Quay (northbound side between the Cenotaph and Molesworth Street), on Sunday 25 April 2010, from 10.15am to 10.45am (access for buses to remain open) for the Wreath Laying Ceremony event
