- 3. Agree to close the following roads for the events as shown, to vehicles only, subject to the conditions listed in the Proposed Temporary Road Closure Impact Reports:
  - (a) For the "Northern Wellington Festival and Christmas Parade" event, Saturday 4 December 2010:
    - (i) Wanaka Street (6.00am to 4.00pm)
    - (ii) Dr Taylor Terrace (6.00am to 1.30pm)
    - (iii) Moorefield Road (between the Haumia Street and Johnsonville Road roundabouts 10.45am to 12.30pm)
    - (iv) Moorefield Road (between the Johnsonville Road and Middleton Road roundabouts -11.00am to 12.30pm)
    - (v) Rotoiti Street (closed to through traffic -11.00am to 12.30pm)
    - (vi) Broderick Rd (Phillip Street to Johnsonville Road 11.00am to 12.30pm)
    - (vii) Johnsonville Road (between the Fraser Avenue intersection and the Moorefield Road roundabout 11.00am to 12.30pm)
    - (viii) Frankmoore Avenue (between Earp Street and Moorefield Rd 11.00am to 12.30pm)
    - (ix) Note: Parking Restrictions 6.30am to 3.00pm Moorefield Road (western side between Wanaka Street and Frankmoore Avenue). Parking Restrictions 7am to 1pm -Bannister Avenue, Broderick Road (Bannister Avenue to Phillip Street), Phillip Street, Frankmoore Avenue (Phillip Street to Earp Street) and Earp Street
    - (x) Note: Detour Route Johnsonville Road, Fraser Avenue, Haumia Street, Bannister Avenue, Broderick Road, Phillip Street, Frankmoore Avenue, Earp Street, Ironside Road, Middleton Road and State Highway 1; and
  - (b) For the "Trust House Men's Cycle Tour of Wellington" event:
    - (i) Lambton Quay (closed between Bowen Street and Willis Street except for traffic turning left from Brandon Street into Lambton Quay)
    - (ii) Ballance Street (between Lambton Quay and Stout Street)
    - (iii) Stout Street (between Lambton Quay and Ballance Street)

- (iv) Waring Taylor Street (closed to through traffic between Maginnity Street and Lambton Quay)
- (v) Johnston Street (closed to through traffic between Lambton Quay and Featherston Street)
- (vi) Brandon Street (closed to through traffic turning right into Lambton Quay), on Sunday 30 January 2011, from 12.00pm to 5.30pm.
