- exemptions from offer back under section 40(2), 40(3), or 40(4) PWA(if appropriate).
- e) Authorise Council officers to initiate the road stopping process for the Road Land in accordance with Section 342 and the Tenth Schedule of the Local Government Act 1974.
- f) Delegate to the Chief Executive Officer the power to formally approve the road stopping, issue all relevant public notices, declare the Road Land stopped, negotiate the terms of sale or exchange, impose any reasonable covenants, enter into an agreement in respect of the Road Land, and conclude all matters in relation to this transaction.

Road Stopping and Exchange - Legal Road Adjoining 45 Mana Street, Vogeltown

- 2. a) Agree that the approximate 93m² unformed legal road land in Mana Street (Road Land) adjoining 45 Mana Street, Vogeltown, is not required for a Public Work.
 - b) Approve the disposal of the Road Land to either the former owner or their successor, or by amalgamation with 45 Mana Street, Vogeltown, either by sale or exchange for approximately 625m² of 45 Mana Street.

 - e) Authorise Council officers to initiate the road stopping process for the Road Land in accordance with Section 342 and the Tenth Schedule of the Local Government Act 1974
 - f) Delegate to the Chief Executive Officer the power to; formally approve the road stopping, issue all relevant public notices, declare the Road Land stopped, negotiate the terms of sale or exchange, impose any reasonable covenants, enter into an agreement in respect of the Road Land, and conclude all matters in relation to this transaction.
