On Monday, 150 years ago, the first meeting of the Wellington City Council was held with Joseph Dransfield, the Mayor, who served twice as Mayor in 1870 and again in 1878. The Mayor advised that the Council had come a long way, the population at that time was less than 5,000 people, as it was just the inner part of Wellington city. The Mayor added that it was then amalgamated with Melrose Borough, Miramar Borough, Karori Borough, Onslow Borough, Johnsonville Borough and Tawa Borough. The Mayor said that it had been a slow process of expanding the boundaries. The Mayor further added that Council would be working with younger citizens to recognise and raise understanding about what Councils does and its responsibilities, and participation and involvement in Council.


What does 6,000 cars look like?

However as Cycle Wellington has pointed out a "collector road" like this should be at least <u>14 metres</u> requiring a footpath each side, along with a seperate cycle path on both sides of the road. Without these safety measure in place cyclists will be forced to share the vehicle lanes.
