This increase is proportionally higher than the increase in dog ownership. (An increase in dog registration of 15% but a 150% rise in dangerous dog classifications and a 800% in menacing dog classifications)

Menacing and dangerous dog classifications are placed on a dog after an attack – either on animals or people. Officers attribute the rise in attacks to a number of reasons: More people are out walking their dogs than in pre-covid times. It has also been acknowledged internationally that dogs pick up on the anxiety of their owners and New Zealanders have generally experienced higher levels of stress than pre-pandemic times. Dogs have also been seen to exhibit signs of separation anxiety now their owners are returning to work.

Due to the rise in attacks, this year officers implemented a more robust procedure for identifying and classifying dangerous and menacing dogs, using an attack rating assessment tool. Previously not all dogs were classified using the same strict criteria. This is the main reason for the increase in recorded attacks and subsequent classifications.
