Confirmation of Minutes

AAG confirmed the previous minutes (remove 3b)

Bede Crestani - Wakefield Street Mobility Car Parks

Bede spoke with the group about changes to car parks on Wakefield Street due to Town Hall Unreinforced Masonry and seismic strengthening work

Feedback:

- Issues around disability car parks at the police station.
- Issue around validity of data as unauthorised users use the disable carparks as a drop-off point.
- Service vans for disable requires more space and cannot use angled carpark.
- Issue around parking at peak time in the CBD
- Non-compliant mobility parking e.g kerb design
- Proximity to where service centres and Democracy Services are located
- Need for real time availability
- Enhance and improve accessibility in the Town Hall

Helen Bolton - Parking Review Policy

Helen spoke with the group about the review of Council's Parking Policy

Feedback:

- Peak time use is at weekends and evenings. During the weekday most disable carparks are underutilised.
- Comments on 2014 Be Accessible audit around 90% are noncompliant of the code, 50% non-legitimate use
- Concern around community veto to relocation of carpark and should be factored around demand forecasting rather than individual retailers
- Carparks need to be compliant and close proximity to high demand area e.g social activities

- Good practice American Disabilities Act improve performance remarkably e.g tow on-site, higher fines for both car owner and owner of business or building owner, flashing lights
- New South Wales jurisdiction no payment for mobility carpark.
- Kerb design is a barrier to carparks.
- Require comparative analysis for weekend use- peak time versus nonpeak time.
- Disable users should have same access as anyone else.
