2. PRESENTATION

2.1 Update on Mobility Survey

Presenter: Helen Bolton, Senior Advisor, Wellington City Council

Helen Bolton presented on the Mobility Survey noting that while feedback numbers were low compared to the number of mobility ticket holders, participants provided detailed information. It was also noted that the number of ticket holders is low compared to the number of people who eligible for one.

Members discussed with the presenter:

- that the survey canvas at what time people might encounter difficulties accessing mobility spaces
- the legality of trucks and construction vehicles blocking mobility spaces
- the location and size of mobility spaces
- the need to publicize the location and availability of mobility spaces including online in real time – was discussed
- whether a law change to allow instant fines would discourage opportunists from using mobility spaces
- the lack of mobility spaces in areas that attract youth

Action:

The presenter agreed to:

- check the legality of trucks and construction vehicles blocking mobility spaces – particularly Lower Cuba Street
- check whether enforcement officers have to sight an offence or whether a picture sent in by a member of the public would suffice.

2.2 Parking Policy

6.22pm

Presenter: Helen Bolton, Senior Advisor, Wellington City Council

Helen Bolton presented on parking policy noting increased discussion regarding high density models and how such discussions need to consider mobility. It was further noted that parking policy was integral to bigger discussions such as climate change. It was acknowledged that, permission would need to be sought from the new Council to release the draft policy for consultation.

Members discussed with the presenter:

- improving any parking hierarchy diagram by using symbols and providing a plain language explanation
- the need for screen reader access for documentation
- including the increase in use of mobility spaces as a measure of success
- how private providers could be included in the discussion
- the decreased use of cars by pensioners.

Action:

The presenter agreed to:

- provide an updated version of parking policy objectives and principles
- provide the draft Mobility Parking Guidelines once available
- include in the recommendations of the draft Mobility Parking Review Report "Provide real-time occupancy information for mobility parking

spaces and add additional information to the Council's mobility parking space map to indicate the suitability of the space for WAVs.

The Advisory group resolved to collate its feedback for forwarding to Helen Bolton.
