# **2.1.** Kristine Ford - Solicited feedback from AAG on:

The proposed 1<sup>st</sup> draft of the <u>Trading and Events in Public Places</u>
<u>Policy</u>, which will replace both the Council's current Footpath
Management and the Trading in Public Places Policies

#### Members discussed:

- Where are rubbish & bin placement is covered in regard to footpaths and trading policy?
- Whether there rules about placement of sandwich boards rubbish bins to be clear of mobility car parks?

- Concern about people and businesses blocking the footpaths without Council's permission.
- An issue at 160 Victoria St of electric cable blockage one metre into the footpath, this has been occurring for ten days already, Councillor Matthews said she would follow-up on the issue.
- That the Urban Design Team are looking into the issue of placement of permanent objects.
- Members discussed how problematic barriers in footpaths are to their community and expressed that it is imperative that Council address it.
- Whether WCC staff monitor for compliance.
- Whether the licencing process accessible/available in alternative formats.
- How do we make events accessible to people with light sensitive epilepsy and some autism people with other sensory sensitivities where there are flashing lights/loud noises.

## 2.2. Draft Letter to Mayoral Forum

#### Members discussed:

- Editing to get the right tone.
- There is a big gap to fill to achieve universal design and barrierfree design - now is the time.
- Current legislation requires only minimum accessibility to get consent.

# 3. Members' and Councillor's Updates

#### **3.1.** M. Wells - Charter

- WCC has allowed as a long-term "temporary" measure to allow residents to run Electric Vehicle cables across footpaths
- Eventually Electric Vehicle charging stations will be set-up around the city – but it is still a long ways off

- There are two accessibility charters:
  - Ministry of Social Development version
  - Christchurch Plan
- Lower Hutt has adapted one
- o Porirua and the Wairarapa are seeking one as well
- C. Richardson suggests Social, Cultural Economic
   Committee is the proper place to petition adoption of the charter
- C. McMenamin points out that there is <u>no mandate</u> for local government to meet the standard
- Councillor Matthews will work with AAG so they can present to Council

### 3.2. C. Richardson -

- Tonight is her last AAG meeting
  - James Robert, Chief Digital Officer, of Smart Council will take over her role starting next month
  - o Very useful to have operational and policy sides aligned

### 3.3. Councillor Matthews - Events

- Must make them more accessible <u>system wide</u>
- C. Richardson commented that she will flag Gisella Carr (Business Unit Manager)

• David Daniela will live-stream (low light) Makariki next month

# 3.5. N. Ruane - NZ Transport Agency's Total Mobility Card

- Parliament will issue cards on Friday
- Grants people with long term impairments access appropriate transport to meet their daily needs in the form of subsidised door to door transport services

#### **3.6.** Councillor Matthews –

• Long Term Plan meetings on-going

- Disability Conference in Auckland in July
- Launch of new swings in Woodridge very successful
  - Additionally, they fund-raised for play equipment for other venues
  - o Great educational experience for recreational staff

## **3.7.** M. Wells –

- Tawa & Freyberg Pools installed new hoists in swimming pools
- Farmer's Lane Design feedback request
  - Non-compliant stairwell
    - Exceeds number of stairs without resting platform
    - Hand-rails insufficient
  - Softening edges on seating areas so as not to impede the blind community
  - Concern over inevitable skateboarders' temptation on street furniture design

- Electric Cabling around footpaths is contentious issue
  - Will research overseas solutions
  - Hard plastic covering is not helpful solution
  - Council needs to come up with guidelines to charge Electric Vehicles in orderly safe way
