Minutes of the Previous Meeting:

• The Minutes were accepted by Nigel and seconded by Jack. There were no matters arising from these Minutes.

Presentation – Greg Campbell (Principal transport planner)

Greg provided an update on the Proposal to open Manners Mall & create shared space in lower Cuba Street, which was a continued session from the Youth Council meeting on 12 August 2009.

- Highlights from this presentation were
 - **Results from first consultation**
 - Manners mall bus way retained
 - Shared space in Lower Cuba Street added
 - Reasons for opening up Manners Mall
 - Unreliable bus journeys (12-25 minutes)
 - Bus patronage increase up to 30%
 - Single most beneficial improvement to Golden Mile bus route
 - Layout of the existing route Taranaki to Willis
 - Time savings (35-162 seconds)
 - Legibility

o Options analysed

- Revoke pedestrian status of Manners Mall & created shared space in lower Cuba
- Retain the pedestrian mall status of Manners Mall with 3 alternatives:
- Retain current route
- Establish 2 way bus route via Wakefield Street
- Establish 2 way route via Dixon Street
- Youth Councillors were advised of Submissions due by 5pm 30 October
- Oral submissions from 9 November
- Local Government provides a right of appeal within one month of decision

Questions and Feedback

Will there be an increase to user charges of buses? No

How much will this cost, and what would the money be spent on if this proposal did not go ahead? *There is a budget of \$11.1 million. These funds would be allocated elsewhere if the proposal were rejected.*

How long will Manners Mall and Lower Cuba be out of action for retailers and public? *Approximately six months for Manners and six months for Lower Cuba, developments would most likely start on Cuba*

Where is lighting considered in the proposal? *Lighting will be part of the finer details when developments start. We are consulting with City Safety to ensure we meet safety standards*

Operation Phoenix and WEMO – Dan Neely (Senior Emergency Advisor)

- **Introduction** Dan introduced his role and previous work experience which led to the position he now holds at WCC.
- **Question** YC was questioned as to why young people may not engage actively in Emergency Management. Responses were:
 - \circ young people may thing there is too much work involved

- people don't care
- Emergency Management is not linked to anything relevant in their ideas
- **Upcoming initiatives** WEMO are working closely with government to produce an NZQA accredited course which young people could attend and gain qualifications' from.
