Minutes

1. Opening

6. General Business

Potential project with McGuinness Institute

Wendy McGuiness presented on the work of the McGuiness Institute (McGI) and proposed a joint YC-McGI summit for youth councils, 24-27 August. The process would likely include participants assembling on 24th, workshops on 25th and 26th, and a presentation at Parliament on the 27th. Some potential topics were brainstormed. The proposal will be refined over the 2 months.

The YC decided to accept the McGI's proposal to jointly host the youth council summit.

North Kumutoto working group update (Jack)

Jack will be presenting the YC's oral submission on the proposed development at North Kumutoto on the waterfront at 11.30am, Tuesday 11 March.

Reduced central city speed limit (30 kph) submission update (Morgan)

Members discussed a draft Youth Council submission on the WCC proposal for safer speed limits in the CBD in pairs and them in plenary. Morgan will modify the draft to

take account of comments and seek ratification on Loomio.

Draft Annual Plan submission update

Members reviewed and commented on sections of the working group's draft submission. The working group will incorporate comments and seek further input and ratification on Loomio.

Video project update

The working group agreed to meet directly after the meeting to appoint a project leader and set up future project meetings.

Working Group for Youth Week event with Evolve

This item was deferred.

Safe and Sustainable Transport Reference Group

It was confirmed that Morgan was elected the Youth Council's representative on SASTRG. He was unable to attend the first meeting of 2014 but will be consulting YC regarding future meetings.

WCC submission on local body elections

It was noted that the Youth Council's project on increasing youth participation in the 2013 Wellington City Council elections was positively cited in the WCC's submission to a parliamentary enquiry.

Election for new Chair/Deputy meeting

Jack Marshall was the only nomination for the position of Chair and was declared the Chair for 2014. Ollie Michie, Petelo Leaupepe and Sean Johnson were nominated for the position of Deputy Chair and a secret ballot was held. Sean Johnson was declared the Deputy Chair for 2014.
